Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, line 4i—schedule of assets (held at year end) and Schedule H, line 4a—schedule of delinquent participant contributions for the year ended December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1. Plan Description

The following brief description of the Mario Tricoci 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of Mario Tricoci Hair Salons and Day Spas, LLC (the Company). Eligible employees may begin participating in the Plan as of the first day of the month coincident with or next following date on which the eligible employee has both attained age 18 and completed three months of service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan, but not to exceed statutory limits of the Internal Revenue Code (IRC). Participants aged 50 and older may contribute catch-up contributions as allowed per Internal Revenue Service (IRS) limitations. The Company contributes a Company match of 25% of each participant's deferral contribution up to first 3% of the participant's eligible compensation. The Company may also make a discretionary contribution to the Plan. The Company did not make a discretionary contribution to the Plan in 2024. Participants may also make Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Contributions are subject to limitations. Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which participant compensation is earned.

Participant accounts: Each participant's account is credited with the participant's contributions, the Company matching contribution, an allocation of the Company discretionary contribution, if any, and any plan net income (loss). Allocation of administrative expenses of the Plan is based on the participant's account balances.

Vesting: Participants are immediately vested in their pretax, Roth and rollover contributions, plus actual earnings thereon. Vesting in the Company's contributions, plus actual earnings thereon, is based on years of service based on the schedule below. In addition, 100% vesting regardless of credited years of service also occurs when a participant terminates employment with the Company on or after the date that the participant attains age 65, or if they terminate because of death or became totally and permanently disabled.

Investment options: A participant may direct all contributions into a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

Note 1. Plan Description (Continued)

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the participant's highest outstanding loan balance in the previous 12 months or 50% of their vested account balance. The term of the notes receivable may not exceed five years unless the note is for the purchase of a principal residence which may not exceed 15 years. The notes receivable are secured by the balance in the participant's account and bear interest at the prime rate of interest plus 1% at the time the note is issued. At December 31, 2024, the rates ranged from 4.25% to 9.50% on notes outstanding. Principal and interest are paid ratably through payroll deductions.

Payment of benefits: On termination of service, death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. A distribution will not be made without the participant's consent if the participant's vested account balance exceeds \$5,000. If the vested account balance does not exceed \$5,000 but is greater than \$1,000, unless otherwise elected, the Plan will be rolled over to an IRA selected by the Plan Administrator as soon as administratively practicable following the date the participant retires, dies, or otherwise terminates employment with the Company. If the vested account balance does not exceed \$1,000, unless otherwise elected, the Plan shall make a lump-sum distribution as soon as administratively practicable following the date the participant retires, dies, or otherwise terminates employment with the Company. Distributions may also be made from the Plan in cases of financial hardship, as defined in the plan document.

Forfeited accounts: Forfeitures can be used to reinstate previously forfeited account balances of participants, reduce future Company contributions, or to pay plan expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,796 and \$4,127, respectively. In 2024, approximately \$1,412 was forfeited into the Plan. \$2,743 of forfeitures were used to pay administrative expenses during 2024.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investment valuation and income recognition: Plan investments are reported at fair value (except for fully benefit-responsive contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines the Plan's valuation policies utilizing information provided by the investment custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent loans are classified as distributions based upon the terms of the plan document.

Accounting estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Note 2. Significant Accounting Policies (Continued)

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Certain administrative expenses of the Plan are paid by the Company. Loans and distribution processing fees are paid by the Plan.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified or Provided by the Trustee

The following is a summary of the Plan's asset and income information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule that were prepared by or derived from information provided by the John Hancock Trust Company LLC, the trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets and income (loss):

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024.

Shares of registered investment companies: Valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 5. Investment Contract With Insurance Company

The Plan entered into a fully benefit-responsive investment contract with New York Life Insurance Company (NYL). The group annuity contract provides for two distinct accounts: The Stable Value Account and Pooled Separate Account No. 25. The Stable Value Account at all times is equal to the contributions made to the contract plus interest credited, plus dividends, if any, minus expenses withdrawn and minus withdrawals made pursuant to the annuity contract and represents the amount NYL is contractually obligated to repay to the Plan. The contract restricts direct transfers from the account to competing investment options. Pooled Separate Account No. 25 is the underlying investment account in which all contributions are invested. The concept of a value other than contract value does not apply to this group annuity contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value.

The Plan receives interest accrued daily and credited monthly to the Stable Value Account and reflects the experience of Pooled Separate Account No. 25. Interest rates are guaranteed by NYL to be no less than 0% before deducting for expenses. Such interest rates are reviewed January 1 and July 1 of each year for resetting.

Events that limit the ability to transact at contract value with the issuer include employer-initiated plan termination, merger, spin-off, lay-off, early retirements that cause significant withdrawal from the Plan or any failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 6. Party-In-Interest Transactions

Plan investments are held by John Hancock Trust Company LLC. John Hancock Trust Company LLC is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees for such transactions were \$110,051 for the year ended December 31, 2024. Administrative expenses paid by the Plan to Kavar Capital Partners, an investment advisor and party-in-interest, was \$47,696 for the year ended December 31, 2024.

Certain employees of the Company provide administrative services to the Plan and are not reimbursed for their services from the Plan. Certain other expenses of the Plan are paid by the Company.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

Note 8. Tax Status

Effective July 1, 2018, most recently amended January 1, 2022, the Plan adopted a non-standardized form of a prototype plan sponsored by John Hancock Retirement Plan Services LLC. The prototype plan provider has received an opinion letter from the IRS as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and is, therefore, a qualified plan and tax-exempt.

Note 8. Tax Status (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Note 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 11. Nonexempt Transactions

During 2024, the Plan Sponsor inadvertently failed to deposit \$2,022,132 of participant deferrals within the timeframe as stated by DOL regulations. The Plan Sponsor intends to reimburse the Plan for lost earnings in 2025.
