### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

#### NOTE A - DESCRIPTION OF PLAN

The following brief description of the EGR, Inc. 401(k) Profit Sharing Plan (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

##### General

The Plan is a defined contribution plan that was established on August 1, 1999, covering substantially all employees of EGR, Inc. (the “Company”) who have reached the age of eighteen and have completed twelve consecutive months of service with the Company. The Plan is a defined contribution plan under section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan’s trustee and recordkeeper changed from Empower Trust Company, LLC and Empower Annuity Insurance Company of America to Voya Retirement Insurance and Annuity Company, effective March 21, 2024.

##### Contributions

Each year, participants may contribute up to 100% of their eligible compensation on a pre-tax basis, subject to the annual limits of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a fully vested safe harbor non-elective contribution equal to 5% of each eligible employee’s compensation. This contribution is intended to satisfy the safe harbor contribution formula permitted under IRS regulations, thereby exempting the Plan from the nondiscrimination testing otherwise applicable to 401(k) contributions. Participants direct the investment of their employer non-elective contributions into the same investment options available under the Plan.

##### Participant Accounts

Each participant’s account is credited with the participant’s contributions, Company safe harbor non-elective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants’ vested account.

##### Vesting

Participants are immediately 100% vested in their elective deferrals, rollover contributions, safe harbor non-elective contributions, and related earnings.

NOTES TO THE FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits

Participants, or their beneficiaries, may receive the vested interest of their Plan account upon death, disability, termination of employment, retirement, or a qualifying withdrawal. Hardship withdrawals from a participant's elective deferral account are permitted under the Plan. Participants who have attained age 59½ may also request an in-service withdrawal of their vested account balance.

Benefit payments may be made in the form of a single lump-sum distribution or in installments. Distributions of less than \$5,000 are required to be rolled into an individual retirement account unless the participant elects otherwise. Participants with account balances greater than \$5,000 may elect to defer distribution until a later date.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to the lesser of (a) \$50,000 reduced by the highest outstanding loan balance during the preceding twelve months or (b) 50% of their vested account balance. Loan repayment periods generally may not exceed five years, except for loans used to acquire a principal residence, which may extend up to thirty years.

Loans are secured by the participant's account balance and bear interest at a rate commensurate with prevailing market rates as determined by the Plan administrator. Principal and interest are repaid through bi-weekly payroll deductions.

Forfeited Accounts

When certain terminations of participation in the Plan occur, the non-vested portion of the participant account, as defined, represents a forfeiture. Forfeitures may be used to reduce future employer contributions or to pay Plan administrative expenses. Forfeitures totaling \$123 were used to reduce employer contributions during 2024. No forfeitures were used to reduce employer contributions or pay administrative expenses during 2023. The balance of forfeited non-vested accounts as of December 31, 2024 and 2023 was \$5,721 and \$5,796, respectively.

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Date of Management's Review

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investment Valuation and Income Recognition

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

##### Payment of Benefits

Benefits are recorded when paid.

##### Administrative Expenses

Administrative expenses include amounts paid by the Plan for recordkeeping services, third-party administration services and investment advisory services. Administrative expenses are allocated to participant accounts based on a pro rata formula. Fees related to the administration of benefit payments and loans are charged directly to the participant's account and are included in administrative expenses. To the extent expenses of administering the Plan are not paid by the Plan, the expenses are paid by the Company, and therefore, are not included in the accompanying financial statements.

NOTE C - FAIR VALUE MEASUREMENTS

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Common collective trust funds:* Valued at the NAV of units of the common collective trust fund as reported by the fund. Units of beneficial interest in these funds are not registered with the Securities and Exchange Commission; however, these funds publish their daily NAV and transact at that price. The Participants' redemptions of the common/collective trusts are permitted daily with no other restrictions or notice periods and there are no unfunded commitments.

*Pooled separate accounts:* Valued at the net asset value (NAV) of units of the pooled separate account. The NAV is based on the fair value of the underlying investments held by the account less its liabilities. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments related to these investments.

For the year ended December 31, 2024, the Plan's trustee and recordkeeper changed from Empower Trust Company, LLC and Empower Annuity Insurance Company of America to Voya Retirement Insurance and Annuity Company, effective March 21, 2024.

Empower Trust Company, LLC and Empower Annuity Insurance Company of America certified the investment information for the periods January 1, 2024 through March 21, 2024, and for the year ended December 31, 2023. Voya Retirement Insurance and Annuity Company certified the investment information for the period March 22, 2024 through December 31, 2024.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE F - GUARANTEED INVESTMENT CONTRACT WITH NATIONAL INSURANCE COMPANY

During 2024, the Plan held a fully benefit-responsive group annuity contract with Voya Retirement Insurance and Annuity Company (Voya), which replaced a similar contract previously held with Empower Annuity Insurance Company of America in connection with the Plan's transition of trustee and recordkeeping services effective March 21, 2024.

Voya maintains contributions under the contract in its general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is a general account obligation of Voya and is not a mutual fund or part of a separate account. The issuer is contractually obligated to repay principal and credit interest at a rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The investment contract is presented at contract value on the statement of net assets available for benefits. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTE F - GUARANTEED INVESTMENT CONTRACT WITH NATIONAL INSURANCE COMPANY  
(CONTINUED)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula established by the issuer but will not be less than the Guaranteed Minimum Interest Rate (GMIR) of 1.00%. The rate is reviewed periodically for resetting, but once declared, it is guaranteed for at least a three-month period. The current effective annual yield as of December 31, 2024 was 1.50%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or removal of equity wash provisions; (3) bankruptcy or insolvency of the Plan sponsor or other sponsor events (for example, divestitures or spin-offs) that cause significant withdrawals; or (4) the failure of the trust to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to maintain tax-exempt status under Section 501(a). The Plan administrator believes that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is not probable.

The issuer may terminate the contract if certain conditions occur, such as: (1) an uncured violation of investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreements without the issuer's consent. All guarantees under the contract are based on the claims-paying ability and financial strength of Voya Retirement Insurance and Annuity Company.

NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others.

During the year ended December 31, 2024, the Plan's trustee and recordkeeper changed from Empower Trust Company, LLC and Empower Annuity Insurance Company of America to Voya Retirement Insurance and Annuity Company, effective March 21, 2024. Accordingly, certain Plan investments were managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC for the portion of the year prior to the transition, and by Voya Retirement Insurance and Annuity Company for the remainder of the year.

For the year ended December 31, 2023, all Plan investments were managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, which also provided recordkeeping, investment advisory, and third-party administrative services.

Fees paid to Empower Retirement, LLC (and its affiliates) and Voya Retirement Insurance and Annuity Company are included in administrative expenses. Notes receivable from participants are also considered party-in-interest transactions. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

### NOTES TO THE FINANCIAL STATEMENTS

#### NOTE H - INTERNAL REVENUE SERVICE STATUS

The Company has adopted a prototype non-standardized 401(k) profit sharing plan. The IRS has opined and informed by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the IRC. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market rate, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE J - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain amounts included on the Schedule H Part I and II on the Annual Return/Report of Employee Benefit Plans (Form 5500) have been grouped differently for purposes of presentation in the financial statements.

There were no reconciling items between the financial statements and the Form 5500 as of December 31, 2024 and 2023.
