NOTE 1: DESCRIPTION OF PLAN

The following description of Arkansas Hospice 401(k) Retirement Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan maintained for the benefit of employees of Arkansas Hospice, Inc. (Employer, Plan Sponsor and Plan Administrator) who have at least one month of service and are age 18 or older. Related employers who also participate in the Plan include Arkansas Palliative Care, LLC, Arkansas Hospice Foundation, Inc., and First Choice Senior Care, Inc.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer utilizes the services of The Standard Insurance Company, the third-party administrator, to process participant transactions and maintain participant account balances. Also, the Employer has entered into an agreement with Prime Capital Investments Advisors (Prime) to provide investment advisory related services. Total fees paid by the Plan to Prime were approximately \$16,000 for the year ended December 31, 2024.

Certain duties related to the administration of the Plan are performed by employees of the Plan Sponsor; however, the Plan Sponsor does not charge the Plan for the estimated cost of such services. Certain other expenses related to the administration of the Plan are paid directly by the Plan Sponsor and are not recorded as expenses in the Plan's financial statements. These expenses totaled approximately \$9,500 for the year ended December 31, 2024.

Contributions

Participants may contribute pre-tax and/or Roth deferrals up to the maximum amount allowed by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Employer may make discretionary matching contributions for participants who have at least six months of service. For the years ended December 31, 2024 and 2023, the Employer made matching contributions to eligible participants equal to 50% of deferrals up to 6% of eligible compensation. Additionally, the Employer may make profit-sharing contributions to eligible participants at the discretion of the Employer's Board of Directors. Participants must be employed on the last day of the plan year and complete one year of service as defined in the plan document to receive a profit-sharing contribution. There were no profit-sharing contributions for the years ended December 31, 2024 and 2023. Employer contributions are also subject to limitations imposed by the IRS.

NOTE 1: DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer matching contributions and allocations of Employer profit-sharing contributions and Plan earnings, net of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested at all times in their own contributions plus actual earnings thereon. Vesting in the Employer's contributions and earnings thereon is based on years of service, as defined in the Plan agreement. A participant is fully vested in Employer contributions upon retirement, permanent disability or death, or completing six years of service.

Investment Options

Contributions to the Plan are invested as directed by the participants. Participants may invest their contributions into any of the pooled separate accounts offered by the Plan under an insurance contract with Minnesota Life Insurance Company and may change their investment options at any time.

Notes Receivable from Participants

Participants may borrow from their accounts at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. Loans may be extended for periods not to exceed five years, except when loan proceeds are used for the purchase of the borrower's primary residence, in which case the loan may be extended. Loans are secured by the participant's vested account balance. The loan interest rate is determined by the Plan Administrator. Principal and interest are paid through bank draft.

Forfeitures

The nonvested portion of a participant's account to which the participant is not entitled upon termination is deemed a forfeiture. Under the terms of the Plan agreement, forfeitures may be used to pay administrative expenses or reduce the Employer's contribution. There were no forfeitures used to reduce Employer contributions or pay plan expenses during the year ended December 31, 2024. There was approximately \$74,000 and \$46,000 in forfeitures available for future allocation at December 31, 2024 and 2023, respectively.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant (or their designated beneficiary) may elect to receive the participant's vested account balance in a lump-sum distribution or equal installments. Upon termination of service for other reasons, a participant may receive the value of the vested interest in their account only as a lump-sum distribution.

NOTE 1: DESCRIPTION OF PLAN (Continued)

Payment of Benefits (Continued)

In-service distributions after a participant's attainment of age 59 ½ are permitted as specified in the Plan agreement. Upon termination, automatic distributions are required for balances of less than \$5,000. Generally, certain minimum distributions are required for participants who have separated from service and have reached age 72½.

Hardship Withdrawals

In case of immediate and heavy financial hardship, a participant may withdraw all or a portion of the participant's vested account balance. A withdrawal shall be deemed for purposes of an immediate and heavy financial hardship if the withdrawal is necessary for certain eligible expenses, such as medical care, the purchase of a principal residence for the participant, payment of tuition and related education fees for the next twelve months of post-secondary education, payments necessary to prevent eviction of the participant from his or her principal residence or to avoid foreclosure on said residence, payments for funeral or burial expenses or expenses to repair damage to the participant's principal residence.

Termination of the Plan

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly fashion between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustees. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as those held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded in accordance with the Internal Revenue Code.

Payment of Benefits

Benefits are recorded when paid. There are no amounts allocated to withdrawing participants that were not yet paid as of December 31, 2024 and 2023.

Estimates

The preparation of financial statements in accordance with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts and disclosure. Accordingly, actual results may differ from those estimates.

NOTE 3: INFORMATION PREPARED AND CERTIFIED BY INSURANCE COMPANY

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, all information pertaining to the Plan’s investments and related investment activity reflected in the financial statements and supplemental schedule as of December 31, 2024 and 2023 and for the year ended December 31, 2024, was certified by The Standard Insurance Company. This information was not subject to audit procedures except for comparing it to the related information included in the financial statements and supplemental schedule. Based on the information provided and certified by the insurance company there are no fixed income obligations, leases or debt instruments in default or deemed uncollectible, as defined by ERISA, for the years ended December 31, 2024 and 2023.

The following information included in the accompanying financial statements, related notes and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the insurance company.

NOTE 4: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2 Inputs to the valuation method include the following:
- Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

The pooled separate accounts are comprised of a wide variety of investments, including equities, preferred stocks, bonds and mutual funds. The pooled separate accounts are designed to deliver safety and stability by preserving principal and accumulating earnings. The fair values of the pooled separate accounts are based on the net asset value (NAV) of each pooled separate account in which the Plan invests. The NAV is determined based on the market value of the underlying investments, which are determined based on quoted market prices or quoted prices for similar assets in active or non-active markets. The NAV of the pooled separate accounts are not publicly quoted prices in an active market.

The Plan failed a discrimination test for the year ended December 31, 2024. Excess contributions totaling \$12,207 are reported as liabilities on the accompany statement of net assets available for benefits as of December 31, 2024.

NOTE 6: EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in pooled separate accounts managed by Minnesota Life Insurance Company which charges contract administration fees that are paid by the Plan and included in administrative expenses on the statement of changes in net assets available for benefits. These transactions qualify as exempt party-in-interest transactions.

NOTE 7: TAX STATUS

Effective April 1, 2022, the Plan executed an adoption agreement for the Minnesota Life Insurance Company Defined Contribution Pre-Approved Plan (the Prototype). As an adopter of the Prototype, the Plan is not subject to tax under present income tax law.

The Prototype obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving that letter, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting standards require the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require the recognition of a liability or disclosure in the financial statements. The Plan may be subject to audit by the IRS; however, there are currently no audits for any tax periods in progress.

NOTE 8: RISKS AND UNCERTAINTIES

The pooled separate accounts in which the Plan's assets are invested are comprised of investment securities, which are exposed to various risks such as interest rate, market and credit risks. Certain of those pooled separate accounts may invest in foreign securities. There are certain additional risks involved when investing in foreign securities that are not present with investments in domestic securities. These risks may involve foreign currency exchange rate fluctuations, adverse political and economic developments and the possible prevention of currency exchange due to foreign governmental laws or restrictions. Due to the level of risk associated with certain investment securities that comprise the pooled separate accounts, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Plan's financial statements.



