**NOTE 1 – DESCRIPTION OF PLAN**

The following brief description of the Blue Diamond Growers Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General: The Plan is a defined contribution plan providing retirement benefits for all eligible domestic employees of Blue Diamond Growers (Plan Sponsor) who are not covered under the terms of a collective bargaining agreement or are not leased employees.

Contributions: Participants are allowed to contribute up to 100% of their eligible compensation in any one year, as defined, not to exceed limitations established by law. Employees are automatically enrolled at a 3% deferral rate upon becoming eligible to participate in the Plan and may elect to change or discontinue deferrals at any time. The deferral percentage automatically increases by 1% increments annually until reaching a maximum of 10% of an employee's salary. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Until March 5, 2023, Plan Sponsor matching contributions to participants' accounts were made in an amount equal to 50% of participants' contributions excluding those contributions which exceed 6% of the participants' compensation for the plan year. Effective March 6, 2023, Plan Sponsor matching contributions to participants' accounts are made in an amount equal to 100% of the first 3% of participants' contributions and 50% of the next 3% of participant contribution, excluding those contributions which exceed 6% of the participants' compensation for the plan year.

Participant Accounts and Allocations: Each participant's account is credited with the participant's contributions and an allocation of the Plan Sponsor's contributions and Plan investment income and charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the balance in the participant's account.

Vesting: Participants are immediately vested in the employee contributions, matching employer contributions, and actual earnings thereon.

Retirement, Death and Disability: On separation of service (death, disability, or termination of employment) if the participant or beneficiary's vested benefit exceeds \$5,000, they must consent to a distribution in either a single lump-sum payment in cash, installment, partial withdrawal, or a joint and 100% survivor annuity. Vested benefits equal to \$1,000 or less shall be distributed in a lump-sum payment as soon as practicable upon separation of service. If the vested benefit is greater than \$1,000 and less than \$5,000 and the participant has failed to elect a lump-sum payment or rollover, the vested benefit shall be distributed into an individual retirement account. Employee participants may withdraw the balance of their account after suffering an extreme financial hardship (as defined in the Plan agreement) or after attaining the age of 59½. The distribution of the participant's account must commence not later than April 1, following the calendar year in which the participant attains age 70½.

Notes Receivable from Participants: The Plan allows participants to borrow from their account balance. The minimum loan is \$1,000 with the maximum loan of 50% of their vested account balance up to \$50,000. The loans bear interest at the prime rate, and the term of the loan may not exceed five years except if it is for the purchase of a principal residence. Interest rates on the loans outstanding at December 31, 2024 ranged from 3.25% to 9.50%, and the loans mature at various dates through March 2035.

Basis of Accounting: The Plan prepares its financial statements on the accrual basis of accounting.

**NOTE 1 – DESCRIPTION OF PLAN** (Continued)

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants and the Plan's record keeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by the Plan Sponsor and are excluded from these financial statements.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net realized and unrealized appreciation (depreciation) in fair value of investments consists of the change in unrealized appreciation or depreciation during the year, and the realized gain or loss on the sales of investments during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Sponsor to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties: The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, liquidity and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants individual account balances.

**NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net (depreciation) appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee of the Plan.

#### **NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments.

Mutual Funds and Personal Choice Retirement Account: The fair values of mutual fund and personal choice retirement account investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust Fund: The fair value of participation units in the collective trust is based upon the net asset value of such fund, as reported in the audited financial statements of the fund. The Plan invests in the Fidelity Managed Income Fund. The collective trust provides for daily redemptions by the Plan at reported net asset value per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intention to do so, the Plan Sponsor has the right to terminate the Plan at any time subject to the provisions set forth in ERISA. See Note 8.

**NOTE 6 – INCOME TAX STATUS**

The Internal Revenue Service (IRS) issued an opinion letter dated June 30, 2020 indicating that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original prototype, the Plan Sponsor believes that the Plan continues to fulfill the requirements of the IRC and ERISA, and the Plan is exempt from income tax.

**NOTE 6 – INCOME TAX STATUS** (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 7 – PARTY IN INTEREST TRANSACTIONS**

Parties in interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Plan Sponsor. Transactions involving the collective trust fund and the cash reserve account qualify as party-in-interest as Fidelity Management Trust Company is trustee of the Plan. Notes receivable from participants also reflect party-in-interest transactions. Strategic Advisors LLC and Morgan Stanley Smith Barney LLC charge investment management fees to the Plan for investment advisory.

**NOTE 8 – SUBSEQUENT EVENTS**

Partial Plan Termination: Subsequent to the plan year ended December 31, 2024, in June 2025 the Plan Sponsor announced the closure of a processing facility that affected approximately one third of its employees. As a result of this significant reduction in workforce, management has determined that a partial plan termination has occurred under the provisions of the Internal Revenue Code. In a partial plan termination, all affected participants who are terminated and are not otherwise vested in their employer contributions will become fully vested in their account balances as of the date of termination, however currently all participants are immediately vested in employer contributions to the Plan, therefore there is no change in vesting of employer contributions as a result of this reduction in force.

The Plan Sponsor has evaluated subsequent events through July 24, 2025, the date the financial statements were available to be issued.
