In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## **Supplemental Schedules Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule H, line 4i – schedule of assets held at end of year and schedule H, line 4j – schedule of reportable transactions as of or for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

## **Note 1 - Description of Plan**

The following brief description of The Prophet Corporation Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Prophet Corporation (the Company) established the Plan effective as of January 1, 2003. The Plan operates, in relevant part, as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (IRC), as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by management of the Company. The trust department of an independent third-party bank is the Plan's trustee.

In 2012, the Plan purchased the Company common stock using the proceeds of a note (Note 7) and holds the common stock in a trust established under the Plan. As the Plan makes debt payments, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the IRC.

The borrowing is collateralized by the unallocated shares of stock and is guaranteed by the Company. The lender has no rights against shares of the stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, present separately the assets and liabilities, and changes therein pertaining to:

1. Accounts of employees with vested rights in allocated stock (allocated).
2. Stock not yet allocated to employees (unallocated).

### **Eligibility**

Employees of the Company and its affiliates are eligible to participate in the Plan after they have completed one year of service, have attained age 21, and are employed on the last day of the year. Leased employees, union members, independent contractors, and non-resident aliens are not eligible to participate in the Plan.

### **Entry Date**

Employees may enter the Plan on the first day of each quarter following the date the employee meets the eligibility requirements.

### **Contributions**

The Company may make contributions in cash to the Plan which, when aggregated with the Plan's dividends, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Employee contributions are not permitted. For the year ended December 31, 2024, the Company made no discretionary contributions.

## Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The trustee is permitted to vote any allocated share for which instructions have not been given by a participant and any unallocated shares in the same proportion to which voting instructions have been received, unless otherwise directed by the Plan Administrator.

## Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

## Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year and have worked 1,000 hours will receive an allocation. Allocations are based on the participant's eligible compensation relative to the total eligible compensation. Plan earnings and losses are allocated to each participant's account based on the ratio of the participant's account balance.

## Vesting

Vesting in the participants' accounts and related earnings thereon is based on years of continuous service as set forth in the following table:

Participants are 100% vested in their account balances upon retirement, death, or disability.

## Forfeitures

At December 31, 2024 and 2023, there was no balance in the forfeited non-vested account, as all forfeitures are used in the same year they are forfeited. Forfeited accounts are used to reduce future employer contributions or allocated to eligible participants. During the year ended December 31, 2024, forfeited non-vested accounts totaling \$7,748 were allocated to eligible participants.

## Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments, as defined in the Plan document. The Plan provides for the settlement of vested accounts in excess of \$25,000 in substantially equal installments over a period of five years, plus an additional year for each \$275,000 that the vested balance exceeds \$1,380,000. Effective October 1, 2024, participants that terminated in 2023 for any reason are allowed to receive a lump-sum payment of their distributions. Annual payments under these installments are subject to certain minimums as defined in the Plan document.

## Diversification

Diversification is offered to participants approaching retirement so that they may have the opportunity to move part of the value of their investments in the Company's common stock into investments that are diversified. The Plan allows participants who have completed ten years of service, attained age 55, and have given notice 90 days after the Plan year-end to diversify a portion of their account balance. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the shares allocated to their respective account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution.

## Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their account.

## Note 2 - Significant Accounting Policies and Use of Estimates

### Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

### Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### Allocations

The financial statements of the Plan present separately the assets and liabilities, and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated), and (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

## Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings (losses) reported above and in the statement of changes in net assets available for benefits may differ from the classification of earnings (losses) on Form 5500 due to different reporting requirements on Form 5500.

## Payment of Benefits

Benefit payments to participants are recorded upon distribution.

## Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

## Subsequent Events

The Plan sponsor has evaluated subsequent events through October 14, 2025, the date which the financial statements were available to be issued.

**Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common stock: The fair value of the Company common stock held in the Plan is valued at estimated fair value based upon an independent appraisal. The appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities, including discounts for lack of control and lack of marketability.

Money market mutual fund: Valued at the daily closing price as reported by the fund. Money market mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The money market mutual funds held by the Plan are deemed to be actively traded.

## Changes in Fair Value of Level 3 Assets

The Plan distributed 14,119 shares valued at \$2,082,744 of the Plan's Level 3 assets for the year ended December 31, 2024, with no transfers in or out and no purchases.

## Note 5 - Tax Status

The Plan was amended and restated effective January 1, 2014, and has applied for a determination letter with the Internal Revenue Service (IRS). The Company and Plan management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and, therefore believe the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## Note 6 - Administration of Plan Assets

The Plan's assets, which consist principally of common shares of the Company, are held by the trustee of the Plan. Company contributions are held and managed by the trustee, which invests cash received, interest, and dividend income, and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company, or its affiliates. No officer or employee receives compensation from the Plan. Administrative expenses for the trustee's fees are paid by the Company.

## Note 7 - Note Payable

In May 2012, the Plan entered into a \$1,500,000 term loan agreement with the Company. The proceeds of the loan were used to purchase Company common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The Plan releases its shares using the principal and interest method. This resulted in 2,899 shares being released and allocated for the Plan year ended December 31, 2024.

The balance due on the note payable as of December 31, 2024 and 2023, was \$237,509 and \$351,101, respectively. The loan agreement bears interest at 3% and provides for the loan to mature on December 31, 2026. The scheduled amortization of the loan for the next four years and thereafter is as follows:

## Note 8 - Related Party and Party-in-Interest Transactions

The Plan's investments consist primarily of the Company's common stock, which has been financed in part by the Plan's issuances of debt to the Company. Interest expense paid to the Company totaled \$10,533 for the year ended December 31, 2024. The Plan recognized \$1,216,397 in dividends from the Company for the year ended December 31, 2024. Transactions related to the Company's common stock qualify as related party and exempt party-in-interest transactions.

## Note 9 - Risks and Uncertainties

The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock, and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term, and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Note 10 - Right of First Refusal**

Shares of Company stock distributed by the trustee to a participant or beneficiary shall be subject to a “Right of First Refusal” if such shares do not constitute registration-type securities within the meaning of IRC section 409(e). The Right of First Refusal shall be in favor of the Company, the Plan, or both in any order of priority as determined by the Plan Administrator. The selling price and other terms under the Right of First Refusal must not be less favorable to the participant than the greater of the value of the Company stock determined by the Plan document, or the purchase price and other written terms offered by an independent and unrelated buyer making a good faith offer to purchase the Company stock.

**Note 11 - Unrelated Business Income Tax**

The Plan has transferred some of the employer stock into a separate non-ESOP component of the Plan. The pass-through income attributable to these shares is subject to unrelated business taxable income rules. Accordingly, the Plan incurred \$68,891 of tax pertaining to the unrelated business income tax for the year ended December 31, 2024.

**Note 12 - Plan Amendment**

Effective October 1, 2024, the Plan was amended to allow participants terminated in 2023, for any reason, to receive a lump-sum payment of their distributions.
