## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator, Participants and Beneficiaries of the  
New TSI Holdings, Inc. 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the New TSI Holdings, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### ***Opinion***

#### **NOTE A - PLAN DESCRIPTION**

The following description of the New TSI Holdings, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

##### **[1] General:**

The Plan is a defined contribution plan covering substantially all employees who meet defined age and employment requirements of New TSI Holdings, Inc., Boston Gym, LLC, Broadway Gym Holdings, LLC, New TSI Corporate, LLC, New TSI FL Holding, LLC, New TSI MA Holding, LLC and Queens Gym, LLC as the Plan’s participating employers (collectively, the “Company”).

Effective January 1, 2021, the Plan was renamed the New TSI Holdings, Inc. 401(k) Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

##### **[2] Eligibility:**

Eligible employees may commence participation in the Plan on the first day of the month coincident with or following their completion of 90 days of employment and are at least age 21 or older.

##### **[3] Plan administrator and trustee:**

The Plan is sponsored by the Company and is administered on a day-to-day basis by the Plan administrator, an employee of the Company. The Plan is overseen by the Investment Committee, a committee comprised of employees of the Company. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (“Principal Trust”) is the Plan’s trustee, and Principal Life Insurance Company is the Plan’s recordkeeper.

##### **[4] Contributions:**

Participants may contribute up to 100% of eligible pre-tax annual eligible compensation, as defined by the Plan, subject to Internal Revenue Service (“IRS”) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, participants may make Roth contributions into the Plan. In no event may participant pre-tax and after-tax contributions exceed any statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan also provides for a discretionary matching contribution as determined by the participating employers. No discretionary matching contribution was made for the year ended December 31, 2024.

##### **[5] Participant accounts:**

Participants may elect to invest, in 1% increments, in one or more of the investment options offered by the Plan. Participants can change their investment allocations on any business day and may change their deferral rate election at any time.

Each participant’s account is credited with (a) the participant’s contribution on a weekly or bi-weekly basis through payroll deduction, (b) the Company’s discretionary matching contribution, if any, (c) forfeiture balance allocation, if any, (d) an allocation of Plan earnings based on the participant’s investment balances, and may be charged with an allocation of administrative expenses, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant’s account.

**[6] Vesting:**

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company’s discretionary matching contribution portion of their accounts, plus actual earnings thereon, is as follows:

1 but less than 2	25%
2 but less than 3	50%

**[7] Forfeitures:**

The Plan document provides that forfeited nonvested accounts be used to reduce future Company contributions or to pay administrative expenses, and any then-remaining forfeitures shall be allocated as of the last day of the Plan year in which such forfeitures are determined. Any forfeitures that are allocated as of the last day of the Plan year are deemed to be additional contributions as defined by the Plan. Such forfeitures shall be allocated as of the last day of the Plan year to each person who meets the allocation requirement, as defined, based on their annual compensation, as defined. During the year ended December 31, 2024, no forfeitures were used to pay administrative expenses. Forfeited nonvested accounts available at December 31, 2024 and 2023 were approximately \$0 and \$0, respectively.

**[8] Notes receivable from participants:**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. A participant may borrow from their vested account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of the vested account balance. Loan terms range from six months to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear interest at a rate, as determined by the Plan administrator. Interest rates on outstanding loan balances range from 4.25% to 9.00% at December 31, 2024 and from 4.25% to 9.50% at December 31, 2023. Principal and interest are paid ratably through payroll deductions. Any participant may not have more than one loan outstanding. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### **NOTE A - PLAN DESCRIPTION (CONTINUED)**

##### **[9] Payment of benefits:**

On termination of service, a participant may elect to receive a lump-sum amount equal to the vested value of his or her account. Participants who meet certain age and service requirements may also elect to receive payments in installments as defined in the Plan document. Upon the death of a participant, the beneficiary will receive the vested balance in his or her account. Participants may also elect to have the vested value of their account distributed as a direct rollover to an eligible retirement plan, as defined in the Plan document.

Upon attaining age 59½, a participant may withdraw all or a portion of his or her vested account balance. Additionally, a participant may make a withdrawal from his or her account, to the extent vested, for financial hardship. Generally, such hardship withdrawals must be for at least \$1,000 and may not be more frequent than once every three months.

#### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### **[1] Basis of presentation:**

The Plan's financial statements have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

##### **[2] Payment of benefits:**

Benefit payments are recorded when paid.

##### **[3] Use of estimates:**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

##### **[4] Investment valuation and income recognition:**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

##### [5] Plan expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to notes receivable from participants, benefit payment processing fees and recordkeeping services fees incurred in connection with the administration of the Plan are paid by the Plan and are included in administrative expenses in the statement of changes in net assets available for benefits.

##### [6] Excess contributions payable:

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to contributions.

##### [7] Subsequent events:

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

#### NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for investment assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain mutual funds held by the Plan are subject to trading limitations. Fidelity Advisor Stock Selector Mid Cap A Fund and Fidelity Advisor Strategic Income A Fund allow one roundtrip investment transaction in excess of \$1,000 per 60-day period. A roundtrip transaction occurs when a participant sells fund shares within the defined number of days from the purchase date. Participants may still transfer out of this investment to different investment options under the Plan.

MFS International Diversification R6 Fund, MFS Mass Investors Trust R6 Fund, MFS Value R6 Fund and MFS Total Return R6 Fund allow no more than two transfers valued at \$15,000 or more out of this investment option per calendar quarter.

Other mutual funds allow no more than one roundtrip transaction in a 30-day period. Participant contributions into the Plan's investment options are not impacted by the limits on investment transfer activity.

#### Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

#### NOTE E - GUARANTEED INTEREST CONTRACT WITH INSURANCE COMPANY

The Plan maintains a benefit-responsive guaranteed interest contract ("GIC") with Principal Life Insurance Company ("Principal Life") offered as Principal Fixed Income Guaranteed Option under the Plan. Principal Life maintains the contributions in a general account. The contract is reported at contract value. The guaranteed interest contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. At December 31, 2024 and 2023, the balances of the GIC held by the Plan were as follows:

Because the Plan's GIC is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest contract. Contract value, as reported to the Plan by Principal Trust, represents contributions made under the contract, plus interest at the appropriate crediting rate, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The crediting rate is based on a formula established by Principal Life, but may not be less than the guaranteed minimum interest rate as further defined in the contract. The crediting rate is generally reset semiannually and was 4.75%, net of the service fee of 0.00%, as of December 31, 2024.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive interest contracts is dependent on Principal Life's ability to meet its financial obligations. Principal Life's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Principal Life reserves the right to delay a payment or transfer out of the GIC for 30 business days if an earlier withdrawal would not allow for the orderly sale of financial instruments. Such limitation is not generally applicable to participant-level withdrawals.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer, such as premature termination of the contract and Plan termination or merger and availability of competing investment options. Transfer of the Plan's interest in the GIC that is initiated by the Plan may be subject to a 12-month irrevocable notice and a 5% surrender charge, as further defined in the contract.

#### **NOTE E - GUARANTEED INTEREST CONTRACT WITH INSURANCE COMPANY (CONTINUED)**

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract.

#### **NOTE F - EXCESS CONTRIBUTIONS**

As a result of excess contributions, the Plan recorded a liability, including earnings adjustments, as of December 31, 2024 and 2023 of \$15,305 and \$27,262, respectively. These amounts were subsequently returned to the respective participants.

#### **NOTE G - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks, as well as risks related to the financial condition of the insurance company. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participant account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

#### **NOTE H - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, the account balances of participants will become 100% vested.

#### **NOTE I - TAX STATUS**

The Plan has adopted a 401(k) Volume Submitter Plan sponsored by Principal Financial Group. On June 30, 2020, the IRS stated in an advisory letter that the Volume Submitter adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC") and, therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan, and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a governmental authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

#### **NOTE J - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain investments held by the Plan are shares of mutual funds and a guaranteed investment contract that are managed by Principal Trust and its related companies. Principal Trust is the Plan's trustee; therefore, transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan were \$119,007 for the year ended December 31, 2024.

#### **NOTE K - MUTUAL FUND FEES**

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees, which are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940, are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identified as an expense.
