Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Carbon, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

A. General

The Plan was established January 1, 2015 to provide retirement benefits to eligible employees of Carbon, Inc. (the "Company"). The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the "Code") and provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

B. Administration and Expenses

Account operating expenses and net contract asset charges are withdrawn from accounts via daily expense withdrawals. Such charges are factored into each account as a reduction in investment return. Participant loan administration and withdrawal fees are charged directly to participants. The Company pays other costs of administering the Plan.

C. Eligibility

Leased employees, interns, part-time employees scheduled to work less than 1,000 hours annually, nonresident aliens and collectively bargained employees are specifically excluded from the Plan. Substantially all other employees of the Company who have attained age 21 are eligible to participate. Eligible employees may enter the Plan on date of hire.

D. Contributions

Eligible participants may elect to make pre-tax and/or Roth after-tax contributions to the Plan up to the maximum amount permitted under Code provisions. Participants of age 50 or older may elect to make additional catch-up contributions as allowed under Code regulations. Participants who make pre-tax contributions to the Plan receive an equivalent reduction in taxable compensation. Participants are also allowed to make rollover contributions of eligible amounts received from other tax-qualified employer sponsored retirement plans subject to approval of the plan administrator. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction.

Eligible participants that do not make alternative elections will be auto enrolled at a pre-tax deferral rate of 5% that will increase 1% annually to a maximum of 10% of eligible compensation. The Plan provides for employer discretionary matching and profit sharing contributions. No discretionary employer contributions were made for 2024.

E. Vesting

Participants vest in their accounts attributable to employer matching and profit sharing contributions over four years at the rate of 25% per annum. There have been no employer contributions from Plan inception, and all participant accounts maintained under the Plan are 100% vested at December 31, 2024.

F. Participant Accounts

Participant accounts are credited with the participants' contributions, rollovers, Company contributions, if any, and an allocation of Plan earnings or losses and expenses. Participants direct the investment of their accounts among the general account and mutual fund options provided under the group annuity contract.

G. Payment of Benefits

Normal retirement age under the Plan is age 65. Participants are eligible for benefits upon attainment of age 59½, retirement, disability or termination of service. A participant or beneficiary may maintain his or her account in the Plan or elect to receive benefits payable in a lump sum or installments. The Plan provides for mandatory distribution of terminated participant accounts valued at \$1,000 or less. Hardship distributions are permitted from participants' vested accounts under limited circumstances subject to approval of the plan administrator.

Participant accounts valued at less than \$5,000 who do not make an alternative election concerning the withdrawal of their accounts are automatically rolled over into an IRA.

H. Notes Receivable from Participants

The Plan allows participants to borrow a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's account, bears interest at a fixed rate commensurate with rates available from commercial lenders for similar types of loans and must be repaid to the Plan within a five-year period, unless a loan is used for the purchase of a principal residence, in which case the maximum repayment period may be extended to 30 years. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 5.25% to 10.50% with maturities through April 2050. Notes receivable are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on terms of the Plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Plan investments are stated at fair value except for fully benefit responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made under the contract plus

earnings less withdrawals and expenses. Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

D. Risks and Uncertainties

Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - TAX STATUS

The Company adopted a prototype plan that has received a favorable opinion letter from the Internal Revenue Service stating that the form of the Plan meets requirements for tax-exempt status. The Company believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

NOTE 5 - RELATED PARTY TRANSACTIONS

Certain Plan investments and managed by affiliates of the trustee. Purchases and sales of these investments and payments of direct and indirect administrative fees to Plan service providers by the Plan are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE AND CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation of investments, interest and dividends for the year ended December 31, 2024 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee and custodian.

NOTE 7 - FAIR VALUE MEASUREMENTS

Accounting guidance establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management estimates of assumptions market participants would use in pricing the asset or liability.

Mutual fund investments are valued based on closing market prices for shares held by the Plan at year end. The following tables summarize Plan investments at December 31, 2024 and 2023 based on the inputs used to value them:

Although the plan administrator believes this valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value could result in a different fair value measurement at the reporting date.

NOTE 8 - GUARANTEED RETURN ACCOUNT

Investments in the Lincoln Stable Value Account are maintained in a general account by Fidelity Management Trust Company who is contractually obligated to repay principal and a specified interest rate to the Plan. Because the Guaranteed Return Account is a fully benefit-responsive investment, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to this fund. Participants may direct the withdrawal or transfer of all or a portion of their investment in the account at contract value. Interest is credited daily to amounts allocated to the contract at the rate declared at the beginning of the quarter, subject to a minimum guaranteed rate set forth in the contract. The minimum crediting rate under the contract was 1.00%.

Certain events might limit the ability of the Plan to transact at contract value including premature termination of Plan investments in the Guaranteed Account. The plan administrator does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring.

NOTE 9 - RECONCILIATION OF FINANCIAL STATEMENTS TO THE FORM 5500

The differences between the information reported in the financial statements and the information reported in the Form 5500 arise primarily from presenting the financial statements on the accrual basis of accounting.
