### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Masada Homes Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. 
