Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE 1 - DESCRIPTION OF PLAN

The following description of the US Magnesium LLC Hourly 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all hourly employees of US Magnesium LLC (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's custodian is Reliance Trust Company ("Reliance"). Standard Insurance Company ("Standard") is the third-party recordkeeper of the Plan.

Contributions: Each year, participants may make salary deferrals as either pre-tax or Roth contributions in amounts up to the maximum allowed by law. The Plan provides for auto-enrollment at 6% of compensation. Participants may also contribute amounts representing distributions from other qualified plans and eligible participants may make catch-up contributions to the Plan. In accordance with the provisions of the Plan, the Company may make discretionary matching contributions of up to 6% of eligible compensation. During the 2024 plan year, the Company made no matching contributions. Additionally, the Company shall make contributions to the Plan based on the age, years of service and compensation of each participant. During the 2024 plan year, the Company made additional contributions of \$102,893. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's own contributions, an allocation of any Company contributions and plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, participant transactions, contributions or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Each participant directs his or her account into any of the investment options available under the Plan. Participants may change their investment options at any time.

Vesting: Participants are immediately vested in their own contributions plus earnings thereon. Vesting in the Company's contribution plus actual earnings thereon is based upon years of continuous service. Participants are 100% vested following a five-year graded vesting schedule. Participants become fully vested upon reaching the age of 65, retirement, death, disability or permanent layoff, regardless of years of service.

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested balance in his or her account. Benefit amounts under \$5,000 are automatically distributed to participants. Participants or their beneficiaries may elect to receive their vested account balances as an installment, an annuity, or as a single lump sum. Participants over the age of 59 ½ may take in-service withdrawals. In certain circumstances, participants not over the age of 59 ½ may take "hardship withdrawals" as defined in the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Notes Receivable from Participants: A participant may borrow up to the lesser of \$50,000 or 50% of his or her vested account balances with a minimum note of \$1,000. The note will bear interest at a rate commensurate with market rates for similar notes. All notes are covered by demand notes and are repayable through payroll withholding or periodic payments.

Forfeitures: The Plan provides that the forfeitures of terminated participants' non-vested accounts may be used to pay the Plan's administrative expenses or to offset Company contributions to the Plan. During 2024, forfeitures of \$38,110 were used to reduce the Company's contributions. There were \$23,587 and \$23,438 forfeited non-vested accounts available at December 31, 2024 and 2023, respectively.

Administrative Expenses: Certain administrative expenses of the Plan, including trust and investment management fees, are paid by the Plan. Certain professional fees are paid by the Company. Investment management fees and certain operating expenses charged to the Plan for investments in the pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, these management fees and operating expenses are reflected as a reduction of investment return for such investments.

Subsequent Events: Subsequent to year-end, on September 10th, 2025, the plan sponsor, US Magnesium LLC, filed for protection under Chapter 11 of the U.S. Bankruptcy Code. This event occurred after the plan's reporting period and does not affect the financial position or operations of the Plan.

Under applicable pension and trust law, the Plan's assets are held in trust for the exclusive benefit of participants and beneficiaries and are legally separate from the assets of US Magnesium LLC. Accordingly, the Plan's assets are not available to satisfy the debts or obligations of the plan sponsor.

Plan management has evaluated subsequent events for recognition and disclosure through October 15, 2025, which is the date the financial statements were available to be issued.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates. Certain investments are particularly subject to change in the near term.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks, such as interest rate, market, liquidity, credit risks, and global events. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Investment Valuation and Income Recognition: The Plan's investments other than fully benefit-responsive investment contracts are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 3 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs when measuring fair value. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trusts: The fair values of participation units held in collective trust funds were based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each collective trust provided for daily redemptions by the plan at reported net asset values per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance (the trustee of the Plan). Excluded from the investment information certified by Reliance were notes receivable from participants of \$245,434 and \$459,275 at December 31, 2024 and 2023, respectively, and interest income from notes receivable from participants of \$21,102 for the year ended December 31, 2024.

NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a fully benefit-responsive investment contract with Standard that is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the Plan's fully benefit-responsive investment contract, by general type, are presented below:

Standard maintains the contributions in its general account. Standard's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the Standard or otherwise.

NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY (Continued)

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include plan termination, plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Standard may terminate the contract. Examples of circumstances which would allow the Standard to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, the Standard could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

The crediting interest rate of the contract is based on an agreed-upon formula with the Standard, as defined in the contract agreement, but cannot be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting. The key factors that influence future interest crediting rates could include the following: the level of market interest rates; the amount and timing of participant contributions, transfers and withdrawals into/out of the contracts; and the duration of the underlying investments backing the contract.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan invests in a fully benefit-responsive contract in 2024 and 2023 managed and issued by Standard, a service provider to the Plan. Accordingly, these investments qualify as party-in-interest investments. Accordingly, this investment is a party-in-interest investment. Notes receivable from participants are also party-in-interest investments. Administrative expenses paid to Reliance and Standard were not significant during 2024 and 2023. Administrative expenses paid by the Plan to Reliance and Standard qualify as party-in-interest transactions.

NOTE 7 - INCOME TAX STATUS

The Plan is stated on a pre-approved volume submitter plan document that has received a favorable opinion letter from the IRS dated June 30, 2020. Since the Plan is using a volume submitter plan document that has received a favorable opinion letter, the Plan is not required to file for an individual determination letter. The Plan has been amended since the adoption of the volume submitter plan; however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 - TRANSFER OF ASSETS TO ANOTHER PLAN

The Company maintains a separate 401(k) plan for salaried employees, the US Magnesium LLC Salaried Pension and 401(k) Plan (Salaried Plan). When participants change their employment status with the Company from hourly to salaried, the participant's balance in the Plan is transferred to the Salaried Plan. During 2024, participants with account balances aggregating \$62,288 changed employment status and their individual account balances were transferred from the Plan, in accordance with Company policy and the provisions of the respective plan documents.
