INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of  
Knight Law Group LLP Retirement Plan

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Knight Law Group LLP Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Knight Law Group LLP Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Knight Law Group LLP Retirement Plan’s ability to continue as a going concern for one year after the date financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors’ Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Knight Law Group LLP Retirement Plan’s internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Knight Law Group LLP Retirement Plan’s ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental Schedule H, line 4i-Schedule of Assets (Held at End of Year) as of the year ended December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### NOTE A. DESCRIPTION OF THE PLAN

The following description of the Knight Law Group LLP Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### 1. General

The Plan is a defined contribution plan, covering all eligible employees of Knight Law Group LLP and the participating Employers (“Plan Sponsor”). Employees must be at least 21 years of age and have completed two months of service with a minimum of 167 hours of service to participate in the Plan. Employees may enter the Plan on the first day of the month coinciding with or next following the date these requirements are met. The Plan was established by the Plan Sponsor on January 1, 2013, to provide retirement income for its employees, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (“ERISA”).

##### 2. Contributions

The Plan is a contributory plan whereby participants may contribute, on a tax-deferred basis up to 100% of their pre-tax annual salary, not to exceed the maximum deferral limits set by the Internal Revenue Code (“IRC”) Section 402(g)(1). Participants age 50 or older may elect to defer an additional “catch-up” contribution. In addition, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan Sponsor contributes a safe harbor contribution, for eligible participants that complete at least one year of service, of 3% of compensation to the Plan. The contributions are subject to limitations established under the IRC. Safe harbor contributions for the year ended December 31, 2024 were \$332,225.

The Plan offers a matching contribution to eligible participants, who have completed two months of service and complete 167 hours of service within the two month period, which equals 50% of a participant’s deferred compensation up to 6% of compensation, as defined by the Plan. For the year ended December 31, 2024, matching contributions were \$266,693.

The Plan Sponsor may also make discretionary contributions to the Plan in the form of a profit-sharing contribution to eligible participants, who have completed two months of service and complete 167 hours of service within the two month period. The profit-sharing contribution is allocated to the account of each participant that is employed on the last day of the Plan year and is paid for more than 500 hours of service, in a manner determined by the Plan Sponsor. Profit-sharing contributions will be made solely at the discretion of the Plan Sponsor’s Board of Directors. Profit-sharing contributions for the year ended December 31, 2024 were \$72,596.

#### 3. Rollovers

An employee who qualifies as part of an eligible class of employees can make rollover contributions subject to the guidelines of the Plan.

#### 4. Participant Accounts

Each participant's account is credited with the employee's contributions, rollovers, Employer matching, safe harbor contributions, and an allocation of Plan's earnings, profit sharing, and charged with an allocation of administrative expenses. Allocations are based on participant's earnings or account balances, as defined. A participant is entitled to the benefit that can be provided from their vested account.

#### 5. Investment Options

Participants may direct employee and Employer contributions as desired, in any of a variety of investments held by John Hancock Life Insurance Company (U.S.A.) ("John Hancock"), as provided by the Plan, as well as self-directed investment accounts. Participants may change their investment options daily.

#### 6. Vesting

Participants are fully vested in their contributions and the Plan Sponsor's safe harbor contributions, plus actual earnings thereon. The Plan Sponsor's profit-sharing and matching contributions vest based on years of service as follows:

#### 7. Benefit Payments

At retirement, disability, or death while employed, a participant automatically becomes 100% vested and may elect to receive either a lump-sum amount equal to the value of the participant's account, annuities, or periodic installments as defined by the Plan. For termination of services for other reasons, a participant may receive the value of the vested interest in his or her account as defined by the Plan. In-service and hardship withdrawals are permitted if certain criteria are met.

#### NOTE A. DESCRIPTION OF THE PLAN (Continued)

##### 8. Forfeitures

Forfeitures may be used to pay administrative expenses or reduce future discretionary Company contributions. Forfeitures in the amount of \$111,012 were applied to Company contributions during the year ended December 31, 2024. As of December 31, 2024 and 2023, outstanding forfeitures available totaled \$75,907 and \$110,756 and are included in the statements of net assets available for benefits, respectively.

##### 9. Plan Termination

Although it has not expressed such intent, the Employer reserves the right under the Plan document to amend or terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their accounts and funds will be distributed in accordance with the Plan terms and the IRC.

#### NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### 1. Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

##### 2. Plan Administration

The Employer is the Plan Sponsor and the plan administrator. The plan administrator is responsible for carrying out the duties imposed under ERISA.

##### 3. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### 4. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisor and Trustee. See Note D for further discussion of fair value measurements.

##### 4. Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation/depreciation includes the gains and losses on investments bought and sold as well as held during the year.

##### 5. Payment of Benefits

Benefits are recorded when paid

##### 6. Administrative and Other Expenses

Administrative expenses incurred by John Hancock in performance of its duties are paid from the assets of the Plan. Fees related to the administration of notes receivable from participants and other participant specific fees are charged directly to the participant's account and are included in administrative expenses. Other reasonable Plan expenses may be paid from the Plan's forfeiture account (see Note A.8). Investment-related expenses are included in net appreciation in the fair value of investments. Certain expenses for maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

##### 7. Contributions

Contributions from plan participants and the matching contributions from the Employer are recorded in the year which the employee contributions are withheld from compensation.

#### NOTE C. CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of December 31, 2024 and 2023 and net appreciation in fair value of investments for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.), the custodian of the Plan and a qualified institution.

#### NOTE D. FAIR VALUE MEASUREMENTS

The framework used for measuring fair value provides a hierarchy that prioritizes the inputs used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 compared to December 31, 2023.

*Pooled Separate Accounts:* The net asset value ("NAV") of these accounts is based on the market value of their underlying investments. The NAV is not a publicly quoted price in an active market. The pooled separate accounts do not have unfunded commitments relating to their investments, or any significant restrictions on participant-directed withdrawals. Participant-directed withdrawals can be made on any business day and do not have a redemption notice period.

Participant-directed transfers to other investment options are generally limited to two per calendar month. Additional restrictions, as defined, may be applied under extreme market or personal circumstances or in the event an exchange may disrupt or be potentially disruptive to an investment option.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are held and managed by John Hancock. John Hancock is the custodian, trustee and recordkeeper as defined by the Plan; and therefore, these transactions qualify as party-in-interest transactions.

**NOTE F. RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in mutual funds. Investment securities are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

#### **NOTE F. RISKS AND UNCERTAINTIES (Continued)**

The Plan invests through mutual funds in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

#### **NOTE G. INCOME TAX STATUS**

The Employer adopted a Volume Submitter Profit Sharing Plan with CODA ("Volume Submitter Plan"), which received its latest opinion letter from the Internal Revenue Service ("IRS") on December 7, 2020, which stated that the Volume Submitter Plan, as then designed, was in compliance with the applicable requirements of the IRC. The plan administrator and the plan's advisors believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Administration errors, if any, that are insignificant or operational in nature, are handled by the plan administrator in accordance with applicable IRS correction policies. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

#### **NOTE H. SUBSEQUENT EVENT**

Plan management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued and have concluded there were no events required to be disclosed except as noted below.

Effective January 1, 2025, the Company amended its adoption agreement to reflect two changes made to the Plan. First, the determination of entry date for safe harbor contributions was modified from a quarterly assessment to a semi-annual schedule. Second, the Plan's matching contribution formula was revised from a fixed formula to a discretionary structure. Under the amended provision, the Employer may determine the matching contribution rate at its discretion, subject to applicable plan and regulatory requirements.
