Notes to Financial Statements

Year Ended December 31, 2024

1. Description of plan:

The following description of the Hull Supply Company, Inc. 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan was established in January 1995, and has been amended several times since that date.

General:

The Sponsor of the Plan is Hull Supply Company, Inc. (Sponsor).

The Plan is a defined contribution retirement plan with 401(k) provisions consisting of a salary reduction arrangement. The Plan covers all employees of the Sponsor who have completed 30 days of service and are at least 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participants' contributions:

Under the 401(k) provisions of the Plan, the participants may elect to defer up to 100% of their eligible compensation, as defined by the Plan, up to current statutory limits determined annually and prescribed by the Internal Revenue Service (IRS). Participant contributions may be in the form of pre-tax or Roth contributions. The Plan also permits participants to make additional voluntary contributions of qualified rollovers from other retirement plans. Participants may also elect to make pre-tax and Roth catch-up contributions to the Plan.

Employer contributions:

The employer may make safe harbor matching, discretionary matching or discretionary profit sharing contributions to the Plan. Employees must have worked 1,000 hours during the plan year and be employed on the last day of the plan year to be eligible for any discretionary profit sharing contributions. Employer contributions are invested in the same funds and increments as directed by the participant for the participant's contributions. The Sponsor did not make a discretionary matching or profit sharing contribution for 2024.

For the year ended December 31, 2024, the Sponsor made a safe harbor matching contribution equal to 100% of participant contributions up to 3% of compensation, plus 50% of participant contributions that exceed 3% but do not exceed 5% of a participant's eligible compensation. The match was made on a per pay period basis.

Participant accounts:

Each participant's account is credited with the participant's elective deferral, rollover, and employer contributions, actual earnings thereon and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements (continued)

Year Ended December 31, 2024

1. Description of plan (continued):

Vesting:

Participants are immediately vested in their elective deferral, safe harbor matching and any rollover contributions made to the Plan, plus actual earnings thereon. Vesting in the employer's discretionary matching and profit sharing contribution portion of the participant's accounts, plus actual earnings thereon, is based on years of credited service. Participants vest at 20% annually, beginning with the completion of their second year and are fully vested after six years of credited service. The Plan defines a year of credited service to be a Plan year (January 1 through December 31) with the participant rendering at least 1,000 hours of service. Upon death or total disability of a participant prior to retirement, the participant's account balance shall become fully vested.

Participants' loans:

The Plan allows for participants to obtain loans from the Plan. All loans cannot exceed the vested portion of the participant's account (or \$50,000 if less) and must be a minimum of \$1,000. The loan must be repaid within five years unless the entire proceeds are used to purchase the participant's primary residence, in which case the loan may be repaid over 15 years. All loans will provide for the repayment of interest at rates at the prime rate plus one percent on the date of the loan. Principal and interest may be paid through payroll deduction or personal check. The participant's individual account serves as collateral for the loan and, in the event of default, death, disability or termination of employment, the entire outstanding principal and accrued interest shall be immediately due and payable. Loans will be considered in default if payments are not made for 90 days or if there is any outstanding principal remaining after the last scheduled repayment date. Because the participant's account collateralizes the loan in its entirety, the credit quality of the participant is not assessed by the Plan Administrator. Unpaid loans will be treated as a taxable distribution from the Plan.

For financial reporting purposes, participants' loans are included in the statements of net assets available for benefits as notes receivable from participants.

Investment options:

Upon enrollment in the Plan, a participant may direct contributions in any increments into any of several investment options. Participants may change their investment options inside the platform at any time.

Payment of benefits:

On termination of service due to death, disability, retirement or other reasons, a participant whose vested account balance exceeds \$7,000 may elect to receive a lump sum payment. Participants with account balances less than \$7,000 must take a lump-sum distribution as soon as practicable following termination.

Forfeited accounts:

The Plan allocates participant forfeitures to reduce administrative costs or to reduce employer contributions. At December 31, 2024, there were no nonvested amounts to be forfeited in future periods.

1. Description of plan (continued):

Hardship withdrawals:

If approved by the Plan Administrator, a participant may withdraw a portion of his/her pre-tax elective deferral account balance to satisfy any of the following immediate and heavy financial needs: unreimbursed medical expenses for qualified persons, purchase of a principal residence, to prevent eviction from or foreclosure on a principal residence, to pay for post-secondary education expenses for qualified persons, funeral expenses or for expenses that qualify as a casualty deduction under the Internal Revenue Code (IRC).

2. Summary of significant accounting policies:

Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of the fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Net appreciation in the fair value of investments includes both realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of benefits:

Benefits paid to participants are recorded when paid.

2. Summary of significant accounting policies (continued):

Expenses:

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid for by the Sponsor. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events:

The Plan has evaluated the events that have occurred subsequent to December 31, 2024 through October 13, 2025, the date that the financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

3. Federal income tax status:

The Sponsor has adopted a non-standardized pre-approved profit sharing/money purchase/CODA plan as published by Nova 401K Associates Inc, who obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Sponsor believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets or active markets that the Plan does not have access to;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Pooled separate accounts: These accounts' assets are invested and reinvested primarily in mutual funds, equity securities, and fixed maturity securities. Investments are valued using pricing data provided by outside valuation service providers. Each account is valued at its net asset value. The net asset value of the accounts' units is determined daily and includes adjustments for investment fees. The funds' daily value is available at empower.com.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investments:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Empower Annuity Insurance Company of America (EAIC) as agent for Massachusetts Mutual Life Insurance Company (MassMutual).

6. Investment contract with insurance company:

The Plan entered into a benefit-responsive investment contract with the MassMutual. MassMutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by MassMutual, represents contributions made under the contract, less participant withdrawals and administrative expenses, plus interest credited. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield, based on both actual earnings and the interest rate credited to participants, was 2.80% for the year ended December 31, 2024. The crediting interest rate is based upon an agreed-upon formula, and is reviewed on a quarterly basis for resetting but may not be less than 0%.

6. Investment contract with insurance company (continued):

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

7. Related party and party-in-interest transactions:

Exempt party-in-interest transaction:

The Plan paid certain expenses throughout 2024 to EAIC, MassMutual and other service providers related to plan administration and investment activity. These transactions qualify as exempt party-in-interest transactions under ERISA.

Related party transactions:

Expenses that are paid directly by the Sponsor are excluded from these financial statements. Employees of the Sponsor perform certain accounting and administrative functions for the Plan, however, no employee receives compensation from the Plan.

8. Plan termination:

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

9. Risks and uncertainties:

The Plan invests in various investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
