### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of the Versova Management Company, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

**1. Summary of Significant Plan Provisions**

The following description of the Versova Management Company, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- a. **General** – The Plan is a multiple employer defined contribution plan for the benefit of employees of Versova Management Company, LLC, Center Fresh Egg Farm L.L.P., Centrum Valley Farms, LLP, Trillium Farm Holdings, LLC, Iowa Cagefree, LLP, Hawkeye Pride Egg Farms, L.L.P., Willamette Egg Farms LLC, Morning Fresh Farms, Inc., and Oakdell Farms, LLC (the “Employer”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.
- b. **Eligibility** – Each employee, who is not a member of a collective bargaining unit or nonresident alien, shall be eligible to participate in the Plan provided that the employee has completed three months of service and attained age 21. Entry dates are the first day of each month.
- c. **Contributions** – Participants may contribute through payroll deductions and eligible rollover contributions. Contributions made through payroll deductions can be made in an amount up to the maximum amount allowed by the Internal Revenue Code (“IRC”). The Employer will make a safe harbor matching contribution equal to 100% of a participant’s contribution up to 3% of the participant’s compensation, plus 50% of a participant’s contribution that exceeds 3% of the participant’s eligible compensation up to 5% of the participant’s eligible compensation. The Employer may also make additional discretionary contributions to the Plan. No such discretionary contributions were made during the year ended December 31, 2024.
- d. **Participant accounts** – Each participant’s account is credited with the participant’s and Employer contributions and allocations of Plan earnings/losses, and is charged with applicable withdrawals and an allocation of administrative expenses. Allocations are based on participant’s earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting** – Participants are, at all times, fully vested with respect to their own contributions and the Employer safe harbor matching contributions, plus earnings/loss thereon. All benefits attributable to a participant shall be fully vested if they reach normal retirement age, become totally disabled, or upon death. If a participant terminates employment for any reason other than those previously mentioned, they are entitled to a vested percentage of discretionary Employer contributions and earning/losses thereon. This vested percentage is determined as follows:

- f. **Investment options** – Upon enrollment in the Plan, a participant may direct contributions into any of the investments offered by the Plan. Participants may change their investment selections at any time.
- g. **Forfeitures** – The portion of a participant’s account to which they are not entitled upon termination of participation is deemed a forfeiture. Forfeitures are used to pay plan expenses or to reduce Employer contributions for the Plan year in which the forfeiture occurs and are allocated in the same manner as the contributions they reduce. No forfeitures were utilized to pay plan expenses for the year ended December 31, 2024. Forfeitures available for future use amounted to \$1,642 and \$0 as of December 31, 2024 and 2023, respectively.
- h. **Payment of benefits** – Upon separation of service due to death, disability, retirement, or termination, the vested portion of the participant’s account will be paid in a lump sum as soon as administratively feasible following the date on which a distribution is requested or is otherwise payable. Participants, upon termination of employment, may also elect to defer payment on their account balance if it exceeds \$5,000. If a terminated participant’s account balance is equal to or less than \$5,000, the account will be automatically distributed. In-service withdrawals are available to participants who attain age 59½ or who meet certain hardship requirements.
- i. **Termination of the Plan** – Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**2. Summary of Significant Accounting Policies**

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- b. **Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.
- c. **Investment valuation and income recognition** – Investments are reported at fair value, except for the fully benefit-responsive investment contracts, which are reported at contract value as disclosed in Note 3. See Note 5 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

2. **Summary of Significant Accounting Policies (cont.)**

- d. **Payment of benefits** – Benefits are recorded when paid.
- e. **Administrative expenses** – Administrative expenses are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Distribution fees are charged directly to the participant’s account.

3. **Fully Benefit-Responsive Investment Contract**

The Plan has entered into a fully benefit-responsive guaranteed investment contract (“GIC”) with Voya Retirement Insurance and Annuity Company (“Voya”). Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Voya is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion of, their investment at contract value.

There are no reserves against the contract value for credit risk of Voya. The contract guarantees a periodic minimum rate of interest declared monthly. The interest rate is guaranteed to be not less than zero.

Certain events limit the ability of the Plan to transact at contract with the issuer. Such events include termination of the contract or termination of the Plan. The Plan’s management does not believe the occurrence of any such event, which could limit the Plan’s ability to transact at contract value with participants, is probable.

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Voya, the custodian of the Plan, and was not subjected to any audit procedures, except for comparing the information with the related information included in the financial statements and supplemental schedules:

- a. Total investments as shown on the accompanying statement of net assets available for benefits of \$28,957,795 and \$18,391,600 as of December 31, 2024 and 2023, respectively.
- b. Interest and dividends as shown on the accompanying statement of changes in net assets available for benefits of \$14,801 for the year ended December 31, 2024.
- c. Net change in value of investments as shown on the accompanying statement of changes in net assets available for benefits of \$2,657,406 for the year ended December 31, 2024.
- d. All investment transactions that occurred during the year ended December 31, 2024.
- e. All of the information included in the supplemental schedules.

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**5. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

**Notes to Financial Statements**

5. **Fair Value Measurements** (cont.)

The three levels of the fair value hierarchy are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 or 2023.

*Mutual funds:* These investments are valued at quoted market prices on the last business day of the Plan year.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan is utilizing a non-standardized pre-approved profit sharing plan document (the “Plan Document”), which received an opinion letter dated June 30, 2020, in which the Internal Revenue Service (“IRS”) stated the Plan Document is designed in accordance with the applicable sections of the IRC. As allowed by the IRS, the Plan is relying on the opinion letter of the Plan Document for its own qualification. Although the Plan Document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. Parties-in-Interest Transactions**

Voya is the custodian of the Plan. The Plan pays Voya for its services. Inasmuch as Voya serves as custodian of the Plan, it is by definition a party-in-interest and, as a result, the investments in the GIC and mutual funds issued by Voya, and investment transactions pertaining to these investments, were with a party-in-interest. Pension Administrators, L.L.C. (“Pension Administrators”) serves as third-party administrator of the Plan. The Plan pays Pension Administrators for its services. Inasmuch as Pension Administrators serves as third-party administrator of the Plan, it is by definition a party-in-interest. All of these transactions are exempt from being prohibited transactions under ERISA.

**8. Delinquent Participant Contributions**

The Plan sponsor determined that during the 2024 Plan year, certain participant contributions were not remitted within the required time frame specified by the DOL’s regulations, which have been reported on the accompanying Schedule H, line 4a – Schedule of Delinquent Participant Contributions in the amount of \$13,182. All participant contributions have been remitted to the Plan as of August 1, 2025. The Plan sponsor is in the process of finalizing lost earnings and will make corrections outside of the Voluntary Fiduciary Correction Program.

**9. Subsequent Events Evaluation Date**

Management of the Plan evaluated the events and transactions subsequent to its December 31, 2024 financial statement date and determined there were no subsequent events necessary for disclosure through October 15, 2025, which is the financial statement issuance date.
