## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of GTM WHOLESALE LIQUIDATORS, INC. 401(K) PLAN (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (an "ERISA Section 103(a)(3)(C) audit"). Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

### NOTE 1. DESCRIPTION OF THE PLAN

The GTM WHOLESALE LIQUIDATORS, INC. 401(K) PLAN (the “Plan”) is a defined contribution plan established in 1991. The Plan is sponsored by GTM Wholesale Liquidators, Inc. (the “Company”) to allow eligible employees of the Company to adopt a regular program of savings for retirement.

The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (“ERISA”). Significant provisions of the Plan are summarized below. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### Eligibility

Employees of the Company are generally eligible to participate in the Plan if they are at least twenty-one years of age and have completed one year of service with the Company. For purposes of determining eligibility, a year of service is defined as having provided at least 1,000 hours of service during the 12-consecutive month period commencing on an employee's date of hire. Entry dates are the first day of each month coincident with or next following the date on which an employee meets the eligibility criteria.

Certain employees are not eligible to participate in the Plan, including employees covered by a collective bargaining agreement and nonresident aliens who received no U.S. sourced income.

#### Participant Contributions

Eligible participants may contribute up to 100% of eligible compensation, as defined by the Plan. Participants may designate their contributions as pre-tax elective deferral contributions or Roth elective deferral contributions. In addition, employees who are age 50 or older can elect to defer additional amounts (called “catch-up contributions”) to the Plan. All participant contributions are subject to limitations imposed by the Internal Revenue Code (“IRC”). Participants may also contribute amounts representing rollover distributions from other qualified sources.

On January 1, 2021, the Plan implemented auto-enrollment at 3% of eligible compensation for all eligible employees to the extent that no election was made or their current deferral elections were less than 3% at the time of implementation.

#### Employer Contributions

*Employer Matching Contributions* – The Plan provides for an employer matching contribution (calculated on a per payroll period basis) equal to 50% of a participant's elective deferral and catch-up contributions, up to 6% of a participant's eligible compensation during the applicable payroll period.

*Profit-Sharing Contributions* – The Plan also allows the Company to make discretionary profit-sharing contributions based on a discretionary formula to be determined each year, and allocated among participants using an age-weighted formula defined by the Plan. For purposes of any profit-sharing contributions, compensation is generally based on the Plan year; however, during the Plan year in which an employee enters the Plan, only compensation earned subsequent to the participant's entry date will be considered. In addition, for purposes of determining eligibility for any discretionary profit-sharing contributions made by the Company for a particular Plan year, employees generally must also be employed on the last day of the applicable Plan year. For the year ended December 31, 2024, the Company did not make any profit-sharing contributions to the Plan.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, any employer contributions, and allocations of Plan earnings and losses, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined.

#### Investment Options

All investments are participant-directed. Upon enrollment into the Plan, participants may direct their contributions to any or all of the investment options offered by the Plan. Subsequently, participants may change their allocations and transfer account balances among the investment options offered by the Plan.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employer matching and profit-sharing contributions vest based on years of vesting service, as follows:

For vesting purposes, a year of service is defined as having provided at least 1,000 hours of service during a Plan year. Upon termination of service due to death, disability, or reaching normal retirement (age 65), employees become fully vested in their accounts.

#### Forfeitures

Forfeitures of employer matching contributions may be used at the discretion of the Company for any allowable purpose. The balance in the forfeitures account as of December 31, 2024 and 2023 was \$4,998 and \$3,487, respectively. The forfeitures account activity is not material to the financial statements for the year ended December 31, 2024.

#### Notes Receivable from Participants (Participant Loans)

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum generally equal to the lesser of \$50,000 or one half of their vested account balance. Such loans are secured by the vested balance in the participant's account and generally bear interest at a fixed rate equal to 1% in excess of the prime rate published in the *Wall Street Journal* on the first business day of the month in which the participant applied for the loan. Principal and interest on loans are generally paid regularly through payroll deductions on a per-payroll basis. Loans are generally repaid within five years unless the proceeds were used toward the purchase of a primary residence, in which case the repayment period may be extended. Outstanding loans become due and payable upon a participant's termination of employment with the Company. As of December 31, 2024, interest rates on outstanding notes receivable from participants ranged from 4.25% to 9.75%.

#### **Payment of Benefits**

Upon attaining age 59½, participants who are employed with the Company may request an in-service distribution from their pre-tax or Roth elective deferral accounts, as well as from that portion of a participant's account attributable to employer matching or profit-sharing contributions that are fully vested. The Plan does not permit hardship withdrawals as defined by the IRC.

Upon disability, death, termination, or upon normal retirement, participants (or their beneficiaries, if applicable) may elect to receive a distribution of their vested account in a lump sum, partial payments, or installment payments. Alternatively, participants they may use their account toward the purchase of an annuity contract, as prescribed, or they may defer distribution if their vested account balance exceeds \$7,000.

Pursuant to the provisions in the Setting Every Community Up for Retirement Enhancement Act of 2019 (the "SECURE" Act), which became law on December 20, 2019, and the SECURE 2.0 Act of 2022 (the "SECURE 2.0 Act"), which became law on December 29, 2022, participants may defer taking distributions as follows:

- If a participant reached the age of 70½ in 2019, the participant may defer receiving distributions until the later of April 1, 2020, or the April following the calendar year in which the participant retires;
- If a participant reaches the age of 70½ in 2020 or later, the participant may defer receiving distributions until the later of the April following the calendar year in which the participant reaches age 72 or retires, except that –
- Beginning in 2023, the age a participant must begin taking distributions was raised to 73. If a participant reached the age of 72 during 2023, the participant may defer receiving distributions until April 1, 2025, the latest date that a required minimum distribution may be taken for 2024.

Upon employment termination, if a participant's vested account balance is between \$1,000 and \$7,000, and if the participant has not elected to receive a cash distribution or have the balance rolled over into an individual retirement account ("IRA") of his/her choosing, the Plan may transfer the participant's account balance into an IRA. Also at its discretion, the Plan may elect to distribute vested account balances of less than \$1,000.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions into the Plan at any time and to terminate the Plan subject to provision of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts including any employer contributions in the Plan.

### **NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, as well as the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation or depreciation in the fair value of pooled separate accounts and common/collective trust includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants (Participant Loans)**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses, charged to participant accounts, and expensed when paid. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

The Plan's administrative expenses are generally paid by the Company. These expenses may include, but are not limited to, custodian, trustee, legal, and accounting expenses. Participants are responsible for distribution and loan-related expenses.

#### **Subsequent Events**

The Plan has evaluated subsequent events through the date of the independent auditors' report, which is the date these financial statements were available to be issued.

### **NOTE 3. INFORMATION CERTIFIED BY THE CUSTODIAN**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the ERISA-required supplemental schedule (Schedule H, Part IV, Line 4i), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation or depreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company, the custodian of the Plan.

### NOTE 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs are unadjusted, quoted market prices in active markets for identical assets or liabilities at the measurement date.

Level 2 – Inputs are either directly or indirectly observable for the asset or liability through correlation with related market data at the measurement date and for the duration of the instrument’s anticipated life. Inputs include, for example, quoted prices for similar assets or liabilities in active markets; quoted prices for identical assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs are both unobservable and significant to the overall fair value measurement for the asset or liability at the measurement date. These inputs reflect Plan management’s best estimate of what market participants would use in pricing the asset or liability at the measurement date. Consideration is given to the risk inherent in the valuation technique and in the inputs to the model.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodology used for assets measured at fair value at December 31, 2024 and 2023:

*Pooled Separate Accounts:* Valued at the separate accounts unit value of shares held by the Plan. Separate accounts unit value is based upon the fair value of the underlying investments. Fair value of shares of an underlying fund equals the number of shares of the respective underlying fund multiplied by the closing net asset value per share quoted by the fund. Any distributions received from an underlying fund are reinvested into additional shares of the underlying fund. The separate accounts do not publish their daily price per unit with any third party.

*Common/Collective Trust:* Valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer may reserve the right to require a notification period in order to ensure that securities liquidations will be carried out in an orderly business manner.

The John Hancock Stable Value Fund is a stable value collective trust which primarily consists of indirect investments in a group annuity contract and guaranteed investment contracts, through multiple investment companies. Consistent with FASB ASC 820, the stable value collective trust's contract value is considered its fair value for financial reporting purposes as that is the amount at which participants would normally transact with the Plan.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 5. TAX STATUS

Effective January 1, 2022, the Company adopted a pre-approved profit sharing plan, and relies upon the pre-approved plan's opinion letter from the IRS, in which the IRS stated that, in its opinion, the pre-approved plan's design was in accordance with the applicable requirements of the IRC. The Company has not applied for a determination letter from the IRS specific to the Plan. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the accompanying financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### NOTE 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the accompanying financial statements.

### **NOTE 7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Company pays certain of the Plan's operating expenses and also provides administrative services at no cost to the Plan. Certain investments are managed by the custodian of the Plan. In addition, the Plan allows participants to take loans against their account balances. These transactions qualify as exempt party-in-interest transactions.

### **NOTE 8. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

Certain investments are classified differently on the Form 5500 from how they are disclosed in the financial statements. For financial statement purposes, investments at fair value are disclosed as consisting of pooled separate accounts and a common/collective trust (Note 4). Although the investments meet the definition of pooled separate accounts and common/collective trust, because the custodian doesn't separately report its pooled separate account and common/collective trust assets to the Department of Labor, these investments are categorized according to their underlying investments (other investments) rather than as pooled separate accounts and common/collective trust on Schedule H of the Form 5500.

### **NOTE 9. SECURE 2.0 ACT**

On December 29, 2022, the SECURE 2.0 Act became law. The purpose of the legislation is to expand access to retirement plans and to help working Americans increase their retirement savings. In addition to the changes to distributions described in Note 1, the SECURE 2.0 Act includes various required and optional provisions that become effective through 2033, certain of which are described below.

- Beginning January 1, 2025, a participant from the ages 60 to 63 can elect catch-up contributions up to the limit of the greater of \$10,000 or 150% of the catch-up contribution limit imposed by the IRS.
- Beginning January 1, 2025, long-term part-time workers (defined as employees who have worked for two consecutive 12 month periods during each of which they have at least 500 hours of service) will become eligible to enroll in their employer's retirement plan after two years.
- Catch-up contributions will be made on a Roth basis, unless the participant earns \$145,000 or less, generally beginning January 1, 2026.

Plan management has not yet determined which of the optional provisions, if any, the Plan will implement. Plan management expects to formally amend the Plan by December 31, 2026.
