**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Glassdoor, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**A. General**

The Plan was established on December 21, 2007 by Glassdoor, Inc. (the “Company”) to provide retirement benefits for eligible employees. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**B. Administration and Expenses**

Fidelity Management Trust Company (“Fidelity”) serves as trustee and provides record keeping and administrative services. Plan expenses may be paid by the Plan or the Company as provided in the Plan document. Certain investment related expenses are charged directly by the funds and are thereby factored into each fund as a reduction in investment return. The Company paid substantially all other costs of administering the Plan in 2024.

**C. Eligibility**

Essentially all employees of the Company who have attained age 21 are eligible to participate in the Plan except the following excluded employees; those covered by a collective bargaining agreement, leased employees, non-resident aliens, part-time employees, and interns. Eligible employees may enter the Plan the first day of the month following eligibility.

**D. Participant Contributions**

Eligible participants may elect to make pre-tax, after-tax Roth, and/or after-tax contributions to the Plan up to the maximum amount permitted under Code provisions. Newly hired eligible employees who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are auto-enrolled at a pre-tax deferral rate of 2% of compensation. Participants of age 50 or older may elect to make additional catch-up contributions as allowed under Code regulations. Participants who make pre-tax contributions to the Plan receive an equivalent reduction in taxable compensation. Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans.

**E. Employer Contributions**

The Company matches 50% of participants deferred contributions up to an annual maximum of \$5,000 per participant for the Plan year ended December 31, 2024.

**F. Vesting**

Participants are immediately 100% vested in their entire accounts.

**G. Participant Accounts**

Each participant's account is credited with the participant's contributions, employer contributions, rollovers and an allocation of Plan earnings or losses and expenses. Participants direct their investments among a menu of mutual funds offered under the Plan. The contributions of participants who decline to make an affirmative investment election are invested in the Fidelity Freedom Index Fund that is appropriate for a participant's age and projected retirement date.

**H. Payment of Benefits**

Normal retirement age under the Plan is age 65. Upon termination of service, death, disability, retirement or reaching age 59½, a participant may maintain his or her account in the Plan or receive benefits in a lump sum. Hardship distributions are available under limited circumstances, as defined in the Plan, subject to approval of the plan administrator.

**I. Notes Receivable from Participants**

The Plan permits participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their account balance. A loan is secured by a participant's account, bears a fixed rate of interest based on available market financing rates at loan inception and must be repaid to the Plan within a five-year period unless the loan is used for the purchase of a principal residence in which case the maximum repayment period may be extended. The plan administrator approves the specific terms and conditions of each loan. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50% with various maturities through March 2031. Notes receivable are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**C. Investment Valuation and Income Recognition**

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes gains and losses on investments bought and sold as well as held during the year. Mutual fund capital gains distributions are included in dividend income.

**D. Risks and Uncertainties**

Plan investments are exposed to various investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

**NOTE 3 - TAX STATUS**

The Company adopted a volume submitter plan that has received a favorable opinion letter from the Internal Revenue Service stating that the form of the Plan meets requirements for tax-exempt status. The Company believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Certain investment funds maintained under the Plan are managed by affiliates of Fidelity Management Trust Company, the trustee. Purchases and sales of these funds and payment of direct and indirect investment management and administrative expenses by the Plan are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition against party-in-interest transactions under ERISA.

**NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Glassdoor, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**A. General**

The Plan was established on December 21, 2007 by Glassdoor, Inc. (the “Company”) to provide retirement benefits for eligible employees. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**B. Administration and Expenses**

Fidelity Management Trust Company (“Fidelity”) serves as trustee and provides record keeping and administrative services. Plan expenses may be paid by the Plan or the Company as provided in the Plan document. Certain investment related expenses are charged directly by the funds and are thereby factored into each fund as a reduction in investment return. The Company paid substantially all other costs of administering the Plan in 2024.

**C. Eligibility**

Essentially all employees of the Company who have attained age 21 are eligible to participate in the Plan except the following excluded employees; those covered by a collective bargaining agreement, leased employees, non-resident aliens, part-time employees, and interns. Eligible employees may enter the Plan the first day of the month following eligibility.

**D. Participant Contributions**

Eligible participants may elect to make pre-tax, after-tax Roth, and/or after-tax contributions to the Plan up to the maximum amount permitted under Code provisions. Newly hired eligible employees who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are auto-enrolled at a pre-tax deferral rate of 2% of compensation. Participants of age 50 or older may elect to make additional catch-up contributions as allowed under Code regulations. Participants who make pre-tax contributions to the Plan receive an equivalent reduction in taxable compensation. Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans.

**E. Employer Contributions**

The Company matches 50% of participants deferred contributions up to an annual maximum of \$5,000 per participant for the Plan year ended December 31, 2024.

**F. Vesting**

Participants are immediately 100% vested in their entire accounts.

**G. Participant Accounts**

Each participant's account is credited with the participant's contributions, employer contributions, rollovers and an allocation of Plan earnings or losses and expenses. Participants direct their investments among a menu of mutual funds offered under the Plan. The contributions of participants who decline to make an affirmative investment election are invested in the Fidelity Freedom Index Fund that is appropriate for a participant's age and projected retirement date.

**H. Payment of Benefits**

Normal retirement age under the Plan is age 65. Upon termination of service, death, disability, retirement or reaching age 59½, a participant may maintain his or her account in the Plan or receive benefits in a lump sum. Hardship distributions are available under limited circumstances, as defined in the Plan, subject to approval of the plan administrator.

**I. Notes Receivable from Participants**

The Plan permits participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their account balance. A loan is secured by a participant's account, bears a fixed rate of interest based on available market financing rates at loan inception and must be repaid to the Plan within a five-year period unless the loan is used for the purchase of a principal residence in which case the maximum repayment period may be extended. The plan administrator approves the specific terms and conditions of each loan. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50% with various maturities through March 2031. Notes receivable are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**C. Investment Valuation and Income Recognition**

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes gains and losses on investments bought and sold as well as held during the year. Mutual fund capital gains distributions are included in dividend income.

**D. Risks and Uncertainties**

Plan investments are exposed to various investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

**NOTE 3 - TAX STATUS**

The Company adopted a volume submitter plan that has received a favorable opinion letter from the Internal Revenue Service stating that the form of the Plan meets requirements for tax-exempt status. The Company believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Certain investment funds maintained under the Plan are managed by affiliates of Fidelity Management Trust Company, the trustee. Purchases and sales of these funds and payment of direct and indirect investment management and administrative expenses by the Plan are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition against party-in-interest transactions under ERISA.

**NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information relating to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee.

**NOTE 7 - FAIR VALUE MEASUREMENTS**

Accounting guidance establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Plan investments at December 31, 2024 and 2023 consist of mutual funds which are valued at closing market prices. The following table summarizes the Plan's investments at December 31 based on the inputs used to value them:
