**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We have performed an audit of the financial statements of Church World Service Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

**Opinion**

**Basis for opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. **NOTE A - DESCRIPTION OF PLAN**

The following description of the Church World Service Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement and Summary Plan Description for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan maintained under Section 403(b) of the Internal Revenue Code (“IRC”) and covers substantially all eligible employees of Church World Service, Inc. (“CWS” or “Employer”) who have completed minimum service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Effective January 1, 2020, CWS merged the Defined Contribution Retirement Plan and the Tax Deferred Annuity Plan into one restated defined contribution plan and transferred assets as of the merger date. The restated plan maintains the primary provisions of each plan as described in Note A of these financial statements.

CWS serves as the Plan Sponsor and Plan Administrator.

**Contributions**

Participants may elect to make contributions through pre-tax payroll and Roth withholdings, as defined in the Plan Agreement, within Internal Revenue Service (“IRS”) limits (maximum of \$23,000 for 2024). There are additional catch-up contributions that are available to participants that meet certain requirements. Individuals age 50 or over, are eligible for an additional catch-up contribution up to \$7,500 for 2024. If a participant has worked at least 15 years for the employer, and the employer is a qualified organization, the participant may make special 403(b) catch-up contributions up to certain limits.

The employer contributions, and limit on the amount of such contributions made to the Plan are determined by CWS. Contribution rates as a percentage of salary are as follows:

Employees with less than 5 years of service	5%
Employees with 5 years to less than 15 years of service	7%
Employees with 15 or more years of service	9%

Each participant may not have more than \$69,000 contributions in 2024 or an amount equal to 100% of his or her compensation, whichever is less. This limit may be adjusted for cost of living adjustments.

The Employer has the option to make employer contributions to the plan but may choose not to make those contributions in certain years. A participant is generally eligible to receive employer contributions after one year of service. Employer contributions are generally contributed to the Plan each payroll period.

***Denominational Pension Plans***

CWS allows employees, who were already members of certain other denominational pension plans upon employment, to elect that the employer contributions be invested in their respective denominational pension accounts rather than invested in the Plan. There are two denominational pension plans to which CWS contributes as of December 31, 2024.

The participant accounts at the denominational pension plans are not considered to be a part of the Plan; rather the accounts are considered to be a part of the respective denominational pension plans. Accordingly, such denominational pension account balances are excluded from the Plan's net assets available for benefits.

The contributions to the denominational pension plans totaled \$37,583 in 2024. This amount is included in both employer contributions and transfers out in the statement of changes in net assets available for benefits.

***Participant Accounts***

Each participant's account is credited with the employer's contributions and an allocation of Plan earnings and administrative fees. The allocations are based on the participant's account balances as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants elect to invest their account balances among investment options available under the Plan. The investment custodians and related investment options may change at the discretion of CWS. As of December 31, 2024 and 2023, the investment custodians are as follows:

- Teachers Insurance and Annuity Association of America (TIAA and CREF)
- Empower Retirement, LLC (Empower)
- Metropolitan Life Insurance Company (MetLife)
- AXA Equitable Life Insurance Company (AXA Equitable)

As of December 31, 2010, New York Life was terminated as an investment option. Participants were permitted to keep their existing balances with New York Life; however, no future contributions could be made to these accounts. The main custodian and recordkeeper is TIAA and CREF.

***Vesting and Forfeitures***

The Plan was amended in October 2015 to provide for a six-year vesting schedule for all new hires employed after January 1, 2016.

Forfeitures are used to reduce future employer contributions or pay Plan expenses. Forfeited nonvested accounts totaled \$15,269 and \$12,246 at December 31, 2024 and 2023, respectively. During 2024, \$36,976 was used to reduce employer contributions and no forfeitures were used to pay administrative expenses.

***Payment of Benefits***

On retirement, death, disability, or termination of service, participants receive payment of their individual vested account balances based on options as defined in the Plan Agreement. In-service withdrawals are also permitted for certain financial hardships or when the participant attains age 59½. The Plan also provides for minimum required distributions in accordance with IRS requirements.

***Notes with Participants***

Participants may borrow funds in accordance with their contracts with the investment vendors. Generally, a participant may borrow a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested account balance or \$50,000. The loans are secured by the balance in the participants' accounts and bear interest at a rate commensurate with local prevailing rates as determined by the investment vendors. The participant pays principal and interest ratably directly to the respective investment vendor or through payroll deduction depending on the type of loan. Defaults on loans will reduce a participant's account by the amount in default (plus accrued interest). The participant pays principal and interest ratably, directly to TIAA and CREF. Participants are permitted to maintain up to two outstanding loans from the plan at any given time.

Prior to January 1, 2020, loans were issued directly with the custodian and not from Plan assets (i.e. collateralized loans). Collateralized loans balances at December 31, 2024 and 2023 was \$231 and \$6,803, respectively, and are not presented on the Plan's financial statements. Effective January 1, 2020, the plan sponsor began issuing Retirement Plan Loans ("RPLs"), which are loans issued directly from the participant's account and are presented as Notes receivables from participants in the Statement of Net Assets Available for Benefits.

***Administrative Expenses***

Certain administrative expenses of the Plan are paid directly by CWS at its discretion. Any general recordkeeping expenses or other investment or transaction fees may be allocated among Plan participants or, for expenses that may be directly related to the participant, charged against the participant's account balance.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments, other than those fully benefit-responsive investment contracts, are reported at fair value. Fair value of plan investments, is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note H for a discussion of fair value measurements. Fully benefit-responsive investment contracts are reported at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less funds used to purchase annuities and pay administration expenses charged. See Note D for a discussion of fully benefit responsive investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Risks and Uncertainties***

The Plan's investments include various types of investment fund options, which in turn invest in any combination of stocks, bonds and other investments exposed to various risks, such as interest rate, credit and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the Plan's financial statements.

**NOTE C - INFORMATION CERTIFIED BY THE CUSTODIANS**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA and CREF, Empower, MetLife and AXA Equitable, the custodians, have certified that the following data included in the financial statements and supplemental schedule are complete and accurate:

- Investments, at fair value, at contract value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, Part IV, line 4i, schedule of assets (held at end of year) as of December 31, 2024.

**NOTE D - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS, AT CONTRACT VALUE**

The Plan holds a portfolio of investment contracts that comprises TIAA traditional investment contracts totaling \$1,827,931 and \$1,915,456 at December 31, 2024 and 2023, respectively. The Plan invests in the Traditional Annuity, which is a fixed-rate contract that is fully and unconditionally guaranteed by TIAA. The Plan's Traditional Annuity investments are through the SRA and the GSRA and are fully benefit-responsive. The type of contract through which a participant invests in the Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement.

Investments in the Traditional Annuity earn a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Together, the guaranteed minimum and additional amounts make up the crediting interest rate. The crediting interest rate is calculated on a daily basis. For accumulating SRA and GSRA contracts, the interest crediting rate was 4.50% and 5.75% as of December 31, 2024 and 2023, respectively.

When a participant's accumulation in the Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution on the statement of changes in net assets available for benefits. The SRA and GSRA contracts provide for full participant-directed liquidity. No events are probable of occurring that might

limit the ability of the Plan to transact at contract value with the contract issuer, and also that limit the ability of the Plan to transact at contract value with participants.

**NOTE E - PLAN TERMINATION**

Although it has not expressed any intent to do so, CWS has the right under the Plan to discontinue its contributions and to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire accounts.

**NOTE F - INCOME TAX STATUS**

The Plan has adopted a volume submitter plan document sponsored by TIAA and CREF. The volume submitter plan provider has received an advisory letter dated August 7, 2017 from the IRS as to the volume submitter plan's qualified status. The Plan has been amended since the volume submitter plan received the advisory letter. The Plan Administrator believes the Plan is designed and is being operated with the applicable provisions of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investments are managed by TIAA and CREF, Empower, MetLife, AXA Equitable, Empower and New York Life, at December 31, 2024 and 2023. Notes receivable from participants held by the Plan are also related party transactions under ERISA. Party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE H - FAIR VALUE OF FINANCIAL INSTRUMENTS**

The Financial Accounting Standards Board has issued guidance that provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

#### ***Traditional Annuity Contract***

Valued using the contract value, which approximates fair value. The Plan's fixed-rate annuities are primarily within the TIAA Traditional Annuity, with an investment through the Retirement Annuity ("RA and GRA"), a fixed rate contract that is non-fully benefit responsive. Observable prices for identical or similar investments do not exist, and it is classified as Level 3 of the valuation hierarchy. Investments in the TIAA Traditional Annuity earn a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The crediting interest rate is calculated on a daily basis. For accumulating RA contracts, the crediting interest rates was 5.50% and 6.50% as of December 31, 2024 and 2023, respectively. The GRA contract does not allow lump-sum cash withdrawals and transfers must be distributed over 10 annual installments.

The contract value is deemed to approximate fair value based on the following valuation techniques:

- Theoretical transfer (exit value) - Observation of recent participant transactions (purchases, sales, and settlements) at contract value; and
- Discounted cash flow - Comparison of historical and current yields of highly rated corporate bonds to historical and current crediting interest rates of the contracts, taking into consideration the liquidity restrictions applicable to the contracts.

#### ***Pooled Separate Account (Real Estate Fund)***

Valued based on each account's daily net asset value (NAV), which plan management considers to be the best approximation of fair value. Data for NAVs are available daily to plan administrators and client investors on NASDAQ's website and provide sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings. Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources. The real estate fund is valued at Level 1 due to its tie to the exchanges.

#### ***Registered Investment Companies***

Valued based on each account's daily NAV, which plan management considers to be the best approximation of fair value. CREF accounts are not exchange traded. Data for NAVs is available daily to plan administrators and client investors on NASDAQ's website and provide sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings. Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources. CREF accounts are valued at Level 1 due to their tie to the exchanges.

***Mutual Funds***

Valued at the quoted NAV of shares held by the Plan at year end as quoted on national securities exchanges.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, using different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The discounted cash flow valuation technique utilizes an appropriate risk-adjusted market discount rate that correlates closely with TIAA Traditional Annuity's historical crediting rates for each contract type. Crediting rates are a combination of a guaranteed rate and an annually established discretionary rate. Additionally, the discretionary rate applied to contributions received during a reporting period may vary from the discretionary rate applied to account balances at the end of the prior reporting period.

In determining the reasonableness of the methodology, management evaluates a variety of factors, including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (e.g., crediting rates) as compared to available market data (e.g., treasury yields) to substantiate the embedded risk premium.

**NOTE I - DELINQUENT CONTRIBUTIONS**

The DOL considers late deposits to be nonexempt or prohibited transactions. The Plan Sponsor plans to remit lost earnings associated with late remittances.

Management has evaluated subsequent events through October 15, 2025, the date the financial statements were available for issuance, and has determined that there are no subsequent events requiring disclosure.
