Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by Plan management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Societal CDMO 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the Societal CDMO 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan originally effective January 1, 2014 sponsored by Societal CDMO, Inc. (the “Company”, “Plan Sponsor”, or “Employer”). The Plan is a defined contribution Plan covering substantially all employees of the Company, as described in the Plan document, who have attained age 18. Employees who are part of a collective bargaining agreement, nonresident aliens, leased employees, and temporary employees are ineligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Retirement Plan Committee is responsible for oversight of the Plan, including the appropriateness of the Plan’s investment offerings and monitoring of the investment performance. Vanguard Fiduciary Trust Company (“Vanguard”) is the trustee of the Plan.

Effective January 1, 2025, the Societal CDMO 401(k) Plan was merged with and into the Bend Bioscience 401(k) Plan (formerly known as the CoreRx, Inc. 401(k) Plan). The plan merger initiated a “Black Out” period beginning December 26, 2024 and continued through February 9, 2025. During this period, participants’ plan accounts were not available for investment fund exchanges, and distribution requests, including participant loan withdrawals. During the Black Out period, funds were transferred from Vanguard Fiduciary Trust Company, the trustee of the Plan, to Fidelity Management Trust Company, the trustee of the Bend Bioscience 401(k) Plan. As a result of the plan merger, \$38,609,900 of plan assets, including \$37,957,974 of investments at fair value, \$632,186 of participant loans and \$19,740 of employer contributions receivable, were transferred from the Plan to the Bend Bioscience 401(k) Plan during the year ended December 31, 2024. Plan management believes that there was no participant-initiated activity after December 31, 2024. As a result, for financial reporting and Form 5500 purposes, all assets, liabilities and participants ceased to be part of the Plan as of December 31, 2024 and such amounts are reported as zero as of December 31, 2024 in the Plan’s 2024 Form 5500.

Contributions

Each year, participants may contribute a percentage of their pre-tax annual compensation, or a flat dollar amount, as defined in the Plan. Contributions may be designated as Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled into the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of pre-tax eligible compensation and their contributions invested in a designated target date fund until changed by the participant. The Plan also includes an auto escalation feature for deferral percentages for each active participant having automatic enrollment contributions made on his or her behalf to be increased annually at the beginning of each year by 1%, limited to 10% of eligible compensation.

The Company may elect to make an Employer matching contribution to the Plan based on a discretionary percentage of base compensation that a participant contributes to the Plan. For the period from January 1, 2024 to May 5, 2024, the Employer matching contribution was 100% of the first 2% of eligible compensation. For the period from May 6, 2024 to December 31, 2024, the Employer matching contribution was updated to be 100% of the first 3% of compensation.

Contributions are subject to certain Internal Revenue Code (“IRC”) limits. Participants direct the investment of their deferral contributions and Employer matching contributions into various investment options offered by the Plan. Participants may change their investment options at any time.

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions and Employer matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their contributions into various mutual fund investment options offered by the Plan and maintained by the trustee of the Plan. Investment performance is dependent on the investment experience, which is variable and not guaranteed. The Plan's exposure to credit loss in the event of nonperformance of investments managed by the trustee is limited to the carrying value of such investments.

Forfeited Amounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$19,118, respectively. Forfeitures may be applied to payment of administrative expenses and/or to reduce Employer matching contributions. During the year ended December 31, 2024, no forfeitures were used to reduce Employer contributions and forfeitures of \$43,329 were used to pay administrative expenses of the Plan.

Vesting

Participants are vested immediately in their contributions, including their elective pre-tax deferral contributions, Roth 401(k) deferrals, and rollover contributions, plus actual earnings thereon.

Vesting in the Employer matching contribution portion of their accounts is based on credited service. A participant is 100 percent vested after 1 year of credited service.

A participant is also 100 percent vested upon death, disability, or early or normal retirement.

Payment of Benefits

Upon termination of service, death, disability, retirement or separation from service, participants or their beneficiaries will receive, in a lump-sum payment, an amount equal to the value of the participant's vested interest in his or her account. If a participant's vested account balance is less than \$5,000 upon termination, the Plan administrator may authorize the benefit payment without the participant's consent. In circumstances when a terminated participant has a vested account balance less than \$1,000, the participant's vested account balance shall be distributed in a lump sum. In circumstances when a terminated participant has a vested account balance greater than \$1,000 but less than \$5,000, if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan administrator.

In-service withdrawals of all or a portion of a participant's vested account balance may be made by participants who have attained the age of 59-1/2. Participants are also permitted to make hardship withdrawals from their deferral contribution accounts in certain cases of immediate and heavy financial need. In-service withdrawals of all or a portion of a participant's rollover account balance may be withdrawn at any time.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may not have more than two loans outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at the local prevailing interest rate at the time of borrowing, as determined by the trustee. Principal and interest are repaid ratably through payroll deductions over a period of five years or less, with the exception of loans made for the purchase of

a primary residence, where the repayment period may be up to and including thirty years. Interest rates on notes receivable from participants ranged from 4.25% to 9.50% as of December 31, 2024 with maturities dates through 2047.

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). The Retirement Plan Committee determines the Plan's investment policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Contributions from plan participants and the Employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit distribution is recorded, based upon the terms of the Plan document.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable and other participant-specific fees are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in the net appreciation in fair value of investments.

3. Information Certified by a Qualified Institution

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Vanguard

Fiduciary Trust Company, a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the merger of the Plan with and into the Bend Bioscience 401(k) Plan (see Note 1), there were no fair value measurements as of December 31, 2024.

5. Related Party and Party-In-Interest Transactions

Plan investments are shares of mutual funds managed by Vanguard. Vanguard is the trustee and record-keeper as defined by the Plan. The Plan also permits notes receivable from participants. The Plan Sponsor pays directly certain fees related to the Plan’s operations. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. Administrative fees paid by the Plan to the trustee and recordkeeper were \$67,007 during 2024.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts including any Employer contributions for which they were not already vested, and all remaining assets in the Plan are to be distributed to the participants in accordance with the accrued benefits of such participants as of the date of termination.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants’ account balances and the amounts reported in the statements of net assets available for benefits.

8. Tax Status

Effective January 1, 2022, the Plan Sponsor authorized a plan document amendment and restatement through the adoption of a Vanguard non-standardized profit-sharing plan. On June 30, 2020, the Internal Revenue Service (“IRS”) stated in an opinion letter that the non-standardized profit-sharing plan document adopted by the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
