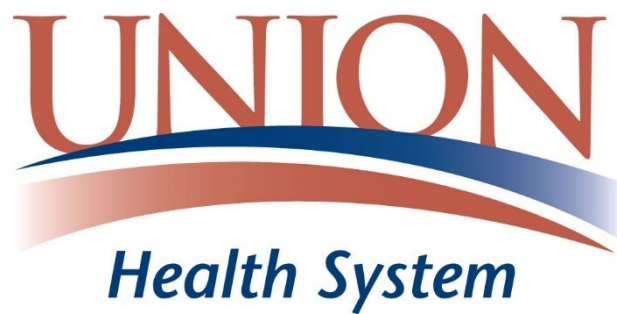

Responsibilities of Management for the Financial Statements

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. DESCRIPTION OF PLAN

The following brief description of the Union Health 403(b) Retirement Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan.

General

The Plan is a defined contribution plan, covering employees of Union Health, Inc. (Company). Effective January 1, 2020, employees of Union Associated Physicians Clinic, Inc. also became eligible to participate in the Plan. The Plan is administered by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Participants may contribute from one percent to 100 percent (in increments of one percent) of their annual compensation, as defined by the Plan, not to exceed certain dollar limitations that are set by law. This limitation is indexed annually by the Internal Revenue Service. The Plan permits pre-tax deferrals and Roth deferrals. The Plan includes an automatic enrollment provision. When an employee of the Company becomes eligible to join the Plan, he/she is automatically enrolled, and four percent of his/her compensation is automatically contributed to the Plan. For each plan year subsequent to automatic deferral, the automatic deferral percentage will increase by 1 percentage point up to maximum as defined in the plan document until. Participant's may enter a salary reduction agreement at any time to select an alternative contribution (deferral) percentage or to elect not to contribute (defer) to the Plan.

Participants age 50 or older may elect to contribute additional amounts to the Plan up to a maximum that is set by law. This limitation is indexed annually by the Internal Revenue Service. Participants may also make qualified rollover contributions of amounts representing distributions from other qualified plans and certain Individual Retirement Accounts (IRAs).

The Company made an annual nonelective contribution of 1 percent of qualified compensation to all eligible employees for 2024. Participants must be employed on December 31 of each year to be eligible for the Company nonelective contribution.

The Company also contributes 50 percent of the first 8 percent (Company matching contribution) of the eligible compensation that a participant contributes to the Plan. Participants must have attained age 21, completed one year of service, 1,000 hours, and be an eligible class of employee, as defined by the Plan, to participate in the Plan and in the Company's nonelective and matching contribution

Additionally, the Plan allows participants to increase, decrease, or stop their contributions and to direct the investment of their account balances and contributions at any time. Participants are currently permitted to divide their contributions among the various investment options in one percent increments. Company contributions are allocated to the various investment options using the percentages selected by the participants.

Participant contributions and Company matching contributions are recognized through salary withholding. The Company's nonelective contribution, as described above, is recognized in the year of service.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contributions and the Company base and matching contributions and is credited or charged with an allocation of investment earnings or losses, and plan expenses. Allocations are based on participant earnings, account balances, and Company matching contributions, as defined.

Notes Receivable from Participants

Eligible participants may borrow amounts from the Plan that shall be for a minimum of \$1,000 and up to a maximum of the lesser of (a) one-half of the vested value of the participant's account or (b) \$50,000 reduced by the highest outstanding loan balance during the twelve months prior to the effective date of the loan. Loans are only available for financial hardship. The term of a general loan is up to 5 years and up to 20 years for the purchase of a primary residence. A loan is secured by the balance in the participant's account or other collateral approved by the plan administrator and bears interest at 1 percent over the prime rate as published in the Wall Street Journal as of the date of the disbursement of the loan proceeds. Principal and interest is paid ratably through payroll deductions. Prepayment of the entire remaining loan balance is permitted. The maximum number of loans that a participant may have at any one time is one. Should the participant terminate as an employee of the Company, the balance of the outstanding loan (including any accrued interest) becomes due.

The loans are issued by Fidelity Management Trust Company and bear interest at a fixed rate ranging from 4.25% to 9.50%. Principal and interest are generally paid ratably through payroll deductions or as a lump sum. The individual loan balances range from approximately \$10 to \$49,000 as of December 31, 2024. The loans are generally due through 2034.

Vesting and Forfeited Accounts

Participants are immediately vested in their contributions, including rollover contributions, plus actual earnings or losses thereon. Vesting in the Company base and matching contribution portion of their account plus actual earnings or losses thereon is based on years of service. A participant is 100 percent vested after 3 years of credited service, as defined by the Plan.

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$96,000 and \$100,000, respectively. The non-vested portion of former participants' accounts may be used to pay administrative expenses of the Plan or to reduce the amount of future employer contributions. In 2024, employer contributions were reduced by approximately \$128,000 from forfeited non-vested accounts.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination, a participant with a vested account balance may elect to receive a lump-sum distribution in cash; monthly, quarterly, or annual installments over a period of not more than their assumed life expectancy (or their and their beneficiary's assumed life expectancies); or partial distributions subject to the provisions of the Plan. Certain investment products may provide a participant with additional distribution options. If a participant terminates employment for any reason and at any age (including retirement) and the value of their vested benefit does not exceed \$1,000, then distribution will automatically be paid to them in a lump-sum distribution. If a participant's vested interest in the Plan exceeds \$1,000 and does not exceed \$5,000 and he or she does not elect either to receive or to roll over the distribution, then under certain circumstances their distribution will be rolled over to an IRA.

The Plan also provides for certain hardship withdrawals and participant loans as previously described. Distributions of benefits are recorded as withdrawals from the Plan and a reduction of assets available for plan benefits in the period paid to the participant.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer contributions.

Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is October 13, 2025.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investments

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See the Fair Value Measurements note for further information.

Contract value is the relevant measure for that portion of the assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are accounted for on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income.

The Plan includes in the statement of changes in assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains (losses) and the unrealized appreciation (depreciation) on those investments.

Concentration of Credit Risk

Financial instruments that potentially subject the Plan to concentrations of credit risk are part of the holdings in Plan's investments. Management believes that the custodian maintains the Plan's investments with high quality institutions and attempts to limit the credit exposure to any particular investment.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related loan origination and annual administration fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Administrative and Other Expenses

The expenses of administering the Plan, including trustee, custodian, and recordkeeper fees, legal fees, and other necessary expenses incurred in carrying out the Plan are paid by the Company to the extent that they are not paid from the participants' accounts. Loan set-up and distribution fees are paid by the participant utilizing such service. Administrative expenses are recognized when incurred.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities may occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

3. INVESTMENTS AND INFORMATION CERTIFIED BY THE TRUSTEES/CUSTODIANS

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, American United Life Insurance Company, Empower Trust Company, LLC, Empower Annuity Insurance Company of America on behalf of Mass Mutual Life Insurance Company and Talcott Resolution Life Insurance Company, and The Lincoln National Life Insurance Company, the trustees and custodians of the Plan, have certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule of assets at December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund: Valued at quoted market prices in an exchange and active markets, which represents the net asset value (NAV) of shares held by the Plan at year-end.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: The fair value of units held in pooled separate accounts are valued at NAV as reported by American United Life Insurance Company, Empower Trust Company, LLC, Empower Annuity Insurance Company of America on behalf of Mass Mutual and Talcott Resolution Life Insurance Company, and The Lincoln National Life Insurance Company. The NAV is based on the value of the underlying investments minus its liabilities and divided by the number of units outstanding. The NAV is quoted on a private market that is not active; however, the unit price of the underlying investments are quoted on an active market. The pooled separate accounts have no unfunded commitments as of December 31, 2024.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan holds investment contracts that are traditional investment contracts. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for the fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contracts held by the Plan are guaranteed investment contracts. The contract issuers are contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rates are based on a formula established by the contract issuer but may not be less than an established percentage. The crediting rates are reviewed on a quarterly basis for resetting. The contracts cannot be terminated before the scheduled maturity date. The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contract
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

The average yield for the Lincoln National Group Fixed Account fully benefit-responsive investment contract based on actual earnings and on interest rate credited to participants was 3.52% for 2024. The average yield for the American United Life Insurance Company Fixed Account fully benefit-responsive investment contract based on actual earnings and on interest rate credited to participants was 3.75% for 2024. The average yield for the Hartford Life Insurance Company Fixed Account fully benefit-responsive investment contract based on actual earnings and on interest rate credited to participants was 3.93% for 2024.

6. TAX STATUS

The Plan has adopted a volume submitter plan document sponsored by Fidelity Workplace Services LLC, which has received an opinion letter from the Internal Revenue Service dated August 7, 2017, stating that the form of the volume submitter plan document, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the volume submitter plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

The Plan invests in mutual funds, pooled separate accounts, and investment contracts managed by Fidelity Management Trust Company, American United Life Insurance Company; Empower Trust Company, LLC, Empower Annuity Insurance Company of America on behalf of Mass Mutual Life Insurance Company and Talcott Resolution Life Insurance Company; and The Lincoln National Life Insurance Company, trustees and custodians of the Plan, and their affiliates. Transactions in such investments are considered party-in-interest investments which are exempt from prohibited transactions rules. Fidelity Management Trust Company, Empower Annuity Insurance Company of America, and American United Life Insurance Company as the recordkeepers are also considered to be a party-in-interest in that capacity. Lincoln National Corporation also serves as contract administrator and is considered a party-in-interest. Axia Advisory Corporation serves as investment advisor and is considered a party-in-interest in that capacity. In addition, notes receivable from participants are considered parties-in-interest.

The Plan Sponsor provides certain administrative services at no cost to the Plan, including administrative, accounting and auditing fees. These expenses qualify as party-in-interest transactions.
