## INDEPENDENT AUDITORS' REPORT

### Opinion

We have audited the accompanying financial statements of the CAWA Arizona Health Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net deficit available for benefits and of plan benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net deficit available for benefits and of changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net deficit available for benefits and plan benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net deficit available for benefits and changes in its plan benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. ### Responsibilities of Management for the Financial Statements

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we—

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Notes to Financial Statements

### Note 1 – Description of the Plan

The CAWA Arizona Health Trust (the Plan), was established on April 18, 2019, and began operations effective October 1, 2019. The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

- a. **General** – The Plan provides health and other benefits for eligible employees and their dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.
- b. **Eligibility** – To be eligible for benefits, participants must be employed by a participating employer and must meet eligibility requirements set by their employer as stated in the employer's Master Application, and the applicable premium must be received on their behalf.

Conditions set forth in the employer's Master Application may include, but are not limited to, one or a combination of the following:

- Limitation to employees scheduled to work at least a specified number of hours per week (at least 20 hours);
- Limitation to a particular class or classes of employee;
- Completion of a permissible probationary period (not to exceed 90 days); or
- Limitation to completion of a look-back period for variable hour employees.

Eligibility for coverage under the Plan will terminate at the earliest of any one of the following: (1) at the end of the calendar month in which the employee no longer satisfies the eligibility criteria set forth in the employer's Master Application; (2) the applicable employer or employee premium is not received; (3) the date the employer ceases to be eligible to participate in the Plan; or (4) on the date the Plan itself terminates.

Continuation of health care benefits to employees who would otherwise lose those benefits due to certain events, as mandated by the Consolidated Omnibus Budget Reconciliation Act (COBRA), normally applies to all employers employing 20 or more employees during a calendar year. Due to plan provisions, all participants in the Plan are COBRA eligible. The Plan provides these benefits on a self-pay basis if a participant loses coverage because they no longer satisfy the requirements for eligibility. The contribution amount is set by the Plan.

- c. **Contributions** – The plan agreement provides that participating employers make monthly contributions to the Plan of a specified amount for each employee to provide benefits. Contributions from employers are accrued based upon reported eligibility months of covered employees. Contributions from participants are based on coverage selected.

## Notes to Financial Statements

### Note 1 – Description of the Plan (Continued)

- d. **Benefits** – The Plan provides medical, dental, vision, prescription drug, life, and accidental death and dismemberment benefits for eligible employees and their dependents. The Plan fully insures these benefits. Premiums are paid by the Plan.
- e. **Administration** – The Plan is administered by a Board of Trustees that is assisted by a contract administration organization and various professional service providers. Administrative expenses are borne by the Plan.

### Note 2 – Summary of Significant Accounting Policies

- a. **Basis of accounting** – The accompanying financial statements are prepared on the accrual basis of accounting.
- b. **Contributions receivable** – Employer contributions due but not paid at year end are recorded as contributions receivable. Delinquent contributions are recorded when collected. For the year ended December 31, 2023, amounts recorded are considered fully collectible, and, accordingly, no allowance for doubtful accounts is presented.
- c. **Deferred revenue** – Employer contributions received in advance of the coverage period are recorded as deferred revenue. Revenue is recognized when the period of coverage begins.
- d. **Benefits** – The Plan fully insures all benefits under contracts with insurance companies. These benefits are covered by nonexperience rated contracts with BlueCross BlueShield of Arizona and Equitable Financial Life Insurance Company of America and an experience rated contract with VSP Vision Care, Inc., to which the Plan pays monthly premiums. Premiums are recorded when paid.
- e. **Benefit obligations** – Premiums payable are estimated based on participant eligibility earned as a result of contributions for participants through December 31 and paid by the Plan subsequent to year end. The Plan has no obligation to provide benefits to retirees; therefore, postretirement benefit obligations are not recorded on the financial statements.
- f. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting year. Actual results could differ from those estimates.
- g. **Subsequent events** – The plan administrator has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.

### Note 3 – Tax Status

The trust established under the Plan to hold the Plan's assets obtained an exemption letter dated July 10, 2023, in which the Internal Revenue Service (IRS) stated the trust is qualified under Section 501(c)(9) of the Internal Revenue Code (IRC), and, accordingly, the trust's net income is exempt from income taxes. The Board of Trustees believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. They believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date; therefore, no provisions for income tax have been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status; however, there are currently no audits for any tax years in progress.

### Note 4 – Priorities Upon Termination

In the event the obligations of the employers to make contributions to the Plan terminate, the Trustees shall determine the disposition of any assets in the trust after all expenses of the Plan have been paid; provided that any such distribution will only be made for the benefit of former participants and for the purposes set forth in the Plan. If the assets are insufficient to pay all accrued benefits and liabilities, distribution of the assets shall be made in accordance with plan termination provisions and the requirements of ERISA and applicable government regulations.

### Note 5 – Funding Policy

The Plan is funded by employer contributions, participant contributions, and from participants electing COBRA coverage. The monthly contribution rate, including the rate for COBRA coverage, is determined by the coverage type selected by the employer in their Employer Participation Agreement.

The employer contribution rate is required to be at least 50% of the monthly contribution rate but can be up to 100% of the monthly contribution rate. Employee contributions include contributions which are being deducted from participant wages when the employer contribution rate is less than 100% of the monthly contribution rate and COBRA contributions. Employee contributions withheld from participant wages are included with employer contributions and are not segregated in the statements of changes in net deficit available for benefits.

### Note 6 – Party-in-interest and Related-party Transactions

Certain transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

The related-party payable is due to the plan sponsor for administrative expenses paid for by the plan sponsor on behalf of the Plan during the initial years of the Plan.

### Note 7 – Concentration of Credit Risk

The financial instruments may subject the Plan to a concentration of risk as, from time to time, cash balances exceed amounts insured by the Federal Deposit Insurance Corporation and the market value of securities is dependent on the ability of the issuer to honor its contractual commitments.
