**NOTES TO THE FINANCIAL STATEMENTS**

December 31, 2024 and 2023

**NOTE 1 - DESCRIPTION OF THE PLAN**

General

The Administration Committee, as Plan Administrator, is responsible for the general administration of The Sherwin-Williams Company Hourly 401(k) Plan (the Plan). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is a defined contribution plan. The Plan covers certain eligible collectively bargained employees of The Sherwin-Williams Company (the Company or Plan Sponsor) and participating subsidiaries.

Enrollment

Eligible employees hired by the Company are automatically enrolled in the Plan and, in the absence of participant direction, their contributions are directed to an age-appropriate T. Rowe Price target date retirement fund. Employee contributions are established at 3% of pre-tax earnings. Eligible new hires may change the pre-selected enrollment option or choose not to participate in the Plan prior to being automatically enrolled. If new hires choose not to change the automatic enrollment employee contribution level of 3%, the employee contribution level will increase at the beginning of each subsequent plan year by 1%, until either the employee individually changes the employee contribution level or the employee contribution level reaches the maximum automatic employee contribution level. The maximum automatic employee contribution level is 10%.

Employee Contributions

Participants are permitted to make salary reduction contributions to the Plan in half or whole percentages up to 60% of their eligible compensation (subject to certain limitations). Certain participants receive Company contributions per the terms of their union contracts.

Investments

Investments are participant directed. In the absence of participant direction, employee and Company contributions are directed to an age-appropriate T. Rowe Price target date retirement fund. Costs incidental to the purchase and sale of securities, such as brokerage fees, commissions and stock transfer taxes, are borne by the respective funds. Participants may change or transfer their investment options any business date subject to certain trading restrictions imposed by each fund manager.

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### Vesting

Participants are fully vested in their respective account balances.

### Notes Receivable from Participants

Participants are permitted to request a loan from their accounts in an amount not to exceed the lesser of \$50,000 (subject to certain limitations) or one-half of the participant's account under the Plan. The interest rate equals the prime rate plus 1%. The note receivable from a participant repayment period may not exceed five years unless the note receivable from a participant is used to purchase a participant's principal residence, in which case the repayment period may not exceed ten years. No allowance for current expected credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be uncollectible, the participant loan balance is reclassified to a Plan distribution.

### Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions (as applicable) and (b) Plan earnings (losses) and is charged with withdrawals and an allocation of administrative expenses. Allocations are based on specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

### Withdrawals

Subject to certain Plan limitations, participants are permitted to withdraw all or a portion of their respective account balances.

### Administrative Expenses

All administrative expenses are paid by the Plan Sponsor, except for fees relating to Notes receivable from participants which are charged to individual participant accounts.

### Additional Information

Further information about the Plan, including benefit provisions, is contained in the Plan's Summary Plan Description (SPD). Copies of this SPD are available from the Administration Committee of the Company.

## **NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from these estimates.

### Investment Valuation

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. See Note 3 for further details.

### Income Recognition

Net realized and unrealized appreciation in fair value of investments represents the change in the difference between the aggregate fair value and the cost of the Plan's investments, including investments bought, sold and held during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

### Payment of Benefits

Benefits are recorded when paid.

### Notes Receivable from Participants

Notes receivable from participants are valued at their unpaid principal balance plus accrued interest. Interest income on notes receivable is recorded when paid.

### Subsequent Events

Events occurring subsequent to December 31, 2024 have been evaluated through September 10, 2025, the date of the issuance of the financial statements, in accordance with the Subsequent Events Topic of the Accounting Standards Codification (ASC). During this period, there were no recognized subsequent events requiring recognition in the financial statements, and no non-recognized subsequent events requiring disclosure.

## **NOTE 3 - FAIR VALUE MEASUREMENTS**

The Fair Value Measurements and Disclosures Topic of the ASC applies to the Plan's financial assets. The levels of the fair value hierarchy are as follows:

- Level 1: Quoted prices in active markets for identical assets
- Level 2: Significant other observable inputs
- Level 3: Significant unobservable inputs

The fair value of mutual funds is based on quoted redemption values on national security exchanges on the last business day of the Plan year.

The fair value of the money market fund is based on quoted prices in active markets for identical securities.

The collective trust funds are measured at net asset value (NAV) as a practical expedient. In accordance with the Fair Value Measurement Topic of the ASC, investments that are measured at NAV using the practical expedient are not classified in the fair value hierarchy. The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the Statements of Net Assets Available for Benefits. There are no unfunded commitments, significant redemption limitations or restrictions on the ability to sell these funds.

#### NOTE 4 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the Trustee).

## **NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right, by action of its Administration Committee, to amend, modify, suspend or terminate the Plan. No such action would allow funds held in trust by the Trustee or the income thereon to be used for purposes other than for the exclusive benefit of participants or their beneficiaries. In the event of Plan termination, the net assets of the Plan shall be distributed in accordance with applicable Plan provisions.

## **NOTE 6 – INCOME TAX STATUS**

The Plan has received a determination letter dated October 26, 2020 from the Internal Revenue Service (IRS) stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code), and therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. Subsequent to this determination by the IRS, the Plan was amended. The Plan Administrator believes the Plan as amended is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

U.S GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

## **NOTE 7 - TRANSACTIONS WITH PARTIES-IN-INTEREST**

As of December 31, 2024 and 2023, the Plan had Notes receivable from participants of \$2,400,626 and \$2,125,480, respectively. Certain Plan investments are shares of mutual funds, collective trust funds or a money market fund managed by the Trustee or an affiliate of the Trustee and, therefore, qualify as party-in-interest. Fees paid during the year for services rendered by the Trustee or an affiliate of the Trustee constitute party-in-interest transactions.
