Note 1 - Plan Description

The following description of the Seattle Symphony Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. Effective January 1, 2025, the name of the Plan changed to the Seattle Symphony and Seattle Opera 403(b) Plan.

General - The Plan is a defined contribution plan, as defined by the Internal Revenue Code (IRC), established to provide retirement benefits to employees of Seattle Symphony Orchestra, Seattle Opera, and B.H. Music Center (collectively referred to as the Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The custodians for the plan are Matrix Trust Company (Matrix), Symetra Life Insurance Company (Symetra), and American Century Investments (American Century).

Eligibility - All employees, other than nonresident aliens, leased employees, and employees who normally work less than 20 hours per week, are eligible to make salary deferrals to the Plan on the first pay period following their date of hire. Effective January 1, 2025, the requirement to work 20 hours or more per week to be eligible to make deferrals in the Plan was removed. All employees other than nonresident aliens, leased employees, employees who normally work less than 20 hours per week, collectively bargained employees that doesn't provide for participation in the Plan, and reclassified employees are eligible to receive employer contributions after completion of one year of service with 1,000 hours.

Contributions - Participants may elect to defer up to 100% of their eligible compensation as pretax or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollover).

The Plan provides for employer safe harbor matching contribution for employees of Seattle Symphony Orchestra and B.H. Music Center. The safe harbor matching contribution formula is equal to 100% of each participant's elective deferrals not exceeding 3% of the participant's eligible compensation, plus 50% of each participant's elective deferrals in excess of 3% but not in excess of 5% of the participant's compensation. The Sponsor may make discretionary matching and nonelective contributions to eligible participants. There were no discretionary matching or nonelective contributions for 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts - Each participant's account is credited with the participant's contributions as well as allocations of plan earnings or losses. Employees of Seattle Symphony Orchestra and B.H. Music Center are also credited with safe harbor matching contributions. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting - Participants are immediately vested in all contributions.

Note 1 - Continued

Payment of Benefits - Upon termination of service, death, or disability, a participant or beneficiary may elect to receive a distribution of their account balance. The distribution may be in the form of a lump-sum payment or ongoing annuity payments. Effective January 1, 2025, the plan was amended to eliminate the annuity distribution payment option. Installment payments are allowed for required minimum distributions only. A participant may request an in-service distribution upon reaching the age of 59½. The Plan also provides for hardship withdrawals in accordance with provisions specified in the plan document.

Notes Receivable From Participants - Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account. Loans are secured by the balance in the participant's account. Interest rates are set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Transaction based fees for notes receivable from participants and distributions are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Subsequent Events - The Plan's management has evaluated subsequent events through October 15, 2025, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 - Fully Benefit-Responsive Investment Contracts

The Plan holds a portfolio of investment contracts that meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus interest, less participant withdrawals, and administrative expenses. Investments held by the Plan that meet the fully benefit-responsive investment contract criteria included the Symetra Qualified Pension Annuity Series III which held \$1,824,649 and \$1,777,658 at December 31, 2024 and 2023, respectively and the Standard Stable Asset Fund which held \$2,477,436 and \$2,405,562 at December 31, 2024 and 2023, respectively.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. If one of the above occurs, a market value adjustment may apply and the third-party issuer reserves the right to delay withdrawal payments.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the plan sponsor not abiding by state and federal law, the plan sponsor has not rendered the performance necessary to comply with the terms of the contract, if the balance in all investment funds falls below \$25,000, or if the IRS disqualifies the Plan.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 5 - Certified Information

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company and Symetra Life Insurance Company, qualified institutions. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

American Century held certain mutual funds of the Plan totaling \$1,736,701 and \$1,359,859 at December 31, 2024 and 2023, respectively. During 2024, net appreciation in the fair value of investments and dividends earned on these investments totaled \$316,970 and \$64,472, respectively. Investments and investment income earned for the mutual funds held with American Century are not certified.

Note 6 - Tax Status

Management has adopted a Thorson Barnett & McDonald PC Volume Submitter 403(b) plan document. Thorson Barnett & McDonald PC received an approval letter from the IRS dated March 31, 2017, which states that the form of the plan document satisfies the applicable provisions of Section 403(b) of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed, and is currently being operated, in a manner that would not jeopardize the tax benefits associated with these arrangements. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 7 - Party-in-Interest Transactions

Certain plan investments are managed by Symetra and American Century. Transactions with such investments are party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are also party-in-interest transactions.

Note 8 - Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 - Concentrations of Credit Risk

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of the guaranteed interest contracts issued by Standard Insurance Company and Symetra. Guaranteed interest contracts held with Standard Insurance Company represented approximately 5.1% and 5.7% of total plan investments at December 31, 2024 and 2023, respectively. Guaranteed interest contracts held with Symetra represented approximately 3.8% and 4.3% of total plan investments at December 31, 2024 and 2023, respectively. The Plan's management seeks to limit its credit exposure by working with high credit quality institutions.
