Notes to the financial statements

Note 1: Description of Plan

The following description of the West Harbor Healthcare 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of West Harbor Healthcare, LLC (the "Company") and its affiliates: Trestles Holdings, LLC DBA The Oaks Post Acute; CALAFIA Holdings, LLC DBA Redding Post Acute; Honolua Bay Holdings, LLC DBA Quartz Hill Post Acute; Bayshore Therapies, LLC; Hanalei Holdings, LLC DBA Bridgeview Post Acute; Swamis Holdings, LLC DBA Niles Canyon Post Acute; Olowalu Beach Holdings, LLC DBA Gridley Post Acute; and Playa Conchal Holdings LLC DBA Brighton Post Acute. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan's Sponsor and serves as the Plan Administrator. The Plan Administrator is responsible for oversight of the Plan as well as determining and reviewing the appropriateness of the Plan's investment offerings and investment performance. A Company officer serves as the Trustee for the Plan.

The Plan is a defined contribution plan under the provision of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC. The Plan became effective on January 1, 2018 and was restated on January 1, 2021. The Company entered into an agreement with John Hancock Life Insurance Company and/of John Hancock Trust Company, LLC (collectively, "John Hancock") to provide Plan recordkeeping and to serve as Custodians of the Plan's assets. Plan compliance and administrative services are provided by a third-party administration firm.

Secure 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date ranging from the date of enactment to 2028 and beyond, with the bulk of the provisions taking effect in 2023 and 2024. In accordance with SECURE 2.0, the Plan increased the age for required minimum distributions (RMD) from age 72 to age 73 effective January 2023. Further changes set forth in the SECURE 2.0 Act include eliminating pre-death RMD rules for Roth accounts and several voluntary changes to distribution provisions, effective January 2024. The Plan is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Contributions

Each year, participants may contribute up to 90% of their annual compensation, as defined in the Plan, into a pre-tax deferral account and/or after-tax Roth account, up to the maximum allowed by the Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans.

Note 1: Description of Plan (Continued)

Contributions (Continued)

The Company provided a Safe Harbor matching contribution of 100% of the first 4% of employee compensation for all eligible participants.

Substantially all employees are eligible to participate in the Plan upon attaining age 21 and completing six months of service. Employees may enter the Plan on the first day of each month coinciding with or following the date eligibility requirements are met.

In addition to participant and matching contributions, the Company may make discretionary profit sharing contributions to eligible participants' accounts, which are allocated based on plan-defined criteria. The Company did not make any discretionary profit sharing contributions for the year ended December 31, 2024.

Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, and allocations of (a) the Company's discretionary profit sharing contributions, (b) plan earnings (losses), and (c) restoration of previously forfeited amounts for qualifying rehired employees. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their contributions plus actual earnings thereon and Safe Harbor matching contributions. Certain participants achieve vesting in prior non-safe harbor Company contributions based on a graded vesting schedule ranging from 2 to 6 years.

Notes Receivable From Participants

The Plan allows participants to borrow against their vested account balances. Loans may not be made for less than \$500 and may not exceed the lesser of \$50,000 reduced by the highest outstanding loan balance in the previous 12 months or 50% of a participant's vested account balance. The interest rate for loans is based on 1 percentage point over the prime interest rate at the time of loan origination. Principal and interest are paid ratably through payroll deductions not to exceed five years unless the note proceeds are used for the purchase of a principal residence. Only one loan can be outstanding at a time for any participant.

Note 1: Description of Plan (Continued)

Payment of Benefits

Upon severance of service due to death, disability, retirement, or termination, a participant (or beneficiary) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installments, or a direct rollover to another eligible retirement plan. Certain other in-service distributions are allowed, including rollovers to other qualifying plans and for military service reasons. For these reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. If a terminated participant's account is \$7,000 or less, the Plan may distribute the account balance in one lump sum to an IRA without prior approval of the participant.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$468 and \$10,353, respectively. These accounts will be used to reduce future Company contributions, pay administrative expenses of the Plan in accordance with the plan document, or restore previously forfeited amounts for qualifying hired employees. During the year ended December 31, 2024, Company fees were reduced by \$8,327 from forfeited nonvested accounts.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

Subsequent Events

The Company has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023:

Pooled separate accounts: Unit values for variable annuity investment options are calculated daily by the annuity provider according to the methods described in the annuity contract. The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value the following morning. The accounting unit value is determined in a manner similar to a mutual fund NAV calculation by dividing the net assets by the number of units outstanding.

Common/collective trust funds: Valued at NAV provided by the administrator of the fund using NAV as a practical expedient to estimate fair value. These funds are stable funds and their NAVs are based on the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily, and there are no restrictions as to the redemption of these funds or unfunded commitments.

In accordance with GAAP, certain investments that are measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy.

Note 4: Information Prepared and Certified by the Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments, non-interest bearing cash and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company and John Hancock Trust Company, LLC, the Custodians of the Plan.

Note 5: Party-In-Interest Transactions

An officer of the Company is the Plan's Trustee, Premier Plan Consultants, Inc. is the Plan's third-party administrator, and John Hancock is the Plan's custodians and recordkeeper. Certain Plan investments are managed by John Hancock; therefore, these transactions are considered to be exempt party-in-interest transactions. Administrative expenses paid by the Plan to the Trustee, third-party administrator, custodians, recordkeeper and other service providers, are considered to be exempt party-in-interest transactions.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Note 7: Tax Status

The Company adopted a non-standardized pre-approved plan document with an IRS notification letter, which states the pre-approved plan document is in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the determination letter; however, the Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
