## Independent Auditor's Report

To the Administrative Committee of

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note A – Description of Plan

The following description of the Hamadeh Educational Services, Inc. 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General.* All employees of the Company except union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining and/or leased employees are eligible to participate in the Plan upon completing the Plan's eligibility requirements. For purposes of salary deferrals, the entry date will be the first day of the month coinciding with or next following the date the employee satisfies the eligibility requirements.

Employees of the Company who have completed six months of service and are age twenty-one or older are eligible to participate in the Plan. The Plan does not credit the employee with the actual hours of service. Instead, the Plan uses an "equivalency" method. Under this method the employee will be credited with 190 hours of service for each month during the year in which the employee would otherwise be credited with at least one hour of service. For employees that are veterans and are reemployed under the Uniformed Services Employment and Reemployment Rights Act of 1994, their qualified military service may be considered service with the Company. Employees who receive wage continuation payments while in the military may benefit from law changes effective in 2009.

2. *Contributions.* Participants under the Plan may elect to reduce their compensation by a specific percentage or dollar amount and have that amount contributed to the Plan as a salary deferral. There are two types of salary deferrals: Pre-Tax 401(k) deferrals and Roth 401(k) deferrals. Elective Deferrals to the Plan are made from participants' eligible earnings before taxes are taken out. Participants may elect to defer a percentage of their compensation each year instead of receiving that amount in cash. In addition, participants may separately elect to defer up to 100% of any bonuses paid to the participant during the year. The total deferrals in any taxable year may not exceed a dollar limit which is set by law. The limit for 2024 is \$23,000. The catch-up contribution limit for employees aged 50 and over who participate in the plan is \$7,500.

This Plan is referred to as a "safe harbor 401(k) plan". In order to maintain "safe harbor" status, the Employer will make a safe harbor matching contribution equal to 100% of the participant's salary deferrals that do not exceed 4% of his/her compensation. This safe harbor matching contribution is 100% vested. For purposes of calculating the safe harbor matching contribution, the compensation and deferrals will be determined on a payroll period basis.

3. *Participant Accounts.* The Administrator will allocate the amount the participant elects to defer to an account maintained on the participant's behalf. The participant will always be 100% vested in this account (applies to new salary deferrals including Roth 401(k) deferrals and catch-up contributions, rollover contributions, and safe harbor contributions).
4. *Vesting.* Participants are 100% vested (applies to new salary deferrals including, Roth 401(k) deferrals and catch-up contributions, rollover contributions, and safe harbor contributions). The "vested percentage" for certain Employer contributions is based on vesting years of service.
5. *Participant Loans Receivable.* The amount the Plan may loan to the participant is limited by rules under the Internal Revenue Code. Any new loans, when added to the outstanding balance of all other loans from the Plan, will be limited to the lesser of: (a) \$50,000 reduced by the excess, if any, of the participant's highest outstanding balance of loans from the Plan during the one-year period ending on the day before the date of the new loan over the participant's current outstanding balance of loans as of the date of the new loan; or (b) 1/2 of the participant's vested interest in the Plan. No loan in an amount less than \$500 will be made. The maximum number of Plan loans that the participant may have outstanding at any one time is three (3). The participant will be charged a commercially reasonable rate of interest. The loan administrator will determine a reasonable rate of interest by reviewing the interest rates charged for similar types of loans by other lenders. The interest rate will be fixed for the duration of the loan.
6. *Payment of Benefits.* The participant may receive a distribution of the vested portion of some or all of his/her accounts in the Plan for the following reasons: termination of employment for reasons other than death, disability or retirement, normal retirement, disability or death. If the employment terminates for reasons other than death, disability or normal retirement, the participant will be entitled to receive only the "vested percentage" of their account balance. Participants will attain the Normal

Retirement Age when they reach their 59 1/2 birthday. The Normal Retirement Date is the date on which the participants attain their Normal Retirement Age. The participant will become 100% vested in all of their accounts under the Plan if they retire on or after their Normal Retirement Age. However, the actual payment of benefits generally will not begin until they have terminated employment and reached their Normal Retirement Date. In such event, a distribution will be made, at their election, as soon as administratively feasible. If the participant remains employed past their Normal Retirement Date, the participant may generally defer the receipt of benefits until they actually terminate employment. In such event, benefit payments will begin as soon as feasible at the participant's request, but generally not later than age 70 1/2.

7. *Forfeitures.*

At December 31, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$12,127 and \$12,130 respectively.

8. *Operating Expenses.* The Plan permits the payment of Plan expenses to be made from the Plan's assets. If expenses are paid using the Plan's assets, then the expenses will generally be allocated among the accounts of all participants in the Plan. These expenses will be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. The method of allocating the expenses depends on the nature of the expense itself. After the participant terminates employment, the Employer reserves the right to charge his/her account for their pro rata share of the Plan's administration expenses, regardless of whether the Employer pays some of these expenses on behalf of current employees. There are certain other expenses that may be paid just from the participant's account. These are expenses that are specifically incurred by, or attributable to, the participant. These additional expenses may be paid directly from the participant's account (and not the accounts of other participants) because they are directly attributable to the participants under the Plan. The Administrator will inform the participants when there will be a charge (or charges) directly to the participant's account. The Employer may, from time to time, change the manner in which expenses are allocated.

Note B – Summary of Accounting Policies

*Basis of Accounting*

The financial statements of the Plan are prepared under the accrual basis of accounting.

*Estimates*

The preparation of financial statements requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year-end. Participant loans are valued at their outstanding balance, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the cash basis. Dividend income is recorded on the ex-dividend date.

*Payment of Benefits*

Benefits are recorded when paid.

Note D – Fair Value Measurements

The Plan’s investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

*Fair Value Measurement*

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1        Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measurable at fair value. There have been no changes in the methodologies used at December 31, 2024.

- *Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Collective trust fund:* Valued at the NAV of units of bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

Note E – Plan Termination

Although the Employer intends to maintain the Plan indefinitely, the Employer reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to the participant's account will become 100% vested. The Employer will direct the distribution of the participant's account in a manner permitted by the Plan as soon as practicable. The participants will be notified if the Plan is terminated.

Note F – Tax Status

The plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. Plan management and Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provisions for income taxes have been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not will be sustained upon examination by the applicable authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress.

Note G – Transactions with Parties-in-Interest

The Plan invests in common/collective trusts and mutual funds sponsored by Massachusetts Mutual Life Insurance Company, the Plan trustee, as defined by the plan, and therefore, these transactions qualify as party-in-interest transactions. Administrative fees related to the Trustees' administration of the Plan are paid by the plan. Other administrative fees are paid by the Plan sponsor on behalf of the Plan.

Note H – Risks and Uncertainties

The Plan's investments, in general, are subject to various risks such as interest rate, overall market volatility risk and credit risks. Additionally, the value, liquidity, and related income of the investment security are sensitive to changes in economic conditions and may be affected by shifts in the market's perception of issuers and changes in interest rates. Certain investments (such as asset backed securities, limited partnerships, and limited liability companies) are less liquid and may have restrictions on their sale. Forced liquidation, although not expected at this time, may affect the estimated value of such investments. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the funded status of the plan.

Note I – Subsequent Events

The Plan Administrator has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
