INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Southern Counties Lubricants, LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Southern Counties Lubricants, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Southern Counties Lubricants, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

NOTE 1. DESCRIPTION OF PLAN

The following description of the Southern Counties Lubricants, LLC 401(k) Plan (or the Plan, as set forth in the Plan Document) is provided for general information purposes only. Participants should refer to the summary plan description for a more complete description of the Plan's provisions. The Plan Document contains the definitive legal provisions governing the Plan.

General

The Plan is a defined contribution profit sharing plan covering full-time employees of Southern Counties Lubricants, LLC (or the Company, or the Sponsor) who are at least twenty-one years of age and have completed at least 500 hours of service within a 6-month period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (or ERISA), as amended.

Contributions

Contributions to the Plan include (a) salary reduction contributions authorized by participants, (b) nonelective contributions made by the Company and (c) participant rollovers from other qualified plans and individual retirement accounts.

The 401(k) salary deferral option allows employees to defer a portion of their salaries for income tax purposes on both a pre-tax and after-tax basis through contributions to the Plan. Participants may elect to contribute any percentage of their compensation to the Plan, subject to the limits of the Internal Revenue Code. Participants who have attained the age of 50 before the end of the Plan year are eligible to make certain catch-up contributions.

The Company may contribute a discretionary matching contribution equal to a percentage, as determined by management, of the elective deferrals of each eligible participant.

The Company may make a profit-sharing contribution, at the discretion of management, for any Plan year. Such a discretionary profit-sharing contribution is allocated to participants in the ratio that their compensation bears to the total compensation paid to all eligible participants for the Plan year.

A participant may make a rollover contribution to the Plan. Rollover contributions are assets transferred to the Plan from individual retirement accounts or other qualified plans in which an employee participated prior to employment with the Company.

NOTE 1. DESCRIPTION OF PLAN (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's matching contribution, if any, (b) Plan earnings and (c) forfeitures of terminated participants' nonvested accounts. Participant accounts are also charged with (a) withdrawals, (b) an allocation of service credit or Plan administrative expenses and (c) an allocation of Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Investment Direction

Participants direct the investment of their contributions and any Company matching contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds and fixed annuities as investment options for participants. Participants may change their investment options at any time throughout the year.

Vesting

Participants are vested immediately in their contributions (elective deferrals, including catch-up contributions and/or rollover contributions) and related earnings. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant vests annually for each year of service per the below schedule:

Payment of Benefits

Benefits are paid to a participant upon retirement, termination, disability, death or attainment of age 59 ½ or 70 ½. Benefits are generally distributed to the participant or beneficiary through a lump sum distribution, as defined in the Plan Document.

Payment of Benefits (continued)

On termination of service due to death, disability, retirement or any other reason, participants with a vested account balance greater than \$7,000 may elect to receive an amount equal to the value of their vested interest in either a lump-sum or in periodic installments. Participants with vested account balances of less than \$7,000 receive a lump-sum distribution upon termination of service with the Company.

In the event of financial hardship (as defined by the Plan Document), participants may withdraw money from the employee contribution portion of their Plan accounts while they are still employed.

Notes Receivable from Participants

Participants may borrow from their account an amount up to a maximum equal to \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a prime rate (as listed in the Wall Street Journal) plus 1%. Rates currently range from 4.25% to 9.5%. Participants are limited to one outstanding note at any given time, payable over a period of one to five years, except for notes used for financing the purchase of a participant's principal residence, which may not exceed fifteen years.

Participant loans are classified as notes receivable from participants on the Statements of Net Assets Available for Benefits and are valued at their unpaid principal balance, plus accrued but unpaid interest. The interest earned on these loans is shown as interest income on notes receivable from participants on the Statement of Changes in Net Assets Available for Benefits. Principal and interest are paid ratably through semi-monthly payroll deductions.

When a participant, whether active or terminated, fails to comply with the terms of a Plan loan, the outstanding principal balance is considered defaulted, and the participant is required to pay any income taxes and penalties, if applicable, on the amount. A participant loan is considered a deemed distribution during a given year if the participant loan is treated as a direct investment solely of the participant's account and, as of the end of the plan year, the participant is not continuing repayment.

Forfeited Accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures may be used to pay administrative expenses or to reduce employer contributions under the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$22,936 and \$39,706, respectively. During the year ended December 2024, \$20,794 of forfeitures were used to pay certain administrative expenses.

NOTE 2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements and accompanying notes are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (or U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value accounting.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) in the fair value of investments includes realized gains and losses on investments bought and sold during the year, as well as unrealized gains and losses on investments held at the end of the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant unpaid loan balance becomes due and payable in accordance with the terms of the underlying promissory note.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Plan Expenses

Administrative expenses are paid by the Plan as permitted by the Plan Document and to the extent that they are not paid by the Company. These expenses include, but are not limited to, accounting, legal and recordkeeping fees and investment expenses.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date which the financial statements were issued. No material subsequent events that required recognition or additional disclosure in these financial statements were identified.

NOTE 3. FAIR VALUE ACCOUNTING

Fair Value Hierarchy

U.S. GAAP includes authoritative guidance that provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs and is described below:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; and inputs other than quoted prices that are observable for the asset or liability. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable estimates using the best information available when there is little or no market data to access.

An asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Valuation Methodology

A description of the valuation methodology used for assets measured at fair value follows. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds

Mutual funds are valued at the end of the year at share prices/net asset values obtained from the National Securities Clearing Corporation, a secondary pricing source such as Interactive Data Corporation or directly from the funds themselves, all of which are considered level 1 inputs.

Fixed Annuities

Fixed annuities are comprised of a group annuity contract through Empower Annuity Insurance Company of America. It is valued using a discounted cash flow methodology where the interest rate is reset at least annually, as calculated by the annuity provider per the terms of the annuity contract at the end of the year, which is considered level 2 inputs. Fair value of this contract, prior to contract termination, equals the contract value provided by the Plan's trustee.

Valuation Methodology (continued)

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. ADMINISTRATIVE EXPENSES

Administrative expenses are paid by the Plan unless the Company elects to pay such costs. Total administrative expenses paid by the Plan during 2024 totaled \$56,407, which was comprised of contractor administrator and recordkeeping fees.

NOTE 6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

As discussed in Note 3, the Plan's investments in fixed annuities are managed or maintained by an affiliate of the trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions. Notes receivable from participants are also exempt party-in-interest transactions. All other transactions, which may be considered exempt parties-in-interest transactions, relate to normal Plan management and administrative services.

NOTE 7. TAX STATUS

The Plan Sponsor has adopted a prototype plan sponsored by Empower Retirement. The prototype plan received a favorable opinion letter from the Internal Revenue Service (or IRS) dated June 30, 2020, which states that the prototype plan and related trust have been designed in accordance with applicable sections of the Internal Revenue Code (or IRC). The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE 8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
