To the Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Terra-Gen, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

Note 1 - Description of the Plan:

The following description of the Terra-Gen, LLC 401(k) Plan (the “Plan”) for eligible employees of Terra-Gen, LLC, Terra-Gen Operating Company, LLC and Nextera Energy Operating Services, LLC (for those employees hired as part of the acquisition of Luz Solar Partners LTD, IX and Luz Solar Partners LTC, VII and related transaction of operations on April 1, 2018) (collectively the “Employer” or “Plan Sponsor”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering substantially all employees who have one month of service and are age eighteen or older. All employees who complete 1 year of service and are age eighteen or older are eligible to receive employer matching, employer profit sharing and safe harbor contributions.

Plan Administration - The Plan is administered by the Plan Sponsor. The Plan’s assets are held by Bank of America, N.A. (the “Trustee”), who is responsible for the custody and management of the Plan’s assets.

Employee Contributions - Each year, participants may make pre-tax elective deferrals and Roth contributions up to 100% of their annual compensation, as defined in the Plan document, up to the 401(k) deferral limit. All new eligible employees are automatically enrolled in the Plan, upon meeting the eligibility criteria as defined. These employees will automatically be enrolled at a default percentage of 3% unless they opt out or elect to change the default deferral percentage. Unchanged default percentages will be increased by 1% each year until a maximum of 6% is reached.

For 2024, the 401(k) deferral limit was \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The maximum catch-up contribution permitted for 2024 is \$7,500.

Employer Matching Contribution - Each pay period, the Employer contributes 50% of the first 6% of a participant’s eligible compensation to participants who have made elective deferrals and completed one full year of service. Contributions are subject to certain limitations. Employer matching contributions for the year ended December 31, 2024 totaled \$1,061,182, which is net of forfeitures applied during 2024 of \$118,000.

Employer Profit Sharing Contribution - The Employer may authorize a profit sharing contribution, which is a discretionary contribution as determined by management. This contribution, if any, will be made on a bi-weekly basis in accordance with the participant’s regular payroll and will be allocated to active participants that have made elective deferrals and have completed at least one full year of service, as defined, and are employed on the last day of the Plan year. Employer profit sharing contributions for the year ended December 31, 2024 totaled \$1,232,321.

Employer Safe Harbor Contribution - The Employer may make a safe harbor contribution to the Plan for participants who have completed one year of service equal to 3% of the eligible participant’s Plan compensation for the Plan year. Employer safe harbor contributions for the year ended December 31, 2024 totaled \$1,349,821.

Participant Accounts - Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contributions and an allocation of the Employer’s contributions, Plan earnings, participant forfeitures, and charged with withdrawals and an allocation of Plan losses and expenses. Allocations are based on participant earnings, account balances, or as defined in the Plan document. Refer to Note 2 for information on investment transactions and income recognition on individual participants’ account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTES TO FINANCIAL STATEMENTS

Investments - Participants direct the investment of their contributions into various investment options offered by the Plan. The following investment options are available for the investment of participants' elective and Employer matching, profit sharing and safe harbor contributions: mutual funds, money market accounts, self-directed brokerage accounts, and a common collective trust. Employer contributions are automatically invested into the participants' respective investment options.

Vesting - Participants are immediately vested in their voluntary contributions and safe harbor contribution accounts plus actual earnings thereon. Participants vest in the Employer matching and profit sharing contributions 20% after two years of service, increasing 20% each succeeding year until fully vested after six years of service.

Payment of Benefits - On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's account balance with full vested rights. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may also obtain a cash withdrawal of the value of their vested contribution including rollover contributions and any Employer contribution (but excluding any qualified nonelected contributions, qualified matching contributions, and safe harbor contributions and earnings on those contributions) on the basis of hardship as permitted under the Plan. See Note 2.

Forfeited Accounts - Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,254 and \$5,964, respectively. Forfeitures due to Employer matching and profit sharing contributions are first used to reduce Employer contributions; second, to offset the Plan administrative costs and; third, redistributed to Plan participants who are active employees. For the year ended December 31, 2024, employer contributions were reduced by \$118,000 and administrative expenses were reduced by approximately \$17,000 from the utilization of the forfeited non-vested accounts.

Note 2 - Summary of Significant Accounting Policies:

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions in net assets available for benefits during the reporting period. Actual results, as determined at a later date, could differ from those estimates.

Money Market Account - Money market account includes highly liquid short-term investments purchased with maturities of three months or less.

Payment of Benefits - Benefits are recorded when paid.

Hardship Withdrawals - The Plan provides for hardship withdrawals from participants' vested balances and earnings on all available sources, not to exceed an amount required to meet an immediate need created by hardship. Permissible circumstances for hardship withdrawals include medical expenses, purchase of a home, tuition payments, amounts necessary to prevent eviction from the participants' personal residence, and such other circumstances as the Plan Administrator may determine in accordance with Internal Revenue Service rules and regulations.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee, and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments as reported on the statement of changes in net assets available for benefits includes the realized gains or losses and the unrealized appreciation or depreciation on investments bought and sold as well as held during the year.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. For the year ended December 31, 2024, administrative fees and investment advisory fees are included in administrative expenses. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are also included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events - The Plan's trustee has reviewed all subsequent events and transactions from December 31, 2024 through October 15, 2025, the date the financial statements were available to be issued. The effects of those events and transactions that provide additional pertinent information about conditions that existed at the Statements of Net Assets Available for Benefits date have been recognized in the accompanying financial statements.

Note 3 - Certified Investment Information:

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the Trustee, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investment information included in the Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown in the ERISA-required supplemental schedule of assets (held at end of year).

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

Note 4 - Fair Value Measurements:

FASB Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures FASB ASC 820, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified contractual term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds:* Valued at the closing price in the active market in which the fund is traded.
- *Money market account:* Interest-bearing money market fund that seeks to provide a rate of return from a deposit in a bank account that is insured by the Federal Deposit Insurance Corporation up to applicable limits. This account is included as a Level 2 investment in the hierarchy as it is valued at the closing price in a similar market in which the fund is traded.
- *Self-directed brokerage account:* Measured as individual shares held multiplied by the closing price at the valuation date. These accounts include equities with quoted prices in active markets and investments in similar markets that trade in highly liquid financial instruments, and are included in Level 1 and Level 2 of the hierarchy.

- *Common collective trust:* Invests in a variety of separate accounts, collective trust funds and mutual funds. Shares held that are actively traded are valued where the total fair value at any valuation date equals the number of shares held multiplied by NAV at the valuation date. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the Trust will sell the investment for an amount other than the reported market value. (See Note 5)

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers Between Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2, or 3.

Note 5 - Common Collective Trust:

The Common Collective Trust held by the Plan is a stable value investment which has an objective to preserve capital and to provide a competitive level of income over time that is consistent with the preservation of capital. To achieve this objective the fund invests primarily in a variety of high quality stable value investments (the performance of which may be predicated on underlying fixed income securities), and cash and cash equivalents. Redemptions are allowed for participants daily, however in the event of a complete redemption the Plan is subject to a one-year redemption notice period, which may be waived by the trustee. There are no unfunded commitments.

Note 6 - Risks and Uncertainties and Concentration of Investment Risk:

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the financial statements.

The Plan may invest in securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage backed securities, including securities backed by sub-prime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

The Plan's investment in one fund comprised approximately 16% and 14% of total investments in 2024 and 2023, respectively.

Note 7 - Party-in-Interest Transactions:

Certain Plan investments are shares of mutual funds managed by the Trustee and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment advisory and administrative services were \$117,630 for the year ended December 31, 2024, which is net of approximately \$17,000 of forfeitures applied from non-vested accounts. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments. As described in Note 2, the Plan Sponsor pays directly any other fees related to the Plan's operations.

Note 8 - Tax Status:

The Plan was written on an Internal Revenue Service (IRS) non-standardized pre-approved document, which obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Note 9 - Plan Termination:

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' contributions remain fully vested and Plan Sponsor contributions, if any, become fully vested. Under no circumstances may the Plan Sponsor take ownership of any of the Plan's assets as a result of such termination.

Note 10 - Notes Receivable from Participants:

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loan fund. Loan terms range from 1 to 5 years, unless the loan is for the purchase of a primary residence. Loans bear interest at the prime rate as determined at the time the loan is approved. Principal and interest are payable ratably through biweekly payroll deductions.
