Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The I.A.T.S.E. Local No. 33 Health and Welfare Trust Fund (the "Plan") is a multiemployer health and welfare benefit plan providing medical, prescription, vision, dental, life and accidental death and dismemberment benefits as detailed in the summary plan description for eligible participants and their dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

For retirees and their dependents, the Plan provides medical and prescription benefits, provided that retirees enroll and meet the enrollment requirements.

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Postretirement Benefit Obligations

The postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed to employee service rendered to December 31. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with participating employers. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date. The postretirement benefit obligations were determined by actuaries from Milliman and are the amounts that result from applying actuarial assumptions to historical benefits cost data to estimate future annual incurred benefit cost per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability or withdrawal), between the valuation date and the expected date of payment.

The significant actuarial assumptions and methods used for the year ended December 31, 2024 (2023) were: (a) Discount Rate: 5.50% (4.80%), (b) Retiree Contribution Increase Rate: Same Increase as Health Care Cost Trend Rates and (c) Postretirement Mortality Rates: Healthy Lives – Pri-2012 Mortality with Blue Collar Adjustment, set forward 1 Year with Generational Projection using Scale MP-2020; Disabled Lives – Pri-2012 Disabled Annuitant Mortality, set forward 1 Year, with Generational Projection using Scare MP-2020.

C. Postretirement Benefit Obligations (Continued)

For the year ended December 31, 2024, the discount rate increased from 4.80% to 5.50% and healthcare cost trends were updated. The change in the healthcare cost trend increased the postretirement benefit obligations by \$1,264,000 and the increase in the discount rate decreased the postretirement benefit obligations by \$3,910,000. The net effect of these changes in actuarial assumptions caused a decrease of \$2,646,000 and a decrease of \$5,408,000 in postretirement benefit obligations during the years ended December 31, 2024 and 2023, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

The cost trend rates have a significant effect on the postretirement benefit obligations. A 1% increase in health care cost trend rates would increase the postretirement benefit obligations as of December 31, 2024 and 2023 by \$5,636,000 and \$7,173,000, respectively.

The costs of the postretirement benefit plan are shared by the Plan's participating employers and retirees. Retiree contributions cover 43% and 42% of gross current year benefit costs as of December 31, 2024 and 2023, respectively.

The calculation and reporting of the postretirement benefit obligations does not imply that there is any legal liability to provide the benefits valued, nor is there any implication that the Plan is required to implement a funding policy to satisfy the projected expense.

D. Contributions

Contributions received in the subsequent year for December and prior months' employees gross wages earned have been accrued. No allowance is provided for estimated uncollectible accounts. Participant contributions consist of employee and retiree self-payments from active and retired participants for coverage during the year.

E. Payroll Compliance Program

Remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' records under a separate payroll compliance program.

F. Investments

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair values are observable in the market:

F. Investments (Continued)

Level 1 – Inputs are quoted prices in an active market.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value:

Common/Collective Trusts – Valued at the net asset value (“NAV”) of shares held by the Plan at year end.

Mutual Funds and Short-Term Investment Fund – Valued at the closing price reported on the active market.

^A In accordance with ASC 820, investments measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

Unrealized appreciation or depreciation in the fair value of investments is reported as net unrealized appreciation of investments.

G. Benefits

Benefit obligations are based on estimates at the end of the year of unpaid premiums for coverage during the year (Premiums Payable); future benefit costs to be incurred based on participants' accumulated eligibility credits (Future Benefits Based on Participants' Accumulated Eligibility) and the actuarial present value of those estimated future benefits expected to be paid to or for (1) currently retired or terminated participants and their beneficiaries and dependents and (2) active participants and their beneficiaries and dependents after retirement from service with participating employers (Postretirement Benefit Obligations).

H. Tax-Exempt Status

No provision for federal or state income tax is made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

I. Plan Termination

The Plan shall continue until all the collective bargaining agreements providing for contributions to the Plan have expired and negotiations for extension thereof have ceased. The Plan may be terminated at an earlier date by written agreement of all the employers and I.A.T.S.E. Local 33.

In the event the obligations of all the employers to make contributions to the Plan shall terminate or the Plan otherwise terminates, the Board of Trustees shall determine the disposition of any assets in the Plan remaining after all expenses of the Plan have been paid; provided that any such distribution shall be made only for the benefit of former participants and for the purposes set forth in the Plan. Upon the termination of the Plan, the Board of Trustees shall continue in such capacity for the purpose of dissolution of the Plan with full powers as herein provided and may execute any and all instruments which may be required.

NOTE 4 - CONCENTRATION OF CREDIT RISK

During 2024, the Plan maintained bank accounts with cash balances in excess of the federally insured limit of \$250,000 per bank. The amount in excess of the limit was subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balances.

NOTE 5 - RISKS AND UNCERTAINTIES

Plan investments are exposed to various risks such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Postretirement benefit obligations are reported based on certain assumptions pertaining to interest rates, inflation rates, employee demographics and other factors, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 6 - PLAN AMENDMENT

Effective June 1, 2023, the Board of Trustees approved Amendment No. 3 to change the Plan's definition for domestic partnership to comply with California law.

NOTE 7 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.



