We have performed audits of the financial statements of The Sherwin-Williams Company Salaried Employees' Revised Pension Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## INDEPENDENT AUDITOR'S REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of The Sherwin-Williams Company Salaried Employees' Revised Pension Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1 - DESCRIPTION OF THE PLAN**

General

The Administration Committee, as Plan Administrator, is responsible for the general administration of The Sherwin-Williams Company Salaried Employees' Revised Pension Investment Plan (the Plan). The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Eligible employees of the Sherwin-Williams Company (the Company) may participate in the Plan upon completion of six months of service.

Eligibility

The Plan has historically provided retirement benefits for the following participants:

- Certain salaried employees of the Company who made an irrevocable election at the applicable time to transfer the present value of their accrued pension benefits from The Sherwin-Williams Company Salaried Employees' Pension Investment Plan (SEPIP) (a defined benefit plan).
- Salaried employees who were hired on or after January 1, 1984 and before January 1, 2002.
  - Effective January 1, 2002, the Plan was frozen and ceased admitting new participants. All salaried employees hired or re-hired between January 1, 2002 and September 30, 2011 became participants in SEPIP.
- Salaried employees hired or re-hired on or after October 1, 2011.
  - Effective October 1, 2011, SEPIP was frozen to new participation and the Plan was re-opened to participation to all U.S. non-bargaining unit employees hired or re-hired on or after this date.

In 2018, the Plan was amended to add the following participants:

- Eligible active employees that were previously precluded from participating in the Plan due to being participants in SEPIP became participants of the Plan effective January 1, 2018.
- In connection with the acquisition of The Valspar Corporation (Valspar) in 2017, eligible former Valspar employees became participants of the Plan effective July 1, 2018.

In 2022, the Plan was amended to add the following participants:

- In connection with the acquisition of Dur-A-Flex, Inc. (Dur-A-Flex) in 2022, eligible former Dur-A-Flex employees became participants of the Plan effective January 1, 2023.

In 2024, the Plan was amended to add the following participants:

- In connection with the decertification of the bargaining unit at the Company's Lawrenceville, Georgia facility, employees previously represented by the Paint Makers and Industrial Workers Local Union 1961 became eligible to participate in the Plan effective February 5, 2024, upon completion of six months of service.

### Employer Contributions

The Company contribution credit for all participants is based on the sum of their age and service as follows:

All amounts contributed to the Plan are maintained in an account on behalf of each participant. The amounts may be invested, in accordance with instructions from each participant, in any of the available investment funds. Participants may choose to invest the amounts in their individual account in any of the investment funds available in whole percentages or by specific dollar amount. Participants may elect to transfer cash between investment funds and to change the method of investing their current account balance any business day, subject to certain trading restrictions imposed by each fund manager. Each participant's account is credited with its respective share of fund earnings.

### Participant-Directed Investments

Investments are participant directed. In the absence of participant direction, contributions are directed to an age-appropriate T. Rowe Price target date retirement fund. Costs incidental to the purchase and sale of securities, such as brokerage fees, commissions and stock transfer taxes, are borne by the respective funds.

### Investments

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### Vesting

Vesting is based on years of service with full vesting occurring after three years of credited service. There is no partial vesting.

### Participant Accounts

Each participant's account is credited with an allocation of (a) the Company's contributions and (b) Plan earnings (losses) and is charged with withdrawals and an allocation of administrative expenses. Allocations are based on specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

### Forfeitures

Participants who separate from service prior to being 100% vested will have the nonvested balances in their accounts forfeited and such amounts are used to reduce future Company contributions. Contributions from the Company during 2024 were reduced by forfeitures of \$3,066,635. The unallocated forfeiture balance as of December 31, 2024 and 2023 was approximately \$1,310,000 and \$1,700,000, respectively.

### Withdrawals

All retirement benefits, based on the value of the respective participant's account, may be distributed directly to the participant in the form of a joint and survivor annuity. However, if the participant properly waives such form of payment and their spouse consents, or if the participant is not married, benefits may be paid to the participant in a life annuity or a lump-sum distribution. Participants may elect to have the vested amounts in their accounts distributed to them upon termination of employment.

### Administrative Expenses

Administrative expenses related to operating and maintaining the Plan are paid by the Plan and the Company, except for costs related to maintaining account balances for terminated participants, which are paid by those participants. Other income consists of unallocated revenue credits, which the Plan intends to use to pay for future administrative expenses or allocate pro-rata back to participants.

### Additional Information

Additional information with respect to provisions of the Plan is contained in the Plan's Summary Plan Description (SPD). Copies of this SPD are available from the Administration Committee of the Company.

## **NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from these estimates.

### Investment Valuation

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. See Note 3 for further details.

### Income Recognition

Net realized and unrealized appreciation in fair value of investments represents the change in the difference between the aggregate fair value and the cost of the Plan's investments, including investments bought, sold and held during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

### Payment of Benefits

Benefits are recorded when paid.

### Subsequent Events

Events occurring subsequent to December 31, 2024 have been evaluated through September 10, 2025, the date of the issuance of the financial statements, in accordance with the Subsequent Events Topic of the Accounting Standards Codification (ASC). During this period, there were no recognized subsequent events requiring recognition in the financial statements and no non-recognized subsequent events requiring disclosure.

## **NOTE 3 - FAIR VALUE MEASUREMENTS**

The Fair Value Measurements and Disclosures Topic of the ASC applies to the Plan's financial assets. The levels of the fair value hierarchy are as follows:

Level 1: Quoted prices in active markets for identical assets

Level 2: Significant other observable inputs

Level 3: Significant unobservable inputs

The fair value of mutual funds is based on quoted redemption values on national security exchanges on the last business day of the Plan year.

The fair value of the money market fund is based on quoted prices in active markets for identical securities.

The collective trust funds are measured at net asset value (NAV) as a practical expedient. In accordance with the Fair Value Measurement Topic of the ASC, investments that are measured at NAV using the practical expedient are not classified in the fair value hierarchy. The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the Statements of Net Assets Available for Benefits. There are no unfunded commitments, significant redemption limitations or restrictions on the ability to sell these funds.

#### **NOTE 4 - CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the Trustee).

## **NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and terminate the Plan. In the event of Plan termination, participating employees will become fully vested in their respective accounts and the net assets of the Plan shall be distributed in accordance with applicable Plan provisions.

## **NOTE 6 – INCOME TAX STATUS**

The Plan has received a determination letter from the IRS dated July 25, 2016, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code), and therefore, the related trusts are exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. Subsequent to this determination by the IRS, the Plan was amended. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended, is qualified and the related trusts are tax-exempt.

U.S. GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

## **NOTE 7 - TRANSACTIONS WITH PARTIES-IN-INTEREST**

Certain Plan investments as of December 31, 2024 and 2023 were shares of mutual funds, collective trust funds or a money market fund managed by Fidelity or one of their affiliates, and therefore qualify as parties-in-interest. Fees paid during the year for services rendered by Fidelity or one of their affiliates constitute party-in-interest transactions.
