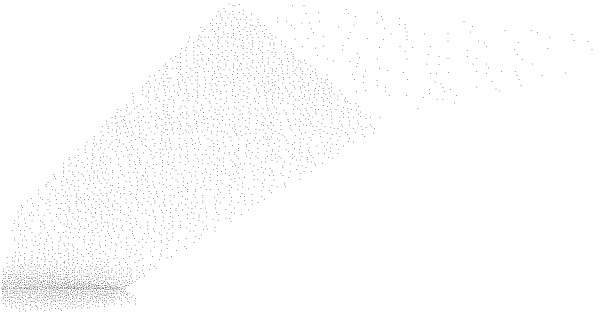

Notes to Financial Statements

Note 1: Description of Plan

The following description of the North American Client Services, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions

General

The Plan is a defined contribution plan covering all eligible employees of North American Client Services, Inc., Apple Valley Post-Acute Rehab, Brentwood Health Care Center, Courtyard Care Center, Fireside Convalescent Hospital, Lincoln Square Post-Acute Care, Linda Mar Care Center, Terrace View Care Center, Valencia Gardens Health Center, Villa Health Care Center, West Covina Care, Inc., NAHS Holding, Inc., NAHS North, Inc., NAHS Southeast, Inc., NAHS Southwest, Inc., Fortis Assurance, Inc., Magave Care, Inc., Alert Mobile Diagnostics, and Wildflower Holdings, LLC (collectively referred to as the "Company"). Employees become eligible to participate in employee deferrals and the company discretionary match and non-elective contributions after completing 60 days of service and attaining the age of 21. Employees enter the Plan on the first day of each calendar month following their fulfillment of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Management of the Company is responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring of investment performance.

Contributions

Each year, participants may contribute to the Plan up to the maximum allowable limits of the Internal Revenue Service ("IRS") on a pre-tax or Roth basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollover contributions"). Participants direct the investments of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions and discretionary non-elective contributions. Rollover contributions are not matched. Participants must be employed on the last day of the plan year and have worked at least 1,000 hours in the plan year in order to receive the Company discretionary non-elective contributions. For 2024, the Company made discretionary matching contributions of 0.5% of eligible compensation, limited to 10% of employee deferrals. The Company did not make any discretionary non-elective contributions during 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, and allocations of (a) the Company's discretionary non-elective contributions and (b) plan earnings (losses). Participant accounts are reduced by withdrawals and charged with an allocation of administrative and investment management expenses paid by the Plan. Allocations are based on the participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately vested in their voluntary deferral and rollover contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and non-elective contributions portion of a participant's account is based on the number of years of service. Participants vest at a rate of 33% per year and become fully vested after three years of service. In addition, there is full vesting upon death or disability of an employee.

As discussed in Note 9, effective January 31, 2023, the Plan experienced a partial termination due to a significant reduction in plan participants. As a result of the partial termination, all affected participants became fully vested in their account balance.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note terms range from one to five years or may extend beyond five years if the note is for the purchase of a primary residence. A participant can only have two loans outstanding at one time. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50% at December 31, 2024, which were equal to the prime rate plus 1.00% as of the date of note issuance. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Plan benefits are available at normal retirement (age 65), disability retirement, death, or termination of employment with vested interest. Participants may elect to receive benefits in the form of a lump-sum distribution or in installments. In addition, hardship distributions out of the participant's voluntary contributions accounts are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participant account balances are also distributable to the participant upon termination of employment if the balance is less than \$7,000. Participants may withdraw their rollover contributions at any time. The distribution of the participant's account must commence no later than April 1 following the calendar year in which the participant attains age 73.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in Company contributions. Forfeited nonvested accounts totaled \$14,914 at December 31, 2024, and \$7,965 at December 31, 2023. These accounts may be used to reduce future Company contributions or pay administrative expenses of the Plan in accordance with the plan document. During the year ended December 31, 2024, forfeitures of \$39 were used to offset Company discretionary matching contributions.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The Plan has adopted some of these provisions, and is the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Note 2: Summary of Significant Accounting Policies (Continued)

Administrative Expenses and Investment Management Expenses

Certain expenses for maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment management fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are reflected as investment management expenses and included in net investment income. Fees related to administrative expenses are allocated proportionately to plan participants based on their respective account balances and included in administrative expenses. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and included in administrative expenses.

Subsequent Events

Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used only if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust funds held in pooled separate accounts: Fair value is estimated using of the NAV per unit by the issuer of the pooled separate accounts. Fair value is based on their value of underlying investments held by the pooled separate accounts. There are no funding commitments associated with the pooled separate accounts and they can transact daily, except in circumstances where funds are being transferred to a competing investment options, which may require a 90-day notice period.

Note 4: Information Prepared and Certified by Trustee and Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC, the Trustee of the Plan and Empower Annuity Insurance Company of America (Empower Annuity), the Custodian of the Plan.

Note 5: Party-In-Interest Transactions

Empower Annuity is the Custodian, as defined by the plan document and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administration services amounted to \$136,533 for the year ended December 31, 2024.

MMA Securities, LLC ("MMA"), Accelerate Investment Advisors, LLC ("Accelerate"), and Stifel Nicolaus & Co., Inc. ("Stifel") are investment advisors to the Plan and, therefore, fees paid to all investment advisors qualify as party-in-interest transactions. Fees paid by the Plan for investment management fees amounted to \$17,572 to MMA, \$14,194 to Accelerate, and \$14,194 to Stifel for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Tax Status

The Company adopted a non-standardized pre-approved plan document with an IRS notification letter dated November 14, 2022, which states the non-standardized pre-approved plan document as then designed is in compliance with the applicable sections of the Internal Revenue Code (IRC). Although the plan document has been amended since receiving the letter, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their account balances.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: Partial Plan Termination

During 2023, the Plan experienced a significant reduction in plan participants due to the Company terminating the employees of Alamos-Belmont Rehab Hospital, Beachside Nursing Center, Broadway by the Sea, Burien Nursing & Rehabilitation Center, Chatsworth Park Health Care Center, Cottonwood Post-Acute Rehab, Coventry Court Health Center, Danville Rehabilitation, Edgewater Convalescent Hospital, Fairfield Post-Acute Rehab Center, Fairmont Rehabilitation Hospital, Garden View Post-Acute Rehab, Grand Terrace Care Center, Issaquah Nursing & Rehabilitation Center, Lake Balboa Care Center, Lomita Post-Acute Care Center, Pacifica Nursing & Rehab Center, Palm Terrace Care Center, Park Ridge Care Center, Park West Care Center, Ramona Nursing & Rehab Center, University Post-Acute Rehab, Woodland Nursing & Rehabilitation, and Orange Coast Care, Inc. dba Orange Coast Post-Acute, due to sale transactions. In aggregate, the terminations represented a partial plan termination of the Plan. The partial plan termination was effective January 31, 2023. As a result of this partial termination, all affected participants became fully vested in their account balance.

Note 10: Prohibited Transactions

Under DOL Reg. 2510.3-102(b), the Company is required to remit the employee contributions to the Plan at the earliest date such amounts can be reasonably segregated from the Company's general assets, but no later than the fifteenth business day of the month following the date that participant contributions are withheld by the Company. As reported on Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain contributions for payrolls during the plan years ended December 31, 2023, 2022, and 2021, totaling \$7,913, \$23,062, and \$6,233, respectively, were remitted outside the 15-day requirement. These transactions constitute a prohibited transaction as defined by ERISA. Subsequent to year-end, the Company will make contributions to the affected participant's accounts to compensate those participants for potential lost earnings due to the delay.
