Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter - supplemental schedules required by ERISA

The supplemental schedule of delinquent participant contributions for the year ended December 31, 2024 and schedule of assets (held at end of year) as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedules that agreed to or is

derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - PLAN DESCRIPTION

The following description of Liquid Web, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document and related adoption agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Liquid Web, LLC (the "Company" or "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Eligibility

All employees of the Company, except nonresident aliens, leased employees and residents of Puerto Rico are eligible to voluntarily participate in the Plan. Employees must reach 18 years of age and may enter the Plan after 60 days of employment and can enroll on the first day of the month after meeting these requirements.

Contributions

The Plan provides for employee salary deferral contributions of no less than 1 percent and no more than 99 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code ("IRC") Section 402(g). Participants who have obtained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants are automatically enrolled in the Plan deferring 6% of eligible compensation unless they opt out of contributing or elect a different contribution amount or percentage. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company may make a matching contribution to each eligible participant based on the participant's total contributions to the Plan. During the year ended December 31, 2024, the Plan provided for Employer matching contributions of 100 percent of the participant's contributions, not to exceed 3 percent of compensation contributed by the employee, 20 percent of the next 2 percent, and 10 percent of the next 1 percent not to exceed 6 percent. The Plan also allows for Company safe harbor contributions. There were no Company safe harbor contributions made during 2024. The total safe harbor contribution is not to exceed 3.5 percent of the employee's compensation.

Participants of the Plan may direct their contributions and any related earnings into a number of available investment options that vary in degree of risk and investment objective.

All Plan contributions are subject to certain IRC limitations.

Benefit Payments

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account. If a participant's vested plan account balance is \$5,000 or less on the date of distribution, the Plan Administrator can force out the distribution. If the participant's account exceeds \$1,000 and the participant does not elect to have the distribution paid to an eligible retirement plan in a direct rollover or receive the distribution directly, the Plan will pay the distribution in a direct rollover to an individual retirement account, unless the benefit is payable to a participant's designated beneficiary in which case the participant's vested account balance will be paid in cash directly to the beneficiary. In addition, participants may elect in-service withdrawals of their account balances after reaching age 59½. Hardships withdrawals are also permitted if meeting the hardship distribution requirements. Employees are entitled to their full account balances if the normal retirement date

and age criteria have been met at the time of retirement. For death, disability, or termination of employment, distributions equal to the vested percentage of the total account balance will be made in the form of a lump-sum amount.

Participants who have terminated employment and reached a certain age are required to take minimum required distributions in accordance with the terms of the Plan and applicable law. As of January 1, 2023, the required minimum distribution age was amended to be age 73.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to pay for Plan expenses. There was \$54,904 of forfeited balances used to pay Plan expenses during the year ended December 31, 2024. There was a balance of \$194,996 and \$4,608 in the forfeitures account as of December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions and Plan earnings and is charged with withdrawals, an allocation of administrative expenses and Plan losses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's matching and safe harbor contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants become fully vested in Employer matching contributions after three years of service and are 100% vested in safe harbor Employer contributions. Participants become fully vested upon death, becoming disabled or attaining early retirement age (59½).

Party-in-interest Transactions

The Plan holds units of a collective trust fund managed by Reliance Trust Company. Reliance Trust Company (the "Trustee") is the Trustee of the Plan; therefore, transactions in the collective trust fund qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

Although there has been no expressed intent to do so, in the event of Plan termination, the custodian will distribute the assets in the Plan to participants in proportion to their respective account balances. Upon termination of the Plan, the participants become 100 percent vested in their account balances.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a description of the fair value investments.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes realized gains and losses on investments sold and the change in the unrealized appreciation on investments held during the year.

Administrative Expenses

Certain Plan administrative expenses are paid by the Plan and others are paid by the Company. Investment transaction expenses are included in net appreciation of fair value of investments.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY THE PLAN TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting Disclosures under ERISA. Accordingly, as of December 31, 2024 and 2023 and for the year ended December 31, 2024, Reliance Trust Company, the Trustee, has certified the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Schedule H, Line 4(i) - schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

US GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There were no transfers between levels for the years ended December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the net asset value ("NAV") of shares held by the Plan at year end and are based on quoted prices and are therefore classified in Level 1 of the fair value hierarchy. The mutual funds held by the Plan are actively traded.

Collective trust fund: Valued at NAV as a practical expedient, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

NOTE 5 - TAX STATUS

The Plan utilizes the Transamerica Retirement Solutions, LLC pre-approved Plan document that received an Internal Revenue Service ("IRS") opinion letter on June 30, 2020 which stated that the Plan is acceptable under Section 401(k) of the Internal Revenue Code (the "Code") for use by eligible Employers for the benefit of their employees. Although the Plan has been amended since the opinion letter was received, the Plan Administrator believes that the Plan is currently designed and operating in accordance with the applicable

requirements of Section 401(k) of the Code and, therefore, believes the Plan is qualified and therefore tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Company has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - TERMINATION OF THE PLAN

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Company contributions.

NOTE 7 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through the date the financial statements were available to be issued, October 14, 2025. There have been no significant events that would require adjustment to or disclosure in these financial statements.
