## INDEPENDENT AUDITORS' REPORT

To the plan administrator of

Los Angeles, California

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Cordoba Corporation 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“U.S. GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors’ Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the key terms and provisions of Cordoba Corporation 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### ***General***

The Plan is a defined contribution and profit sharing plan, established on July 1, 2004, covering the employees of Cordoba Corporation (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and subsequent amendments. The Company is the Plan’s sponsor and serves as the plan administrator and is responsible for oversight of the Plan as well as determining the appropriateness of the Plan’s investment offerings and monitoring of investment performance. The Plan’s record-keeper is Fidelity Workplace Services LLC and the trustee is Fidelity Management Trust Company (the “Trustee”).

##### ***Eligibility***

Full-time employees of the Company are eligible to participate in the Plan after attaining age 21. Participation in the Plan for full-time employees is effective the first day of the following month upon hire. Upon the participant’s eligibility, the participant is automatically enrolled in the Plan with an automatic deferral set at 4% of eligible compensation unless the participant makes a contrary election. Part-time employees are eligible to participate after attaining age 21 and completing one year of service and at least 1,000 hours of service during the Plan year or three consecutive years of service each with 500 hours of service. Participation for part-time employees is effective the first day of the following month after eligibility requirements are met.

##### ***Contributions***

Each year, participants are able to contribute up to 75% of their pre-tax eligible compensation, as defined by the Plan agreement, in an amount not in excess of the maximum allowed by the Internal Revenue Code (“IRC”). A participant may designate all or part of their elective contribution as a Roth, after-tax basis, contribution. Participants who have reached age 50 as of the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified plans.

The Company, at its discretion, may make matching contributions equal to a discretionary percentage of the participant’s eligible compensation contributed to the Plan. During the year ended December 31, 2024, the Company made discretionary matching contributions equal to 50% of the first 7% of a participant’s eligible deferred compensation. The Company, at its discretion, may also make a discretionary profit sharing contribution in accordance with the provisions of the Plan agreement. To become eligible for discretionary profit sharing contributions, employees must make deferral contributions, complete at least one year of service and 1,000 hours of service during the Plan year and be employed the last day of the year. The Company did not elect to make a discretionary profit sharing contribution for the year ended December 31, 2024.

#### *Contributions (continued)*

In addition, the Company may make qualified non-elective contributions (“QNEC”). A QNEC is a discretionary, fully-vested contribution. The Company may direct that QNECs be allocated specifically to designated non-highly compensated employees in varying percentages of compensation as permitted by law.

#### *Participant accounts*

Each participant’s account is credited with the participant’s contributions, rollover contributions, the Company’s matching contributions, if any, an allocation of the Company’s discretionary profit sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which the participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of their account to any of the investment options available under the Plan.

#### *Vesting*

Participants are vested immediately in their elective contributions, rollover contributions and QNEC contributions, plus actual earnings thereon. A participant is fifty percent (50%) vested in employer matching contributions after two (2) years of credited service and one hundred percent (100%) after three (3) years of credited service. Vesting in the Company’s profit sharing contributions is based on continuous years of service. A year of service is defined as 1,000 hours within a Plan year. The vesting schedule is as follows:

Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years or more	100%

A participant is entitled to 100% of their balance upon retirement, death or disability.

#### *Notes receivable from participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms shall not exceed five years, unless the loan is for the purchase of a primary residence, in which case the plan administrator may permit a longer repayment term not to exceed ten years. The loans are secured by the balance in the participant’s account. Each loan bears a commercially reasonable rate of interest as set by the plan administrator and is typically paid ratably through payroll deductions. Loans outstanding at December 31, 2024 and 2023 bore interest at rates ranging from 3.25% to 8.50% per annum. Loans outstanding at December 31, 2024 mature through August 2030.

##### ***Payment of benefits***

On termination of service due to death, disability, retirement, or for other reasons specified by the Plan agreement, a participant (or beneficiary) may elect to receive either a lump-sum amount equal to the value of the vested interest in the participants' account, a distribution under a systematic withdrawal plan, or a direct transfer into another qualified plan that accepts transfers. Normal retirement age is 65. In-service distributions are also permitted after age 59½, and upon meeting certain requirements as defined by the Plan. The Company may periodically distribute the funds of terminated participants who did not make a distribution election; however, participant consent is required for distributions where the vested account balance exceeds \$7,000.

##### ***Hardship withdrawals***

A participant may be permitted to withdraw a portion or all of the balances of their individual account that is attributable to the participant's pre-tax deferral contributions (without earnings), Roth deferral contributions (without earnings), profit sharing and matching contributions for the reasons specified by and to the extent permitted under regulations issued by the Internal Revenue Service ("IRS").

##### ***Forfeited accounts***

Forfeited balances of terminated participants' non-vested accounts are used first to restore rehired participants' previous forfeitures, then may be used to pay Plan expenses or reduce future Company contributions. During the year ended December 31, 2024, \$345,578 of forfeitures were applied to offset employer discretionary matching contributions. Unallocated forfeitures at December 31, 2024 and 2023 amounted to \$15,400 and \$75,931, respectively.

#### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### ***Basis of accounting***

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

##### ***Use of estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### ***Investment valuation and income recognition***

The Plan's investments are reported at fair value, except for the guaranteed investment contract and stable value fund that are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation or depreciation in investments includes the Plan's gains and losses in investments bought and sold as well as held during the year.

##### ***Notes receivable from participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### ***Payment of benefits***

Benefits are recorded when paid.

##### ***Plan expenses***

The majority of costs and expenses of administering the Plan are allocated and charged to participant accounts. The Plan permits the payment of plan expenses to be made from the Plan's assets. Certain administrative expenses of maintaining the Plan may be paid directly by the Company, which is a party-in-interest. These expenses would not be reflected in the financial statements and constitute exempt party-in-interest transactions under ERISA.

##### ***Excess contributions payable***

Excess contributions payable represents amounts refunded to participants after year-end to comply with regulatory and Plan contribution limitations.

#### **NOTE 3 - INVESTMENTS**

The Plan assets were held by the Trustee pursuant to the agreement which provides all funds received by the Trustee shall be held, administered, invested and distributed by the Trustee, and that no part of the corpus or income shall be used for, or directed to, purposes other than for the exclusive benefit of participants or their beneficiaries.

In the statement of changes in net assets available for benefits, the Plan presents the net appreciation in investments of \$3,603,623, which consists of realized gains or losses, and unrealized market value change of investments.

#### **NOTE 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

#### NOTE 4 - FAIR VALUE MEASUREMENTS (Continued)

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Self-directed brokerage accounts primarily consist of common stocks that are valued on the basis of readily determinable market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

#### NOTE 5 - INVESTMENTS AT CONTRACT VALUE

The Plan's investments include a guaranteed income fund which is a guaranteed investment contract designed to provide safety of principal, liquidity and a competitive rate of return. The Empower Guaranteed Income Fund is a group annuity guaranteed investment contract issued by Empower Annuity Insurance Company ("Empower"). Amounts contributed to the guaranteed investment contract are deposited in Empower's general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Payment obligations and the fulfillment of any guarantees specified in the contract are insurance claims supported by the full faith and credit worthiness of Empower. Empower periodically resets the interest rate credited on contract balances, subject to a minimum rate specified in the contract.

The Plan's investments also include a stable value fund. The Putnam Stable Value Fund 25 invests in a diversified portfolio including cash alternatives, traditional guaranteed investment contracts, and wrapped actively managed strategies which seeks to preserve principal and achieve high current income.

Because the guaranteed investment contract and stable value fund are fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to these investments. Contract value, as reported to the Plan by the Trustee, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would also limit the ability of the Plan to transact at contract value with the participants. There were no events that allowed Empower to terminate the contract with the Plan and settle at an amount different than contract value. If the Plan requests to withdrawal or liquidate its entire share of the Stable Value Fund, the trustee of the fund, Putnam Fiduciary Trust Company, LLC, reserves the right to apply a twelve-month put, or delay, in payment.

#### **NOTE 6 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of annual reporting compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in investments, dividends, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments and notes receivable from participants reflected on the schedule of assets (held at end of year).

#### **NOTE 7 - PLAN TERMINATION**

Although it is currently the intent of the Company to continue the Plan, the Company has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

#### **NOTE 8 - TAX STATUS**

The Plan agreement is a non-standardized pre-approved profit sharing plan that received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan was in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment instruments. Investment instruments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **NOTE 10 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under the DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Plan investments are managed by the Trustee. Transactions with the Trustee qualify as exempt party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. The administrative fees paid by the Plan include account fees which are charged to participants, and third-party fees for Plan administration. Investment management fees and expenses paid to parties-in-interest are reflected as a reduction in the investment returns of the individual investments held by the Plan and reflect party-in-interest transactions.

#### **NOTE 11 - PROHIBITED TRANSACTIONS**

During the years ended December 31, 2022 and 2023, the Plan failed to comply with the regulations concerning the timely remittance of participants' contributions to the trust containing assets for the Plan. Accordingly, participants' contributions, including loan repayments, totaling \$2,861 were remitted to the Plan late as described in the supplemental schedule (Schedule H, Part IV, Line 4(a) - Schedule of Delinquent Participant Contributions). The principal amount of the contributions were remitted to the Plan, however, in order to complete the correction, lost earnings must also be remitted by the Plan sponsor. During 2024, the Plan sponsor remitted the lost earnings for the remaining late contributions of \$536 and \$2,325 related to years ended December 31, 2022 and 2023, respectively.

#### **NOTE 12 - SUBSEQUENT EVENTS**

Subsequent events have been evaluated by the Plan through October 15, 2025, which is the date the financial statements were available to be issued.
