Note 1 – Description of Plan:

The following description of the Advance Trading, Inc. 401(k) Plan and ESOP (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Plan is sponsored by Advance Trading, Inc. (the “Plan Sponsor” or “Company” or “ATI”).

General

The Plan was established to provide retirement benefits for employees of the Company. Each eligible employee shall become a participant in the Plan on the enrollment date following the completion of one year of service in recognized employment. However, non-highly compensated employee participants are eligible to enter into Employee Deferral Agreements on their date of hire. The Plan is subject to the provisions of the Employer Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan contains an elective 401(k) deferred compensation component. Eligible participants may elect to contribute not less than 1% and up to 100% of their compensation, subject to limitations to the 401(k) components of the Plan. The Plan is subject to a non-discretionary, safe-harbor contribution of 3% of the participants’ eligible compensation. To be eligible for the safe-harbor contribution, the participant must have attained age 21 and completed one year of service. The Company’s contributions for the plan year ended December 31, 2024 were \$394,245.

Rollover contributions from certain qualified plans for eligible employees are permitted under the Plan. There were \$-0- of rollover contributions received by the Plan during the plan year ended December 31, 2024.

Qualified Nonelective Contributions are Company contributions made as the Company deems appropriate. When made, these contributions are allocated to non-highly compensated employees who have either completed 500 hours of service during the Plan Year or are in recognized employment on the last day of the Plan Year.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the employer’s contributions, and the earnings attributable to the participant’s account.

Vesting

Participants are immediately vested in their 401(k) contributions, which also include rollover contributions, plus actual earnings thereon, as well as employer contributions. Due to participants being fully, immediately vested in employer contributions, there are no forfeited accounts as of December 31, 2024.

Note 1 – Description of Plan – Continued:

Plan Termination

The Plan Sponsor intends to terminate the Plan subject to the provisions of ERISA. See Note 10 for further information.

Distributions to Participants

Amounts credited to an individual participant's account are distributed at termination of employment as a lump sum or in installments. Distributions may be deferred until the later of the participant's actual retirement date or the attainment of age 65, if the value of the distribution is not less than \$1,000. However, the Plan agreement stipulates that distributions must commence no later than April 1 of the year following the year in which the participant reaches the age of 73, unless the participant is not a 5% owner of the Company and is still employed by the Company.

In certain hardship situations, as described in the Plan agreement, participants may withdraw part of their account balances while actively employed, but such withdrawals are limited to their vested account balance.

Participant Notes Receivable

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest between 5.25% and 10.50%, which are commensurate with local prevailing rates and is pre-determined by the Plan's loan policy with interest rates based on the Wall Street Journal Prime Rate plus 2%, at the time the loan is originated. Principal and interest are paid ratably through monthly payroll deductions.

Participant notes receivable are measured at their unpaid principal balance. Any accrued but unpaid interest is included in participant contributions receivable. Interest income is recorded on the accrual basis and related fees are recorded in the note receivable and paid out of the participant's account when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the Plan Document.

Note 2 – Summary of Accounting Policies:

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Note 2 – Summary of Accounting Policies – Continued:

Investment Valuation and Income Recognition

The Plan's investments are held in a trust. The custodian values all investments at fair value except for the guaranteed investment contract, which is valued at contract value. The investment options consist of a guaranteed investment contract under a guaranteed benefit policy, pooled separate accounts of Principal Trust Company (Principal), mutual funds, and self-brokerage accounts.

The pooled separate accounts represent contributions invested in domestic and international common stocks, high-quality short-term debt securities, real estate, private market bonds and mortgages, and high-yield fixed-income securities that are slightly below investment grade, all of which are valued at fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net Assets Available for Benefits

Net assets available for benefits at both December 31, 2024 and 2023 included \$-0- allocated to the accounts of persons who, prior to that date, had withdrawn from participating in earnings and operations of the Plan.

Note 3 – Tax Status:

The Plan, originally adopted during 1984, amended and restated effective January 1, 2017, obtained its latest determination letter during 2017, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

The Plan Administrator and the Plan's Sponsor believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 4 – Investments:

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- a. Total investments as shown in the accompanying statements of net assets available for benefits of \$98,095,521 and \$85,329,432 as of December 31, 2024 and 2023, respectively.

- b. Total investment income (loss) as shown in the accompanying statement of changes in net assets available for benefits is \$12,608,946 for the year ended December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 5 – Guaranteed Investment Contract With Insurance Company:

The Plan has a benefit-responsive guaranteed investment contract with Principal Trust Company (“Principal”). Principal maintains the contributions in a general account that is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed by Principal.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract as of December 31, 2024 and 2023 was \$10,934,267 and \$9,412,412, respectively. The crediting interest rate is based on a formula agreed to with the issuer.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 6 – Fair Value Measurement:

The Plan has determined the fair value of certain assets and liabilities through application of ASC 820. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values. Financial assets and liabilities carried at fair value are classified and disclosed in one of the following three categories:

- Level 1 – Valuations for assets and liabilities traded in active exchange markets. Valuations are obtained from readily available pricing sources for market transactions involving identical assets or liabilities.
- Level 2 – Valuations for assets and liabilities traded in less active dealer or broker markets. Valuations are obtained from third party pricing services for identical or similar assets or liabilities.
- Level 3 – Valuations for assets and liabilities that are derived from other valuation methodologies, including option pricing models, discounted cash flow models and similar techniques, and not based on market exchange, dealer or broker traded transactions. Level 3 valuations incorporate certain assumptions and projections in determining the fair value assigned to such assets.

Transfers between fair value hierarchy levels are recognized at the beginning of the reporting period. There were no transfers between levels during 2024 and 2023.

The fair value of the employer securities is reflected in Level 3, and the valuation is based on the appraisal by an independent valuation firm. The value is based on the Company's operating results, history and nature of its business, conditions and trends in the economy, and the commodity contracts brokerage industry.

The pooled separate accounts are investments in sub-accounts of the Plan's group annuity contract with Principal Life Insurance Company and are valued at unit value, which is based on the aggregate fair value of the underlying assets in relation to the total number of units outstanding. Unit value is the equivalent of NAV, which is a practical expedient for estimating the fair values of these investments. Each of these investments may be redeemed daily with a notice period of one day. The Plan had no unfunded commitments as of December 31, 2024 and 2023. Accordingly, these investments have been excluded from the fair value hierarchy.

Mutual funds listed on a national market or exchange are valued at the last sales price, or if there is no sale and the market is still considered active at the last transaction price before year end. Self-directed brokerage accounts allow participants to develop their own portfolios of individual stocks, bonds, mutual funds and other investment options.

Note 7 – Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 8 – Related Party Transactions and Party-In-Interest Transactions:

Certain Plan investments are shares of mutual funds and pooled separate accounts managed by various fund companies. Fees incurred by the Plan for investment management services related to those investments are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor pays directly some fees related to the plan's operations.

Note 9 – Uncertain Tax Positions:

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely would not be sustained upon examination by applicable taxing authorities. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Tax years prior to 2021 are closed.

Note 10 – Subsequent Events:

On March 21, 2025, the Plan Sponsor finalized an agreement to sell essentially all of its assets in an Asset Purchase Agreement to another Introducing Broker company. The operations and employees of the Plan Sponsor will continue forward as a division of the new owner's operations in nearly the same manner as it has operated for forty-three years. The new Plan Sponsor intends to terminate the Plan subject to the provisions of ERISA by December 31, 2026.

Except for the event described above, no other events have occurred subsequent to December 31, 2024 which would require accrual or disclosure in these financial statements. This evaluation was made as of October 15, 2025, the date these financial statements were available to be issued.
