INDEPENDENT AUDITOR'S REPORT

Opinion

We have audited the financial statements of HPFFA Medical Trust 341, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in benefit obligations and net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the HPFFA Medical Trust 341 (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan and the related trust is a contributory defined benefit health and welfare plan, which was formed for the benefit of the active and retired members of the International Association of Fire Fighters Local No. 341 (the “Plan Administrator”), their dependents, or designated beneficiaries. The Plan and the trust, through which the benefits are provided, qualify as a voluntary employee beneficiary association under Section 501(c)(9) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All active members of the Plan Administrator are eligible to participate in the Plan, along with dependents as defined in the Plan agreement. In addition, any retired member of the Plan Administrator is eligible to participate if he or she was enrolled in the Plan prior to retirement. Coverage is effective on the first day of the month following the member’s enrollment date.

Benefits

The Plan provides supplemental health reimbursement benefits to members and their eligible dependents. Claims are processed by the claims administrator, but responsibility for payments is retained by the Plan. Benefits are available only as specifically described in the Plan agreement, up to the maximum amounts stated. Proof of loss in proper form (for certain benefits) is to be furnished to the Plan Administrator within or not later than one year following the date of service rendered or first day of disability for which the claim is made.

The Plan pays premiums to Humana CompBenefits Insurance Company for dental and vision benefits coverage and to Standard Insurance Company for accidental death and dismemberment benefits coverage. Disability income protection (short-term disability) benefits are also provided for active members only.

Contributions

The participant contributions into the Plan vary depending on the coverage elections and contribution amounts defined in the Plan agreement. Participant contribution amounts are deducted from the participant’s paycheck and remitted to the Plan Administrator either by the City of Houston (the “City”) or the Houston Firefighter’s Relief and Retirement Fund. The City contributed through June 2017, \$30 per month for each active firefighter enrolled in the Plan and ceased contributions in July 2017. The City’s contribution increased to \$50 per month for each firefighter enrolled in the Plan through a collective bargaining agreement that was entered into in July 2024 and that expires in June 2029. The City made a one-time contribution in 2019 outside of the contract. In May 2024, \$16,760,417 was awarded to the Plan through a settlement between the City and Houston Professional Fire Fighters’ Association, Local 341 for missed contributions from the City (arrears) of \$4,804,566, legal reimbursement of \$1,955,851, and \$10,000,000 for the development of a health and wellness center.

Funding Policy

Contributions to the Plan are invested by the Plan Administrator in marketable securities held in trust to enable the Plan to meet its obligations.

Termination of the Plan

Although it has not expressed any intention to do so, the Plan Administrator has the right under the Plan agreement to terminate the Plan, at any time, subject to the provisions of ERISA. Upon termination, no benefits shall be paid for any expense incurred or disability that begins after the date of termination.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator's Board of Directors determines the Plan's valuation policies and procedures. See Note 3 for discussion of fair value measurements. The sale or purchase of securities is recorded on the trade date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Receivables

Contributions and other receivables are presented in the statements of benefit obligations and net assets available for benefits net of any applicable allowance for credit losses. The allowance for credit losses is determined by analyzing the collectibility of contributions from the participants and the City. Receivables are written off against the allowance for credit losses when they are determined to be uncollectible. Based on review, plan management believes that no allowance for credit losses was necessary at December 31, 2024 or 2023.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses

The Plan pays administrative expenses that consist primarily of fees paid to third-party claims administrators, accountants, and investment advisors. These expenses are reported in the statement of changes in benefit obligations and net assets available for benefits as administrative expenses.

Concentrations of Credit Risk

Financial instruments that potentially subject the Plan to a concentration of credit risk consist primarily of cash deposits held by one financial institution. The Plan's exposure to loss is the amount of cash deposits in excess of the federally insured limits.

Claims Incurred But Not Reported

Claims incurred but not reported (IBNR) represent the estimate of claims incurred by participants, but not yet reported by the participants. Such amount is based on historical claims rates and amounts paid subsequent to year-end.

NOTE 3 - FAIR VALUE MEASUREMENTS

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Exchange Traded Funds: Valued based on quoted prices in an active market.

Level 2 - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Cash Equivalents: Valued based on amounts on deposit at the financial institution.

NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024 or 2023.

NOTE 4 - RELATED-PARTY TRANSACTIONS

The Plan reimburses the Plan Administrator for management and office services. Fees paid for these services amounted to \$3,875 for the year ended December 31, 2024. The amount due to the Plan Administrator at December 31, 2024 and 2023 was \$21,576 and \$16,622, respectively. In 2024, the Plan reimbursed the Plan Administrator \$1,955,851 for legal fees (See Note 1).

NOTE 5 - INCOME TAX STATUS

The trust established under the Plan to hold the Plan's net assets is qualified pursuant to Section 501(c)(9) of the IRC and, accordingly, the trust's net investment income is exempt from income taxes. The Plan Administrator obtained a favorable determination letter dated April 13, 1988 in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan and trust, as amended, continue to qualify and operate as designed. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

NOTE 5 - INCOME TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan uses various investment products. In general, such investments are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of benefit obligations and net assets available for benefits.


