Notes to Financial Statements

Note 1. Plan Description

The following description of the Anchor-Harvey Components, LLC Thrift Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan, established as of November 8, 1988, and covering eligible nonunion employees of Anchor-Harvey Components, LLC (the "Company"). Employees who are at least 18 years of age are eligible to participate in the Plan on their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: Each participant may elect to make before-tax and Roth contributions up to 50 percent of eligible compensation, as defined by the Plan. Participants who attain the age of 50 before the end of the Plan year are eligible to make catch-up contributions. All eligible employees are automatically enrolled in the Plan at a rate of 3 percent of eligible compensation 60 days after becoming eligible to participate unless the employee makes an affirmative election otherwise. Participants who are automatically enrolled in the Plan will have their deferral percentage rate increase by 1 percent on April 1 of each year following the year of their initial participation up to a maximum rate of 12 percent. Participants may also contribute amounts representing distributions from other qualified plans.

Annually, the Company makes a matching contribution on behalf of each participant who is employed on the last day of the plan year (subject to certain exceptions) equal to 50 percent of each participant's contributions for Plan year up to 6 percent of each participant's eligible compensation. At year end, the Company may also make, at its discretion, a profit sharing contribution to the Plan at year end. Participants must be employed as of the last day of the Plan year to be eligible for a profit sharing contribution. The Company did not make profit sharing contributions for the years ended December 31, 2024 or 2023.

Participant accounts: Each participant's account is credited with the participant's contributions and an allocation of Company contributions and plan earnings, and charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, death and disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Participants' vesting in the Company profit sharing contribution and Company matching contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after three years of credited service.

Payment of benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Participants (or their beneficiaries upon the death of the participant) may elect to receive their vested account balances as a single lump sum or partial withdrawals of at least \$5,000 and no more than one per year. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Note 1. Plan Description (Continued)

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. All loans are covered by demand notes and are repayable through payroll deductions.

Forfeitures: Participant forfeitures of Company profit sharing contributions and/or Company matching contributions are used to offset administrative expenses of the Plan, then to restore any prior account balances, then to reduce future Company matching contributions.

Transfers in due to merger: Effective July 1, 2024, the employees of New Dimensions Precision Machining LLC ("New Dimensions"), an adopting employer under the ADP TotalSource Retirement Savings Plan (the "ADP Plan"), became eligible to participate in the Plan and account balances in the amount of \$544,133 from employees of New Dimensions participating in the ADP Plan were merged into the Plan.

Effective December 31, 2024, the Northfield Industries, LLC 401(k) Profit Sharing Plan (the "Northfield Plan") was merged into the Plan. The account balances and notes receivable from participants in the Northfield Plan were merged into the Plan in the amounts of \$3,298,324 and \$137,438, respectively. Effective January 1, 2025, the participants formerly eligible to participate in the Northfield Plan became eligible to participate in the Plan.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Payment of benefits: Benefits are recorded when paid.

Notes receivable from participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Investment valuation and income recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

Note 2. Significant Accounting Policies (Continued)

Plan termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

Subsequent events: Plan management has evaluated subsequent events for recognition and disclosure through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include:

- Quoted prices for similar assets and liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in markets that are not active.
- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals).
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: The fair values of mutual funds are based upon the closing net asset value (NAV) per share of the mutual fund on the day of the valuation as reflected on a national securities exchange (Level 1 inputs).

Collective trust funds: Valued at the NAV per unit held by the Plan at year end as reported by the fund manager (Level 2 inputs). The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. Redemptions are permitted by participants on any business day and by the Company within 12 months' written notice. There are no unfunded commitments or liquidity restrictions related to the collective trust funds as of December 31, 2024 or 2023.

Note 4. Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income of notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company as of December 31, 2024 and 2023, and for the year ended December 31, 2024 and Reliance Trust Company as of December 31, 2024.

Note 5. Income Tax Status

The Internal Revenue Service (IRS) issued an opinion letter dated June 30, 2020, indicating that the prototype plan adopted by the Plan Sponsor as then designed was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original volume submitter document, Plan management believes that the Plan is currently being operated in accordance with the IRC. Therefore, they believe that the Plan was qualified and tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 6. Risks and Uncertainties

The Plan holds various investments. Investments are exposed to various risks, such as interest rate, market, liquidity, credit risks and global events. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Party-In-Interest Transactions

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, employees, and certain others. The Plan holds units of collective trust funds and mutual funds issued by Vanguard Fiduciary Trust Company, the trustee of the Plan, and The Vanguard Group, respectively. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Notes receivable from participants also qualify as party-in-interest transactions.

Investment management fees are paid by the Plan. Administrative fees paid to the trustee and other service providers qualify as party-in-interest transactions.
