Notes to Financial Statements

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of the Johnson Electric 401(k) Retirement Savings Plan (the "Plan") have been prepared on the accrual basis.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Benefit Payments

Benefit payments are recorded when paid.

Estimates

The preparation of financial statements in conformity with United States generally accepted accounting principles ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Expenses

Certain expenses and costs of the Plan were paid by Johnson Electric North America, Inc. (the "Company") and accordingly, are not reflected in the Plan's financial statements. Investment related expenses are included in net appreciation in fair value of investments.

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Related Party Transactions

The Plan makes loans to participants. These transactions qualify as party-in-interest transactions.

Several employees of the Company provide administrative services to the Plan. These services include plan oversight and day-to-day plan administration. The Plan is not charged by the Company for the services of the employees to the Plan.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan with an original effective date of January 1, 2001. All employees of the Company are immediately eligible for participation in the Plan, with the exception of employees covered by a collective bargaining agreement, leased employees, non-resident aliens, and temporary employees with less than 1,000 hours of service. The Plan is considered a "safe harbor" 401(k) plan with Charles Schwab Trust Bank serving as trustee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute between 1% and 75% of eligible compensation, as defined in the Plan Document, on either a pretax or after-tax (Roth) basis. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). For 2024, Section 414(v) of the Internal Revenue Code of 1986 allowed a maximum catch-up contribution of \$7,500.

The Plan has been modified to satisfy certain "safe harbor" rules and to comply with the qualified automatic contribution arrangement ("QACA") provisions of the Pension Protection Act of 2006 ("PPA"), which eliminate the need for most types of nondiscrimination testing. Under the safe harbor QACA approach, the Company will match elective deferrals made by participants 100% up to 1% of a participant's eligible compensation as well as 50% that is over 1% not to exceed 6% of a participant's eligible compensation. The Company makes a true-up matching contribution to the Plan to ensure that participants are receiving a match based on the employee contributions for the entire year.

Notes to Financial Statements (Continued)

NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

Contributions (Continued)

The Plan includes an automatic enrollment feature. Initially, 3% of a participant's eligible compensation is automatically deducted and contributed to the Plan, unless the participant elects a different percentage. In addition, a participant's contribution rate is automatically increased each year after the automatic deferral date, up to 6% of eligible compensation.

Participants designate the percentage of their total contribution to be invested in any of the Plan's investment funds. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year.

Rollover Contributions

Participants may roll over their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

Participant Accounts

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings. The pro-rata allocation is based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's QACA "safe harbor" match portion of their accounts, plus actual earnings thereon, is based on years of continuous service. Participants become 100% vested after two years. Employer contributions prior to the adoption of safe harbor provisions are subject to other vesting requirements. Non-vested portions of participant accounts that are forfeited upon payment of benefits are retained in the Plan and are used to pay Plan expenses and may also be used to reduce future employer contributions. During 2024, the Company used \$62,710 to reduce employer contributions and \$30,696 to pay Plan expenses. There was an unallocated forfeiture balance of \$132,346 and \$82,137 at December 31, 2024 and 2023, respectively.

NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

Payment of Benefits

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed under two options. Participants may elect to receive their benefit in installments, a partial distribution, or a lump sum cash payment.

In-service distributions are permissible from the Plan for participants that have attained the age of 59 1/2. Withdrawals from a participants' rollover portion of their account is permitted at any time.

In conditions of "financial hardship" a participant may apply to the plan administrator for approval to withdraw that portion of his or her 401(k) retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code ("IRC").

Notes Receivable from Participants

Notes receivable from participants are available on amounts in the participant's account. The minimum loan amount is \$1,000 and the maximum loan amount is the lesser of 50% of the participants vested account balance or \$50,000. The vested participant account balance will be used as collateral for any loan. All loans shall bear a reasonable rate of interest as determined by the plan administrator. All loans must be repaid within five years except in the case of a loan for the purpose of acquiring a home. Participants may only have one loan outstanding at any given time.

NOTE 3 INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan maintains an investment contract in a common collective trust, Putnam Stable Value Fund (the "Fund"). The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Fund is included in the financial statements at fair value. Withdrawals from this account for other than payment of benefits may be subject to a market value adjustment. The investment contracts held in the common collective trust are reported in the accompanying financial statements at fair value.

The existence of certain conditions can limit the fund's ability to transact at fair value with the issuers of its investment contracts. Specifically, any event outside the normal operation of the trust which causes a withdrawal from an investment contract may result in a negative market value adjustment with respect to such withdrawal. Examples of such events include, but are not limited to, partial or complete legal termination of the trust, tax disqualification of the trust, and transfers of assets from the fund directly to a competing investment option. As of December 31, 2023, the occurrence of an event outside the normal operation of the fund which would cause a withdrawal from an investment contract is not considered to be probable.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued based on information reported by the investment advisor using the audited financial statements of the common collective trust at year end. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
