**Note 1  
Description of the Plan**

---

The following description of the Desert Ready Mix, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Desert Ready Mix, LLC (the “Company” or “Sponsor”) adopted the Desert Ready Mix, LLC 401(k) Plan effective January 1, 2015. The Company is majority-owned by Sunshine Concrete & Materials, Inc.

**Eligibility**

The Plan covers substantially all employees of the Company and Desert Aggregates, LLC (an affiliated entity) who have completed three (3) months of service, and have attained the age of twenty-one (21).

**Contributions**

Participants are permitted to make voluntary deferral contributions to the Plan under the provisions of Internal Revenue Code Section 401(k). Participants may contribute an amount of eligible pre-tax or after-tax Roth annual compensation not to exceed limits established by the Internal Revenue Code, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Company makes matching contributions equal to 100% of the first 3% of eligible compensation that employees contribute as an elective deferral each pay period. The Company may also, in its sole discretion, make nonelective contributions to the Plan on behalf of eligible participants, although the Company is not required to do so.

**Participant Accounts**

Each participant’s account is credited with the participant’s deferral contributions and the Company’s matching or nonelective contributions, as well as allocations of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant’s earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

**Vesting**

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company’s contribution portion of the participant’s assets is based on years of continuous service, determined by hours worked. For matching contributions, a participant becomes 100% vested after five years of credited service, at a rate of 20% per year beginning after the first year of credited service. For nonelective contributions, a participant becomes 100% vested after six years of credited service, at a rate of 20% per year beginning after the second year of credited service.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is the prime rate, plus two percentage points. Principal and interest is paid ratably through payroll deductions. Each participant may only have one loan outstanding at a time.

**Payment of Benefits**

On termination of service for reasons other than death, a participant has the election to receive the value of the vested interest in the participant's account as either a lump sum distribution or annuity payments over the life expectancy of the participant. On termination of service due to death, distributions generally must be completed within five years, unless an election is made by the beneficiary to receive annuity payments over the life expectancy of the beneficiary.

**Forfeitures**

Any forfeitures of employer contributions may be used to reduce employer contributions for the Plan year in which the forfeitures occur, to pay Plan expenses, and/or to restore previously forfeited account balances as provided for under the Plan. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$18,671 and \$26,186, respectively. For the year ended December 31, 2024, employer contributions were reduced by \$46,792 from forfeited non-vested accounts.

**Note 2  
Summary of Significant Accounting Policies and Use of Estimates**

---

**Basis of Accounting**

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP"), using the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions Receivable**

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

---

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. As of December 31, 2024 and 2023, the rate of interest on outstanding loans ranged between 5.25% - 10.50% with various maturities through September 2029. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent accounts are treated as a deemed distribution when a distributable event occurs (i.e. termination of employment).

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions as of December 31, 2024 to the applicable participants prior to March 15, 2025.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Note 3**

**Plan Termination**

---

Although it has not expressed an intent to do so, the Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, participants would become 100% vested in their employer contributions.

**Note 4  
Tax Status**

---

The IRS has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 5  
Fair Value Measurements**

---

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Registered Investment Companies (Mutual Funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
