NOTE 1 – PLAN DESCRIPTION

The following description of the Flex Film Inc. Rashmi 401k Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Flex Film Inc. Rashmi 401k Plan is a defined contribution plan covering substantially all employees of Flex Films (USA) Inc. (the “Company”) who have reached the age of 19 and completed 60 days of service to the Company. Employees are automatically enrolled at a 2% deferral rate upon becoming eligible to participate in the Plan and may elect to change or discontinue deferrals at any time. The Plan also provides that each participants’ deferral rate will increase 1% annually until reaching the maximum of 4% unless elected otherwise. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Reliance Trust Company served as the trustee of the plan as of December 31, 2023 and for the period from January 1, 2024 through November 30, 2024. Effective December 1, 2024, the trustee of the plan is ADP Retirement Trust Services, LLC, who also served as the Plan’s custodian and recordkeeper for both years.

Contributions: Participants may contribute up to the maximum allowable amount of pretax annual compensation as determined by the Federal Government each year, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Beginning in June 2022 the Company implemented a match of up to 2% of employee contributions. Participants may direct the investment of the contributions into various investment options offered by the Plan. The Plan currently offers a number of mutual funds and collective trusts as investment options for participants.

Participant Accounts: Each participant’s account is credited with the participant’s contribution, the Company’s contribution and Plan earnings, and charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are immediately vested in their voluntary contributions, plus earnings thereon. Graded vesting in the Company’s contribution portion of their accounts, plus earnings thereon, is based on years of continuous service. A participant is 20% vested after two years of service and is fully vested after three years of continuous service. In addition, if a participant incurs a severance from employment as a result of death or disability or attainment of normal retirement age, that participant will automatically become 100% vested

Participant Loans: The Plan does not allow loans to participants.

Forfeited Accounts: Upon participant termination, the nonvested portion of the participant’s account, as defined by the Plan, represents a forfeiture. Forfeited accounts are used to pay Plan expenses and employer matching contributions. Forfeited amounts in plan year 2024 were \$12,797. Forfeitures available at December 31, 2024 and 2023 were \$0.

Payment of Benefits: On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or, if permitted under the Plan at the time of distribution, an alternative form of payment. For termination of services for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum.

Administrative and Investment Management Expenses: Trustee fee and investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by the Company.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions: Refunds of excess participant deferral contribution is required to satisfy the relevant nondiscrimination provisions of the Plan. Such refunds are accrued as a liability and reduction in contributions in the Plan year in which excess deferrals were made to the Plan.

Estimates in the Financial Statements: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Payments of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan provides for various investment options. The investments are exposed to various risks, such as interest rate, liquidity, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balances.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 15, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the former trustee of the Plan) as of December 31, 2023 and for the period from January 1, 2024 through November 30, 2024, and ADP Retirement Trust Services, LLC (the trustee of the Plan) as of December 31, 2024 and for the period from December 1, 2024 through December 31, 2024.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchange (Level 1 inputs).

Collective Trust: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The fund provides for daily redemptions by the Plan at reported net asset value per share, with no advance notification requirements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – INCOME TAX STATUS

The Internal Revenue Service (“IRS”) issued an opinion letter dated October 6, 2020, that the pre-approved plan qualifies under Section 401(a) of the Internal Revenue Code (“IRC”) and is, therefore, not subject to tax under present income tax law. No determination letter specifically for the Plan has been requested. Although the Plan has been amended since receiving the opinion letter, Plan management believes that the Plan is designed and being operated in compliance with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Reliance Trust Company served as the Plan’s trustee through November 30, 2024. Effective December 1, 2024, ADP Retirement Trust Services, LLC became the Plan’s trustee. ADP Retirement Trust Services, LLC served as, record-keeper and the custodian of the Plan for both 2024 and 2023. Each of these organizations qualify as a party-in-interest.

NOTE 7 – RIGHTS UPON PLAN TERMINATION

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
