#### **1. DESCRIPTION OF PLAN**

The following description of Aequor 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

##### ***General and Eligibility***

The Plan is a defined contribution plan covering all employees of Aequor Technologies, LLC (the “Plan Sponsor”) and related entities identified in the adoption agreement. The Plan was established on January 1, 2007 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Employees can begin participating under the Plan once they have satisfied the eligibility requirements and reached their entry date, provided they are not excluded employees. The employees who are excluded are:

- Union employees whose employment is governed by a collective bargaining agreement
- Certain nonresident aliens who have no earned income from sources within the United States
- Residents of Puerto Rico

Employees are eligible to participate in the Plan for purposes of making elective deferrals as of the date the requirements are met, which is the entry date. Employees are eligible to participate in the Plan for purposes of nonelective contributions when they have satisfied the following eligibility conditions and reached the entry date.

- Attaining of age 21
- 12 consecutive month period from the eligible employee’s employment commencement date and during which at least 1,000 hours of service are completed.

##### ***Participant Contributions***

Participants of the Plan can contribute on a pre-tax basis a percentage of their compensation up to the maximum amount allowed under the Internal Revenue Code (“IRC”), which is \$23,000 in 2024. Participants who are at least age 50 or will attain age 50 before the end of a calendar year may elect to defer additional amounts (called “catch-up contributions”) to the Plan for that year.

### **NOTES TO FINANCIAL STATEMENTS - CONTINUED**

#### **1. DESCRIPTION OF PLAN - CONTINUED**

##### ***Participant Contributions - Continued***

The additional amounts may be deferred regardless of any other limitations on the amount that the participants may defer to the Plan. The maximum catch-up contribution for 2024 is \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contribution). Rollover contributions amounted to \$95,690 in 2024. Participants direct the investment of their contribution into various investment options offered by the Plan. The Plan currently offers various mutual funds and fixed income accounts as investment options for participants.

Effective as of September 1, 2020, the Plan was amended to include a traditional automatic contribution arrangement. The provisions apply to employees who become participants on or after September 1, 2020 and existing participants who on the effective date of the automatic deferral provisions are not deferring any amount and who did not make a timely affirmative election to not contribute elective deferrals in connection with the implementation of the traditional Automatic Contribution Agreement (“ACA”), Eligible Automatic Contribution Agreement (“EACA”) or Qualified Automatic Contribution Agreement (“QACA”), as applicable (regardless of any prior affirmative election to not contribute elective deferrals). Unless the participant makes an affirmative election, the Plan Sponsor will withhold 2% of compensation for each payroll period with no escalation of automatic deferral amount.

##### ***Employer Contributions***

At the employer’s discretion, the employer can make a nonelective contribution to the Plan to participants who are at least employed for one year. Employer’s share of the nonelective contribution depends on the participant’s compensation for the year. There are no employer discretionary contributions in 2024.

##### ***Participant Accounts***

Each participant’s account is credited with the participant’s contribution and an allocation of the employer discretionary contributions and plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants direct the investment of their employee contributions and share of employer contributions into investment options offered by the Plan.

##### ***Vesting***

Participants are fully vested in their employee contributions plus actual earnings thereon. Vesting in employer contributions and earnings thereon is based on years of service and is determined as follows:

##### *Notes Receivable from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance reduced by any outstanding loan balance during the one-year period ending on the day before the new loan is made. The loan is secured by the balance in the participant's account. Generally, the term of the loan may not exceed five years unless the loan is for purchase of participant's primary residence, and the loan bears a reasonable rate of interest. Loans currently outstanding bear interest at rates ranging from 4.25% to 9.50%. The loan must be repaid through payroll deduction.

##### *Benefit Distributions*

Benefit distributions are based on the vested interest of the participants' account upon retirement, death, disability, or termination of employment. The Plan also allows for hardship distributions, subject to certain Plan provisions.

##### *Forfeited Accounts*

At December 31, 2024 and 2023, the balance of the forfeited non-vested accounts is \$0. Forfeited non-vested accounts will be used to pay Plan expenses and reduce any employer contribution. In 2024, Plan expenses paid from the forfeited non-vested accounts amounted to \$290.

##### *Recent Regulatory Event*

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement ("SECURE") 2.0 Act of 2022 was signed into law as part of the Consolidated Appropriations Act of 2023. The SECURE 2.0 Act of 2022 builds on the SECURE Act of 2019 which revised existing rules around retirement saving. The SECURE 2.0 Act of 2022 contains dozens of new retirement-related provisions with effective dates beginning January 1, 2024 and beyond. SECURE 2.0 is intended to expand and increase retirement savings and to simplify and clarify many complex existing retirement plan rules. However, there was no impact to the Plan's 2024 or 2023 financial statements. See Note 2 for subsequent event disclosure information related to provisions adopted in 2025.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Plan Sponsor and are, therefore, excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Administrative expenses of the Plan are allocated to participant accounts.

##### ***Subsequent Events***

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan elected to adopt the following provisions of the SECURE 2.0 Act in actual operation (see Note 1): a) increase in dollar threshold for catch up contributions of \$10,000, or 150% of the base catch up amount, and b) increased catch-up limits for participants ages 60, 61, 62 and 63, effective January 1, 2025.

#### **3. CERTIFIED INFORMATION (UNAUDITED)**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company ("RTC"), the trustee of the Plan, has certified to the completeness and accuracy of all the investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

#### **4. INVESTMENTS AND FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. The Plan Sponsor determines the Plan's valuation policies. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if level 1 or level 2 inputs were not available. There are no Plan assets requiring the use of level 2 and level 3 inputs for the periods presented.

#### 4. INVESTMENTS AND FAIR VALUE MEASUREMENTS - CONTINUED

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The fair value of participation units held in the common collective trust (“CCT”) is based on the NAV as reported by the manager of the collective trust fund and Invesco Trust Company, and as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV of the CCT is based on the fair value of the underlying investments held by the fund less their liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The Plan’s CCT invests in assets (typically fixed-income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements), enters into “wrap” contracts issued by third-parties, and invests in cash equivalents represented by shares in money market funds. The CCT seeks to minimize the exposure of the fund to wrap credit risk through, among other means, diversification of the wrap contracts across an approved group of issuers. The portfolio’s ability to receive amounts due pursuant to this contract is dependent upon the issuer’s ability to meet its financial obligations. The CCT provides for daily redemptions by the Plan at reported NAV, with no advance notice requirements.

#### **6. TAX STATUS**

On December 1, 2019, the Plan has adopted a Prototype Non-standardized Profit Sharing Plan with CODA sponsored by ADP. On July 8, 2014, the Internal Revenue Service (“IRS”) stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC and, therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

#### **7. PARTY IN INTEREST TRANSACTIONS**

The Plan’s trustee is RTC and the Plan’s custodian and recordkeeper is ADP. Accordingly, these transactions qualify as party-in-interest transactions. Recordkeeper fees directly paid by the Plan to ADP for the year ended December 31, 2024 amounted to \$35,896.

Certain employees of the Plan Sponsor, who may also be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

#### **8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
