INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Hallman Automotive Group 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1. Description of the Plan

General

The following description of the Hallman Automotive Group 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions. The Plan covers all eligible employees of Dave Hallman Chevrolet, Inc. (Plan Sponsor) and the related entities, as defined below, over the age of eighteen who have two months of service. Participants can defer amounts into the Plan up to limits imposed by the Internal Revenue Code (IRC).

Participating employers in the Plan are as follows:

- Champion Ford Sales, Inc.
- Champion Ford Edinboro, Inc.
- Dave Hallman Hyundai, Inc.

Additional information about the Plan agreement, including contributions, vesting, benefit payments, forfeitures, and investment allocation provisions is contained in the Summary Plan Description. Copies of this booklet are available from the Plan Administrator.

Participant Contributions

Participants may contribute any amount of pre-tax contributions up to the maximum percentage or dollar amount as permissible by the Internal Revenue Service (IRS). Contributions from Plan participants are recorded in the year in which participant compensation is earned. Additionally, eligible participants may rollover retirement benefits from other qualified plans. New employees are automatically enrolled in the Plan with a deferral rate of 3%, unless they elect otherwise. Additionally, participants are permitted to make Roth contributions to the Plan.

During 2024 and 2023, the Plan Sponsor failed to remit various participant elective deferral contributions to the plan in a timely manner as required by the Department of Labor (DOL). These delinquent contributions totaled \$44,305 and \$812, respectively. The Plan Sponsor is in the process of remitting lost earnings to participants resulting from these untimely remitted deferrals for 2024 and 2023. The lost earnings calculation is in the process of being finalized by the Plan's recordkeeper. The correction of this failure will be made under the Internal Revenue Service (IRS) Employee Plans Compliance Resolution System (EPCRS) Self-Correction Program (SCP). The Plan Sponsor plans to correct the 2024 and 2023 delinquent contributions during 2025 under the IRS EPCRS SCP.

Hallman Automotive Group 401(k) Retirement Savings Plan Notes to Financial Statements – (continued)

1. Description of the Plan (continued)

The Plan Sponsor has the right to make discretionary contributions to the Plan which shall be allocated to the account of each eligible employee in proportion to his or her compensation as a percentage of the total compensation of all eligible employees. The Plan Sponsor may also make a flexible discretionary matching contribution. The Plan Sponsor may determine the allocation formula, which includes the rate or amount, limit on deferrals or employee contributions subject to match, and per participant allocation amounts. Effective January 1, 2023, the Plan Sponsor may also make a discretionary profit-sharing contribution to eligible employees if they are employed on the last day of the plan year. The Plan Sponsor made no discretionary contributions in 2024 or 2023.

Participant Accounts

Each participant's account is credited with (a) the participant's contribution, (b) the participant's share of Plan Sponsor contributions (if any), and (c) an allocation of investment income, and reduced by participant withdrawals.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service. Participants become fully vested upon their death, if they become totally and permanently disabled, or meet the early retirement requirements of five years of credited service and age 55. Any forfeited balances are held in a separate account and may first be used to reduce any Plan Sponsor contributions. The Plan Sponsor may decide in its discretion regarding the use of any remaining forfeitures.

Notes Receivable from Participants

Eligible participants have the ability to borrow from \$1,000 to \$50,000, up to a maximum of 50% of their vested account balance. All loans accrue interest at a reasonable rate at the time of the loan. Eligible participants can have one residential loan for purchase of the participant's primary residence and one general purpose loan. Loan refinancing is permitted. A general purpose loan should have repayment terms of less than five years.

Withdrawals and Benefit Payments

Upon termination of service, a participant is entitled to the vested portion of their account. Payments are able to be made in a lump sum, substantially equal installment payments, and partial withdrawals. Under certain circumstances, the Plan permits participants to take hardship withdrawals. Participants are also able to take in-service withdrawals prior to termination of service, provided the participant has attained age 59 ½. Benefits are recorded when paid.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

1. Description of the Plan (continued)

Administrative Expenses

During 2024 and 2023, certain fiduciary and Plan administrative expenses were paid by the Plan. Legal and accounting services, which were not material, are provided at the expense of the Plan Sponsor, while all other services are provided at the expense of the Plan.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to permanently discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Securities Act of 1974 (ERISA). In the event the Plan terminates, participants will become fully vested in their accounts.

2. Significant Accounting Policies

Basis of Accounting

The accounting records and financial statements of the Plan are maintained on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of the financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect amounts reported in the financial statements and related disclosures. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Asset values are based upon the latest quoted prices as provided by the custodian. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Investments are valued daily.

3. Information Prepared and Certified by the Custodian and former Trustee

For the years ended December 31, 2024 and 2023, the Plan Administrator elected the method of compliance permitted under ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL Rules and regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under this election, all investment information disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net realized and unrealized appreciation in fair value of investments, interest and dividend income, and administrative expenses for the years ended December 31, 2024 and 2023, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by The Standard Insurance Company and Minnesota Life Insurance Company, the current custodians of the Plan as of December 31, 2024 and 2023.

The Standard Insurance Company certified the completeness and accuracy of the notes receivable from participants as of and for the years ended December 31, 2024 and 2023, except for loans deemed as distributions in a previous year for the year ended December 31, 2023. The financial statements have been adjusted to reflect the inclusion of such deemed loans in the statements of net assets available for benefit.

4. Fair Value Measurements

Investments are recorded at estimated fair value, in accordance with FASB ASC's *Fair Value Measurements and Disclosures* topic. This topic establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under this topic are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

4. Fair Value Measurements (continued)

Pooled separate accounts: Valued daily based on the market value of the underlying net assets in each separate account. The majority of the underlying net assets have observable Level 1 and/or 2 quoted pricing inputs which are used to determine the unit value of the pooled separate accounts which is not publicly quoted. These pooled separate accounts are valued based on the NAV of the units held by the Plan as of year-end. The redemption frequency of each of these pooled separate accounts is daily, and there are no redemption restrictions. There are no unfunded commitments related to the Plan’s investment in pooled separate accounts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments Measured Using NAV per Share Practical Expedient

5. Group Annuity Contract

The Plan holds a guaranteed interest account with Minnesota Life Insurance Company. The account meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The account is a traditional investment contract under which the Plan owns only the contract itself. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

Hallman Automotive Group 401(k) Retirement Savings Plan Notes to Financial Statements – (continued)

5. Group Annuity Contract (continued)

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is declared and changed from time to time by Minnesota Life in accordance with its usual practices for contracts of this class, but shall not be less than 0.25%. The average interest rate as of December 31, 2024 and 2023 was 2.45% and 2.20%, respectively.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the Plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

No transfers into this account may be made by participants for 90 days following a transfer out of this fund.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material representation or (4) a material amendment to the agreements without the consent of the issuer.

6. Income Tax Status

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by Minnesota Life Insurance Company who has received an opinion letter from the IRS dated June 30, 2020 as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by the Plan. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Plan management believes the Plan is operating in compliance with the Code.

During 2024 and 2023, the Plan Sponsor failed to remit various participant elective deferral contributions to the plan in a timely manner as required by the Department of Labor (DOL). These delinquent contributions totaled \$44,305 and \$812, respectively. The Plan Sponsor is in the process of remitting lost earnings to participants resulting from these untimely remitted deferrals for the 2024 and 2023 delinquent contributions. The lost earnings calculation is in the process of being finalized by the Plan's recordkeeper. The correction of this failure will be made under the IRS EPCRS SCP. The Plan's Administrator believes the necessary steps are in place to properly correct the error and maintain the Plan's qualified status to operate in compliance with the IRC.

For the year ended December 31, 2024, there was a missed deferral opportunity for a certain participant. The Plan Sponsor will correct this matter under the IRS EPCRS SCP. The Plan Sponsor believes the necessary steps will be taken to maintain the Plan's qualified status.

6. Income Tax Status (continued)

The FASB issued guidance on accounting for uncertainty in income taxes. Management evaluated the Plan’s tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan administrator believes the Plan is operating in compliance with the IRC and has taken the necessary steps to maintain the Plan’s qualified status. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Sponsor believes it is no longer subject to income tax examinations for years prior to 2021.

7. Related Party Transactions

Plan investments are managed by and in the custody of The Standard Insurance Company and Minnesota Life Insurance Company and, therefore, these transactions qualify as party-in-interest transactions. The Plan also issues loans to participants, which are secured by the balances in the respective participant accounts.

Fees paid by the Plan for the investment management services amounted to \$26,120 and \$25,044 in 2024 and 2023, respectively. The Plan believes these fees are not prohibited as they represent payments for reasonable compensation for the operation of the Plan.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
