## INDEPENDENT AUDITOR'S REPORT

#### 1. Plan Description and Summary of Significant Accounting Policies

---

The following description of the Taher, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General Information

The Plan is a defined contribution plan covering substantially all employees (other than nonresident aliens) of Taher, Inc. and related entities (the Company) who have one year of service and have attained age 21. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

##### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

##### Administration

The Plan is administered by the Company and advised by an external third-party consultant. The Trustee of the Plan's assets is Reliance Trust Company. The Trustee executes transactions based upon direction from the Plan's administrator and the Plan's participants.

##### Contributions

Each year, participants may contribute up to the maximum allowable not to exceed the limits of the Internal Revenue Code (IRC), as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are also eligible to make catch-up contributions in any amount up to the limits prescribed by law. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their account into various investment options offered by the Plan.

The Company may contribute to the Plan discretionary matching and/or non-elective contributions. Matching contributions, if any, are determined annually and may be a percentage of compensation or a fixed dollar amount. In addition, each year the Company may contribute a non-elective contribution to the Plan. The Company's non-elective contribution, if any, is allocated to participants eligible to share in the contribution based upon a percentage of each participant's compensation. Participants direct the investment of their matching and/or non-elective contributions into various investment options offered by the Plan.

#### 1. Plan Description and Summary of Significant Accounting Policies (Continued)

---

##### Participant Accounts

Each participant's account is credited with the participant elective deferrals, discretionary matching and non-elective contributions (if any) and an allocation of Plan earnings and expenses. Allocations of Plan earnings are based on the valuation of the investments (participant-directed) held in each participant's account. Participants' accounts are valued on a daily basis. The benefit the participant is entitled to is the benefit that can be provided from the participant's account.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, reduced by the participant's highest outstanding loan balance in the previous twelve months and the existing loan balance. Loan terms may be up to five years for general purpose loans or up to thirty years for loans for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a fixed rate of 1% over the Wall Street Journal Prime rate of interest at the time of loan. Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the plan document. Interest rates on loans outstanding as of December 31, 2024 ranged from 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions.

##### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is fully vested in their account after 5 years of service, upon reaching age 65, or upon death or upon permanent disability. Termination of employment before any of the above occurs activates the following vesting schedule for the profit sharing and matching portions of their accounts:

##### Forfeited Accounts

Terminated participants forfeit their non-vested balance upon the earlier of the receipt of their vested benefits or after incurring five consecutive one-year breaks in service. Forfeitures are used by the employer to reduce discretionary contributions, or to pay certain plan expenses. There were forfeitures of \$15,935 and \$92 during the years ended December 31, 2024 and 2023, respectively. Forfeitures in the amount of \$9,082 and \$16,276 were used to reduce employer discretionary contributions during the year ended December 31, 2024 and 2023.

As of December 31, 2024 and 2023, forfeited non-vested amounts totaling \$7,276 and \$7,372, respectively, were available to reduce future employer contributions or pay plan expenses.

##### Payment of Benefits

Upon termination of employment, death, disability, or reaching normal retirement age (65), participants or their beneficiary(ies), where applicable, may receive the value of the accrued vested benefit in the form of a lump sum payment; or if the balance exceeds \$1,000, may elect to defer the distribution in accordance with Plan guidelines. If the participants' vested account balance is less than \$1,000, the Plan will distribute the participant's vested account balance in a lump-sum payment with or without the participant's consent.

The Plan allows for hardship withdrawals from the employee elective deferral portion of the participant's account. The Plan also allows in-service distributions to participants who have attained the age of 59.5. The distributions may be made from all accounts which are fully vested. In-service distributions of rollover account balances are allowed. Benefit payments are recorded upon distribution to participants.

##### Investment Valuation and Income Recognition

Investments are reported at fair value (which is equal to contract value for investment contracts in the collective trust fund). Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

All purchases and sales of securities have been recorded on a trade-date basis. Income is recorded as earned. The increase or decrease in the fair value of investments represents the net difference between the current value of securities held at the beginning of the year or cost of securities purchased during the year and the current value of securities held at the end of the year.

##### Administrative Expenses

The Plan or Company pays certain administrative expenses on behalf of the Plan. Distribution processing fees are deducted from the benefits paid to participants and are shown as plan expenses.

##### Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

##### Subsequent Events

In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2024 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.

#### 2. Financial Information Certified by the Trustee

---

The Administrator of the Plan appointed Reliance Trust Company as Trustee of the Plan's assets. Reliance Trust Company has supplied the Plan Administrator with certifications as to the completeness and accuracy of Plan investments aggregating \$14,783,293 and \$12,978,535 as of December 31, 2024 and 2023, respectively, and the related investment income of \$1,968,388 and \$1,754,105 for the years ended December 31, 2024 and 2023, respectively, which includes interest on notes receivable from participants. The notes receivable from participants of \$247,655 and \$206,267, as of December 31, 2024 and 2023, respectively, were also certified as complete and accurate by the Trustee. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedule based on the certifications from Reliance Trust Company.

Under the terms of the trustee agreement, the Trustee manages investment funds on behalf of the Plan. The Trustee has been granted non-discretionary authority concerning the purchases and sales of the investments of the investment funds.

---

#### 3. Fair Value Measurements

---

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Observable market-based inputs or unobservable inputs that are corroborated by market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common/collective trust:** The collective trust fund is valued at contract value which is determined by the net asset value of units of a bank collective trust. The net asset value, as provided by the trustee, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants or their beneficiaries are entitled to a distribution of 100% of their account balances in all funds.

---

#### 5. Plan Tax Status

---

The Company adopted a non-standardized 401(k) Profit Sharing Plan and Trust which received a favorable opinion letter from the Internal Revenue Service which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The non-standardized 401(k) Profit Sharing Plan and Trust has been amended since receiving its determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC

Plan management evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of December 31, 2024, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan's income tax returns are subject to examination by the appropriate regulatory authorities as of December 31, 2024, and the Plan's federal tax returns generally remain open for three years.

---

#### 6. Risk and Uncertainties

---

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### 7. Party-in-interest Transactions

---

Transactions resulting in Plan assets being transferred to or used by a related party are considered prohibited transactions under ERISA unless a specific exemption exists. Reliance Trust Company is the trustee of a portion of the Plan's assets; therefore, the transactions qualify as party-in-interest transactions and are indicated as such on the supplemental Schedule of Assets Held at End of Year. However, the transactions are not considered prohibited transactions as ERISA regulations provide for a specific exemption for such transactions.

The Plan issues loans to participants, which are secured by the participant account balances. These qualify as party-in-interest transactions but are permitted under ERISA regulations.

Additionally, certain employees of the Company provide certain accounting and administrative services to the Plan for which no fee is charged. These transactions are also permitted under ERISA regulations.

#### 8. Concentration Risk

---

Individual investments representing 20% or more of the total investments subject the Plan to potential concentration risk. As of December 31, 2024 and 2023, investments over the 20% threshold were as follows:
