Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of *Southwest Georgia Community Action Council, Inc. 401(k) Profit Sharing Plan* (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years December 31, 2024 and 2023, stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirement of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.



Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events considered in aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United State of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of Assets Held for Investment Purposes at End of Year is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE A - Description of Plan

The following description of the ***Southwest Georgia Community Action Council, Inc. 401(k) Profit Sharing Plan (the Plan)*** provides only general information. The Plan is administered by selected individuals of the Plan Sponsor (The Plan's Committee). They are responsible for oversight of the Plan including investment options and monitoring performance. These individuals report to the Board of Directors. They are appointed by the Plan Sponsor or Southwest Georgia Community Action Council, Inc. (the Organization), a Georgia not-for-profit corporation with its principal office in Moultrie, Georgia, and its successors, which adopted the Plan. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

1. **General** - The Organization established the Plan to provide employees with a systematic means of savings and investing for the future. The Plan is a defined contribution plan covering all full-time employees of the Company. There is no minimum age requirement. The minimum service requirement is 3 months of eligibility service (not to exceed 24 months) whether or not completed consecutively. Deferrals begin on the first day of the month subsequent to enrollment. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
2. **Contributions** - Each year, participants may contribute a portion of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and an insurance investment contract as investment options for participants. Lincoln Financial Group is the custodian receiving contributions.

Each pay period during the Plan year, the Organization will make a matching contribution equal to 4% of base compensation that a participant contributes to the Plan. The maximum contribution amount eligible to be matched is 4% of eligible compensation. The Organization's contributions are allocated to participants' accounts on each monthly valuation date. Total participant contributions in any calendar year are limited to the applicable limit under the Internal Revenue Code.

3. **Participant Accounts** - Each participant's account is credited with the participant's contribution and Organization's matching contribution, as well as allocations of Plan earnings/losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. **Vesting** - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Organization's matching contribution portion of their accounts is as follows:
 1. (a) less than one year service, 0% vested, (b) 1 year service, 20% vested, (c) 2 years service, 40% vested, (d) 3 years service, 60% vested (e) 4 years service, 80% vested, (f) 5 years service, 100% vested.

5. **Payment of Benefits** - Participants entitled to termination payments receive payment in accordance with the plan document. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a determined term. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.
6. **Participant Investment Rollovers** - Participants are allowed to transfer or rollover funds into the Plan from another qualified retirement plan or IRA. Participants are 100% vested in all rollover amounts. Rollover contributions will be affected by any investment gains or losses under the Plan.
7. **Forfeited Accounts** - During the Plan year ended December 31, 2024 and 2023, the Plan incurred \$7,572 and \$5,761, respectively in forfeitures and applied \$7,572 and \$5,761 to offset employer match during the Plan years.

NOTE B - Summary of Significant Accounting Policies

1. **Basis of Accounting** - The financial statements of the Plan are prepared using the accrual basis of accounting.
2. **Investment Valuation and Income Recognition** - Investment are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.
3. **Basis of Presentation** - U.S. Department of Labor (DOL) regulations and IRS Form 5500 require a comparative Statement of Net Assets Available for Benefits but only require that the current year's statement of changes in net assets available for benefits presented in the Form and also attached to it. The financial statements have been prepared to meet DOL and IRS requirements.
4. **Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
5. **Payment of Benefits** - Benefits are recorded when paid.
6. **Date of Management's Review** - The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

7. **Plan Expenses** - Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

8. **Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. The CARES Act and the Secure Act were considered and applied during the plan year for participants that qualified for such provisions.

During 2024, the Plan changed custodians and adopted a new plan agreement. Under the new adoption agreement, among other plan changes, the Plan does not allow participant loans. Accordingly, the previous custodian (Mutual of America) transferred the outstanding loan portfolio, effective January 12, 2024 totaling \$26,345, out of the Plan assets. Therefore, the total assets transferred to the Lincoln Group Trust Company, Inc. excludes the participant loan balances reported in the 2023 plan year.

9. **Third-Party Administrator** - The plan sponsor has engaged a third party, Lincoln National Corporation, to remit contributions, prepare financial statements, perform compliance testing, and prepare the annual information return.

NOTE C - Tax Status

The Plan was established effective November 1, 2018, and is intended to qualify under Section 401(a) of the Internal Revenue Code (IRC), with its related trust exempt from tax under Section 501(a). The Plan has been restated effective January 1, 2024, to incorporate applicable regulatory updates and maintain compliance with current IRS requirements.

The Plan Sponsor adopted a pre-approved plan document, and as such, reliance on the IRS opinion letter issued to the document provider is maintained. While the Plan has not received a separate determination letter from the IRS, the Plan Administrator believes the Plan continues to operate in compliance with applicable provisions of the IRC and ERISA.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service or Georgia Department of Revenue. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE D - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodologies include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund: A unique asset class offering intermediate term returns and participant liquidity without market value risk to the participant. A stable value fund typically provides a participant market value protection through a "wrap contract" from an insurance company or other investment contract which guarantees the payment of plan benefits at book value, even when the market value of the stable value fund is insufficient to pay benefits.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE G - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that change in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H - Related Party Transactions and Party in Interest Transactions

Certain Plan investments are shares of mutual funds managed by Lincoln Financial Group, which began serving as the Plan's custodian effective January 1, 2024. As defined by the Plan, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services to Lincoln Financial amounted to \$16,783 for the year ended December 31, 2024. Lincoln Financial did not receive any sales-based compensation for the 2024 plan year.

Prior to 2024, Mutual of America Life Insurance Company served as the Plan's custodian. Fees paid by the Plan for investment management services to Mutual of America amounted to \$1,261 for the year ended December 31, 2023. Mutual of America also received sales-based compensation of \$1,423 for the plan year ended December 31, 2023.

NOTE I - Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE J - Rollover Contributions

During the plan year, participants rolled over \$0 into the Plan.

NOTE K - Subsequent Event and COVID-19

The Organization evaluated subsequent events and transactions that occurred after the statement of net assets available for benefits up to the date that the financial statements were issued. Management is currently evaluating the impact of the COVID-19 pandemic on the Organization and its funding sources and the impact on the Plan and has concluded that while it is reasonably possible that the virus could have a negative effect on the Organization's financial position and the valuation of the net assets available (investments of the Plan), the specific impact is not readily determinable as of the date of these financial statements. The financial statements do not include any adjustments that might result from the outcome of the uncertainty.

NOTE L - New Accounting Pronouncements

ASU 2016-13, *Credit Losses (Topic 326) Measurement of Credit Losses on Financial Instruments*, as amended, modifies the measurement of expected credit losses on certain financial instruments. The new accounting guidance is effective for private companies with fiscal years beginning after December 31, 2022. Upon implementation, an entity may utilize the modified retrospective transition method, which changes how the allowance for the credit losses is determined. For the years ended December 31, 2024 and 2023, the Organization adopted this standard; however, it did not have a material impact on the financial statements.
