INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
MasterControl 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of MasterControl 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of MasterControl 401(k) Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about MasterControl 401(k) Savings Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about MasterControl 401(k) Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter - 2024 Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 ("supplemental schedule") is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Auditor's Report on the 2023 Financial Statements

The financial statements of MasterControl 401(k) Savings Plan as of December 31, 2023, were audited by Cooper Savas, whose practice became part of Armanino LLP, as of May 15, 2025. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to the statements or information related to assets held by investment funds for the year that were certified by a qualified institution. Their report, dated August 8, 2024, indicated that in their opinion (a) the form and content of information included in the supplemental schedule related to assets held by and certified by a qualified institution with accounting principles generally accepted in the United States of America, and (b) other information in the supplemental schedule related to assets held by and certified by a qualified institution agrees to or is derived from those statements or information prepared and certified by an institution that management determined meets requirements under ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF THE PLAN

The following description of MasterControl 401(k) Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by MasterControl Solutions, Inc. (the "Company" or "Plan Sponsor"), and is intended to qualify under Section 401(a) and related provisions of the Internal Revenue Code (IRC). The Plan was established effective January 1, 2000, and was most recently restated effective January 1, 2023, to change the vesting schedule from five years to four years. The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent amendments.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Company has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has administratively adopted some provisions of SECURE 2.0 but the Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan administration

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. The Plan's investments are held by the trustee of the Plan, Reliance Trust Company (the "Trustee"), and recordkeeping services and administrative services are provided by ADP Retirement Services.

Eligibility

Employees, as defined by the Plan, are eligible to participate in the Plan when they have completed thirty days of service and are age 21 or older. Union employees, nonresident aliens, and leased employees are ineligible to participate in the Plan.

1. DESCRIPTION OF THE PLAN (continued)

Contributions

Each year, participants may contribute up to 90% of their pre-tax or after tax (as Roth contributions) compensation, as defined in the Plan subject to an annual limit of \$23,000 for the year ended December 31, 2024. Participants who have attained the age of 50 before the end of 2024 are eligible to make catch-up contributions of \$7,500. Participants may also contribute amounts representing distributions from other qualified plans upon proof that the contribution has been in such a plan and/or segregated conduit or individual retirement account. Participants are 100% vested in these rollovers. Participants direct the investment of their contributions into various investment options offered by the Plan.

In 2024, the Company provided a discretionary matching contribution equal to 50% of each participant's contribution up to 6% of gross compensation or \$5,000, as defined in the Plan document. In order to be eligible for a matching contribution, the participant must be employed on the last day of the Plan year and must complete 30 days of service. Matching contributions are credited to the accounts of the deferring participants. Matching contributions are calculated and contributed to the Plan after the Plan's year-end.

Participant accounts

Each participant's account is credited with the participant's contributions (including rollovers from the participant's previous plan), and an allocation of the Company's contributions, if any, and Plan earnings, if any, and charged with an allocation of Plan losses, if any, and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their accounts attributable to salary deferrals and rollover contributions, plus actual earnings thereon. Vesting of discretionary employer match made by the Company is based upon years of continuous service. On January 1, 2023, the Company amended the Plan to change the vesting schedule from five years to four years, as follows:

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$74,875 and \$182,098, respectively. The Plan may elect to use forfeitures to reduce fees and/or to reduce future matching contributions. For the year ended December 31, 2024, forfeitures of \$194,369 were used to reduce matching contributions.

Administrative expenses

Fees and expenses charged under participant accounts impact retirement savings and fall into three basic categories. Investment fees such as sales charges, loads, commissions, or management fees are generally assessed as a percentage of assets invested and are deducted directly from investment fund balances. Plan administration and recordkeeping fees cover the routine expenses for the services of lawyers, accountants, third party administrators, and other advisors. Currently, the Company directly pays all expenses incurred to operate and administer the Plan. Transaction-based fees are associated with optional services offered under the Plan and are charged directly to participant accounts for particular plan features that may be available, such as the maintenance of a terminated participant's account.

Payment of benefits

Distributions and withdrawals are payable to participants upon retirement, termination, attainment of age 59 ½, financial hardship (as defined), disability, or to a beneficiary upon a participant's death. If a participant's vested account balance is less than or equal to \$1,000 upon termination, the balance is distributed immediately in a lump-sum cash payment unless a direct rollover into another qualified benefit plan is requested. Vested balances greater than \$1,000 but less than or equal to \$5,000 upon termination, will be rolled over to an individual retirement plan designated by the plan administrator if the participant has not requested a lump-sum cash payment or a direct rollover into another qualified benefit plan. If the vested account balance is over \$5,000 upon termination, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, a direct rollover into another qualified plan, installment payments, or to postpone payment in the Plan until they are legally required to begin taking distributions.

Participants are permitted to request in-service distributions from their vested Plan accounts at any time after having attained age 59 ½. Participants with an immediate and heavy financial need may be eligible for a hardship withdrawal, subject to certain restrictions as described in the plan documents. Immediate and heavy financial needs include: (1) medical expenses; (2) purchase of a principal residence; (3) to prevent eviction from principal residence; (4) to pay for education expenses; (5) funeral expenses; or (6) repair damage on principal residence.

Effective January 1, 2024, the Plan was administratively amended to adopt the increased threshold for mandatory distributions under Section 304 of the SECURE 2.0 Act, raising the limit from \$5,000 to \$7,000 for automatic rollovers to an individual retirement account.

Notes receivable from participants

A participant may borrow up to 50% of his or her vested account balance up to a maximum of \$50,000. The minimum note amount is \$1,000 with a maximum of two loans outstanding at a time. Notes bear interest at prime rate plus 1% and are fixed for the term of the note. Notes must be repaid to the Plan within five years. Notes are secured by the participant's vested balance and are generally repaid through payroll withholdings. Outstanding participants loans at December 31, 2024, bear interest at annual rates between 4.25% to 9.50%, and mature at various dates through June 2054.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial statement presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risk in the near term could materially affect participants' account balances and the amounts reported in the Plan's financial statements.

Investment valuation and income recognition

The Plan's investments in mutual funds and a common collective trust fund are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as those held during the year.

Administrative expenses

Administrative expenses are recorded when incurred.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits

Benefits are recorded when paid.

Contributions and contributions receivables

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the Company, which is the pay date. Employer contributions are recorded in the year they are earned and to coincide with the year in which the Employer records the contribution in its general ledger. The Plan records receivables based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year. Rollover contributions are recorded when they are received by the Trustee.

Subsequent events

Management has evaluated, for potential recognition or disclosure in the financial statements, subsequent events that have occurred through October 15, 2025, which is the date that the financial statements were available to be issued. No subsequent events have occurred that would have a material impact on the presentation of the Plan's financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the Plan's investment information, and related activity, certified by the Trustee, determined to be a qualified institution by the plan administrator, as complete and accurate, except for comparing such information to corresponding information included in the Plan's financial statements and supplemental schedule of assets (held at end of year) ("supplemental schedule"). The Trustee has certified that the following data included in the financial statements is complete and accurate:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, interest and dividends, and other income reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024, and;
- Investments and notes receivable from participants reflected on the supplemental schedule as of December 31, 2024.

4. FAIR VALUE MEASUREMENTS

Accounting standards establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology other than quoted prices included in Level 1 are observable for the asset or liability, each directly or indirectly, and include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

4. FAIR VALUE MEASUREMENTS (continued)

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value and estimated fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common and collective trust (CCT) – Investments in the CCT are valued at NAV of units of a bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. The unit value of this fund is determined on a daily basis, and units are issued and redeemed at their unit value. Net investment income and realized and unrealized gains and losses on investments are not distributed to participants but are reflected in the unit value. Were the Plan to initiate a full redemption of the CCT, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right, under the terms of the Plan, to terminate the Plan subject to the provisions of ERISA. In the event of such termination, all participants become fully vested and the rights of participants to their accounts under the Plan shall be non-forfeitable.

6. TAX STATUS

The Plan adopted the Automatic Data Processing Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan ("Pre-Approved Profit Sharing Plan") that has received a favorable opinion letter dated October 6, 2020, from the Internal Revenue Service stating that the Pre-Approved Plan is designed in accordance with the applicable sections of the IRC for use by employers for the benefit of their employees. The plan administrator believes that the Plan is currently designed and is being operated in accordance with the applicable section of the IRC and therefore, believes the Plan is qualified and is tax-exempt. Therefore, no provision for income taxes has been included in these financial statements.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines party-in-interest similar to a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan. However, these entities may not necessarily be related parties. Plan management did not identify any related parties to the Plan that were not also considered to be parties-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain fees and expenses of the Plan are paid by the Company. The Plan is not required to repay expenses paid by the Company on its behalf.

Certain fund level fees incurred by the funds in which the Plan invests for such services as investment management, shareholder services, and sub-transfer agency fees are paid through fund level revenue sharing arrangements. These fees reduce fund earnings thereby impacting Plan revenue applied to participants' accounts.

The Trustee retains, as compensation for services provided to the Plan, any interest (or "float") on amounts earned while certain transactions are pending. This applies to both contributions and distributions. Earnings are at institutional money market rates.
