Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the accompanying financial statements of the 3MD, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), my audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

NOTE 1 DESCRIPTION OF PLAN

The following description of the 3MD, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was restated with an effective date of March 1, 2021 (Cycle 3 restatement), and is a defined contribution Plan covering substantially all eligible employees of 3MD, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan, which includes determining the appropriateness of the Plan's investment offerings, monitoring investment performance, and reporting to the Company's Board of Directors.

Eligibility

The Plan covers substantially all employees of the Company, except for members of a collective bargaining unit, non-resident aliens, and interns, as defined by the Plan. There are no age or service requirements. Employees enter the Plan on scheduled enrollment dates.

Contributions

Participant – Each year, participants may contribute pretax and after-tax up to 100 percent of annual compensation, as defined by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2 percent of eligible compensation and their contributions invested in a model portfolio based on age until changed by the participant.

Matching – The Company will contribute a matching contribution of \$25 for each 1 percent of salary deferrals made that do not exceed 5 percent of eligible compensation, which equates to a maximum match of \$125 per quarter. To be eligible for the employer matching contribution, an employee must be employed on the last day of the plan year and have 200 hours of service during the plan year. For the year ended December 31, 2024, the Company made matching contributions of \$112,623.

Profit Sharing – Additional profit-sharing amounts may be contributed at the option of the Company's Board of Directors. There were no profit-sharing contributions for the plan year ended December 31, 2024.

Participant Accounts

Separate accounts are maintained for each participant. Each participant's respective account is credited with the participant's contributions and allocations of the Company's matching contributions, as well as an allocation of the Company's profit sharing contributions, if any, and Plan earnings. Participant accounts are charged with withdrawals, an allocation of investment losses, and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their and the Company's contributions into various investment options offered by the Plan. Participants may move portions of their accounts between investment options, and can change their salary deferral each pay-period.

Vesting

Participants are vested immediately in their deferral contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after four years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is commensurate with the interest rate charged by local commercial banks for similar loans. Principal and interest are paid ratably through payroll deductions and notes must be fully repaid within five years unless the note was issued for the purchase of a primary residence, upon which the note must be fully paid in accordance with the Plan provisions. One loan may be outstanding at a time, and the minimum loan amount is \$1,000.

Payment of Benefits

On termination of service due to any reason, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants with vested account balances of less than \$7,000 (\$5,000 in 2023) receive an automatic distribution to an Individual Retirement Account (IRA).

In-service and hardship withdrawals are permitted by the Plan. Hardship withdrawals must be approved by the Plan trustee and are available from all money types that are 100 percent vested, including earnings.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1 and \$0, respectively. These accounts can be used to reduce future employer contributions, or to pay administrative expenses under the Plan, if so directed by the Company. In 2024, forfeitures of \$42,952 were used to reduce future employer contributions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Contributions

Contributions from participants are recorded as they are withheld from the participant's wages. Contributions from the Company are recorded in the period in which the related participant contributions are due.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has performed an evaluation of subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

NOTE 3 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds:

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 CERTIFIED INVESTMENTS

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants as of December 31, 2024, and 2023, and net appreciation in fair value of investments, interest and dividends income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company, Inc. (the trustee of the Plan), a qualified institution. The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing the information with the information included in the financial statements and supplemental schedule.

NOTE 5 CONTRACT WITH INSURANCE COMPANY

The Lincoln Stable Value contract, with a December 31, 2024 and 2023 balance of \$334,943 and \$291,477, respectively, is a fixed annuity contract issued by The Lincoln National Life Insurance Company for contracts sold outside of New York. Contracts are backed by the general account of the issuing company. The guaranteed interest rate for the contract account may be based upon an index rate specified in the contract which may be changed quarterly, with a guaranteed minimum interest rate that varies by contract and can range from 1 percent to 3 percent.

The value of the Lincoln Stable Value contract which is reported to the Plan sponsor is the contract value. Contract value represents the amount participants would receive if they were to initiate a transaction under the terms of the ongoing Plan. The Lincoln Stable Value contract is between the Plan and the issuer and may not be assigned or sold to another party without the consent of the issuer.

The Lincoln Stable Value contract meets the requirements for fully benefit-responsive contracts and as such is reported at contract value. This means that participants are able to get 100 percent of their value when needed for bona fide plan benefits, such as retirement, termination, hardships, etc. There are some restrictions on the free transferability from the Lincoln Stable Value contract to other investment options and withdrawals for reasons driven by the contract owner, such as a plant shutdown.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 RELATED PARTIES AND PARTY- IN-INTEREST TRANSACTIONS

The Lincoln Stable Value Account is managed by Lincoln Financial Group Trust Company, Inc. (Lincoln). Lincoln is the trustee as defined by the Plan and, therefore, these transactions qualified as exempt party-in-interest transactions.

The Company is a party in interest to the Plan. However, there were no transactions with the Company other than employer contributions and the payment of certain administrative expenses on behalf of the Plan. These transactions qualify as exempt party-in-interest transactions.

Loans to participants also qualify as party-in-interest transactions.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company contributions.

NOTE 8 TAX STATUS

The Company has adopted a Non-Standardized Pre-Approved Profit-Sharing Plan with CODA plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved Plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
