Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Center City Housing Corp 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

1. DESCRIPTION OF THE PLAN

The following description of the Center City Housing Corp 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

General - The Plan was adopted effective January 1, 2024. The Plan is a defined contribution 401(k) profit sharing plan covering substantially all full-time employees of Center City Housing Corp that are age eighteen or older and have completed three months of service. The Plan excludes union employees, leased employees, non-resident aliens, and interns.

The Plan's custodian is Matrix Trust Company and the Plan's sponsor and Plan Administrator is Center City Housing Corp (the Employer). Human Interest, Inc. has been appointed the Plan's third-party administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Investments held with Matrix Trust Company are invested in mutual funds.

Contributions - Participants are allowed to make elective pre-tax contributions up to 90% of eligible wages and Roth contributions up to 50% of eligible wages, subject to Internal Revenue Code limitations. The Plan allows participants age 50 and older to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

The Employer may make discretionary matching, profit sharing, or non-elective contributions equal to a uniform percentage of the employee's elective deferrals. No Employer discretionary matching, profit sharing, or non-elective contributions were made in 2024. The Plan allows for additional qualified non-elective contributions in amounts determined at the sole discretion of the Employer. An employee must be employed with the Employer on the last day of the Plan year in order to be eligible for any additional qualified non-elective contributions. No additional qualified non-elective contributions were made in 2024.

1. DESCRIPTION OF THE PLAN (Continued)

Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of (a) the Employer's discretionary matching, profit sharing, and non-elective contributions, plus the Employer's additional qualified non-elective contributions if any, (b) Plan earnings and increases or decreases in the value of investments, net of expenses, and, (c) forfeitures of terminated participant's non-vested accounts. Allocations are based on account balances, participant earnings, or specific participant transactions as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - The participant's elective deferrals, the Employer discretionary matching contributions, the Employer qualified non-elective contributions, and earnings thereon are always 100% vested. For the Employer's discretionary non-elective contributions and earnings thereon, vesting is based on years of service. An employee must complete at least 1,000 hours of service during a Plan year to receive credit for a year of service. For any Employer discretionary non-elective contributions, a participant is vested based on a 2-to-6 year graded vesting schedule. Notwithstanding the above, a participant's account will be fully vested upon death, or disability.

Payment of Benefits - If a participant's employment is terminated and the participant's account value is less than \$5,000, the balance is automatically distributed in a single lump sum payment. If the participant's account value exceeds \$5,000, the Plan allows for single lump-sum payment, installment payments, and partial withdrawals. The Plan also allows for in-service withdrawals and hardship withdrawals subject to Plan provisions.

Forfeitures - Forfeitures can be used to pay administrative expenses of the Plan or reduce Employer discretionary matching contributions. Forfeited non-vested accounts totaled \$- at December 31, 2024. In 2024, no forfeitures were used to pay administrative expenses or reduce Employer discretionary matching contributions.

Investment Options - Participants are allowed to direct the investment of their contributions among the various investment options offered by the Plan. Employer discretionary matching, profit sharing, and non-elective contributions and additional qualified non-elective contributions are allocated on the same basis as participant contributions.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates - The preparation of any financial statements in accordance with U.S. generally accepted accounting principles may require management to make estimates that affect amounts reported and disclosed in the financial statements. Actual results could differ from such estimates.

Valuation of Investments and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Administrative Expenses - The Employer pays certain administrative expenses on behalf of the Plan. Expenses that are paid from Plan assets are reflected in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

4. INCOME TAX STATUS

The pre-approved plan document adopted by the Plan obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the pre-approved plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected.

5. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means; and Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement and have the lowest priority.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the methodologies used to measure the fair value of the Plan's investments. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

6. **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their employer contributions and all of the assets will be distributed to the participants based upon the balances in their respective accounts.

7. **PARTY-IN-INTEREST TRANSACTIONS**

The Plan Sponsor pays certain administrative expenses of the Plan.

8. **SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 15, 2025 the date on which the financial statements were available for issue, and identified no further significant events or transactions to disclose.
