Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Windsor America 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Windsor America 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

Description and Eligibility

The Plan was formed on January 1, 2024, as a defined contribution retirement savings plan. In connection with the formation of the Plan, the Company consolidated and merged several separate 401(k) plans maintained by its subsidiary entities into a single plan to provide uniform benefits and administration across the organization. The Plan covers all employees of Windsor America LLC and subsidiaries (the “Company”) except ineligible classes as defined by the Plan document. Employees are eligible to participate in the Plan after two months of service and upon attainment of age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Board of Trustees is responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

Contributions

Participants may contribute between 1% and 90% of either their pre-tax and/or post-tax annual compensation, as defined in the Plan, up to the annual Internal Revenue Service (“IRS”) dollar limit. If a participant reaches age 50 during the calendar year and is making the maximum Plan or IRS pre-tax contribution, they may make an additional “catch-up” contribution each pay period, up to the annual IRS dollar limit.

Effective January 1, 2025, the Plan was amended to add an automatic enrollment feature where participants are automatically enrolled in the Plan ninety days after their date of hire, unless they elect otherwise, at an enrollment rate of 3%. An auto-escalate feature was also added to the Plan where an active participant’s deferral contributions will increase by 1% annually (limited to 10% of eligible compensation), unless affirmatively elected otherwise.

The Plan provides a safe harbor contribution equal to 100% of the first 3% and 50% of the next 2% of active participants’ compensation contributed to the Plan. The Company contributed \$413,360 in matching contributions for the year ended December 31, 2024.

The Company may also make discretionary matching contributions to the Plan. Employees are eligible to receive employer matching contributions after six months of service. The Company may also make discretionary non-elective contributions. There were no discretionary contributions to the Plan in 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s contributions, as described above, and investment earnings, net of an allocation of administrative expenses charged, based on the participant’s account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Participants direct the investment of their contributions in various investment options offered by the Plan.

Rollovers

Participants may transfer cash distributions from eligible qualified plans attributable to rollover distributions. This amount shall be credited to the participant's rollover contributions account within the Plan.

Vesting

Participants are vested immediately in their contributions and the Company's safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contributions and discretionary nonelective contributions will vest based on the following schedule: 34% after 1 year, 67% after 2 years, and 100% after 3 years.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at Prime plus one percent at the time of the note. The term of the loan may not exceed 5 years or 15 years if the loan proceeds will be used to acquire the principal residence of the participant. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant may elect to receive the value of the vested interest either in a lump sum amount, partial withdrawals, or installment payments under a systematic withdrawal plan. However, if the vested account balance is less than \$5,000, a lump sum distribution will be made to the participant regardless of whether the participant elects to receive it. In-service distributions of vested balances are permitted if the participant is 100% vested. Upon proven financial hardship, participants may elect to withdraw an amount equal to the cumulative value of their elective contributions.

Forfeitures

Forfeitures are used to reduce employer discretionary matching contributions, safe harbor contributions and discretionary nonelective contributions to the Plan, either on an annual or per payroll period basis, or to pay administrative expenses of the Plan. At December 31, 2024, forfeited non-vested accounts totaled \$417. Employer contributions were reduced by forfeitures of \$1,087 for the year ended December 31, 2024.

Administrative Expenses

The Plan pays expenses incurred in the administration of the Plan, unless paid by the Company. The Plan permits the payment of Plan expenses to be made from Plan's assets in which expense amounts may be allocated either (1) proportionately among participants based on account balances, or (2) in equal dollar amounts across all participant accounts.

Plan Termination

Although it has not expressed any intent to terminate the Plan, the Company has the right to do so at any time subject to the provisions of ERISA. In the event of termination, the accounts of the participants will be distributed in a manner determined by the Plan Administrator and in accordance with the provisions of the Plan.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and reported amounts of revenue and expenses during the reporting period. Actual results could differ from these estimates.

Fair Value Measurements

Fair value estimates are made at a specific point in time based on relevant market information about the financial instrument. These estimates are subjective in nature and involve uncertainties and matters of significant judgment and, therefore, cannot be determined with precision. Changes in assumptions could significantly affect the estimates.

Valuation of Investments and Investment Income

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by its investment advisors and trustees. See Note 4 for a discussion of fair value measurements.

Contract value is the relevant measurement attributable to that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in the Great-West Guaranteed Portfolio. This fund meets the fully benefit responsive investment contract criteria and therefore is reported at contract value. Contract value, as reported to the Plan by the Trustee represents deposits made to the contracts, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Investment income consists of dividend and interest income. The net appreciation (depreciation) of investments consists of realized gains or losses and the unrealized appreciation or depreciation on those investments. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are reported based on historical cost.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. In management's opinion, all notes receivable are fully collectible; accordingly, no allowance for credit losses was recorded as of December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued. See Note 1 for disclosed subsequent event.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan's investments are participant-directed accounts that are held by the Trustee.

Fair value is a market-based measurement that is determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, the Company uses a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 – Observable inputs such as quoted prices in active markets;
- Level 2 – Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3 – Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The classification of fair value measurements within the hierarchy is based upon the lowest level of input that is significant to the measurement. Valuation methodologies used for assets and liabilities measured at fair value are as follows:

- Registered investment companies: Valued based on quoted prices in the active market.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

At December 31, 2024, the Plan had no unfunded commitments related to common/collective trust funds. The redemption of the common/collective trust fund is subject to the preface of individual Plan participants, with the issuer reserving the right to temporarily delay the withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan is invested in the Great-West Guaranteed Portfolio Fund which is a fully benefit-responsive investment contract. There are no events that could limit the ability of the Plan to transact at contract value. There are not any events that could allow the Issuer to terminate the contract and which require the Plan to settle at an amount different than contract value.

NOTE 6 – TAX STATUS

The Plan, an adopted prototype plan, obtained its determination letter dated October 6, 2020, in which the Internal Revenue Service stated that the Plan is qualified, and the trust established under the Plan is tax-exempt, under the appropriate sections of the Internal Revenue Code (“IRC”). Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan Administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan’s qualified status and believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and for the year then ended, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 – RELATED-PARTY TRANSACTIONS

Certain administrative expenses were paid by the Plan or the Company. The Plan issues loans to participants, which are secured by the vested balance in the participant's accounts. The Plan makes loans to Plan participants who are also considered to be parties-in-interest.

NOTE 9 – TRANSFERS

Effective January 1, 2024, the Windsor Door Retirement Savings Plan 001, Windsor Door Retirement Savings Plan 002, Lodi Door 401(k) Plan and Garage Door Services of Houston 401(k) Profit Sharing Plan merged into the Plan. As a result, \$4,542,647 of assets were transferred into the Plan.
