Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Maguire Automotive Group, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTES TO FINANCIAL STATEMENTS

Years Ended December 31, 2024 and 2023

A. DESCRIPTION OF PLAN

The following description of the Maguire Automotive Group, LLC 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document and adoption agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Maguire Automotive Group, LLC (“Company”) and was part of a controlled group along with the Maguire CDJRWG, LLC 401(k) Plan prior to the merger discussed in Note J. Prior to June 1, 2024, employees were eligible to contribute once they completed one (1) year of service with 1,000 hours of service during that year and are age 21 or older. As of June 1, 2024, employees are eligible to contribute once they have completed two (2) months of service and are age 21 or older. The eligibility requirements are also applicable to employer matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Trustees are responsible for the governance of the Plan.

Contributions: Prior to June 1, 2024, participants may contribute up to 100% of pretax annual compensation as defined in the Plan, subject to limits defined by the Internal Revenue Service (IRS). As of June 1, 2024, participants may contribute up to 90% of pretax annual compensation as defined in the Plan, subject to limits defined by the Internal Revenue Service (IRS). Roth deferrals are also permitted. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation, and their contributions are invested in the designated default fund until changed by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Company makes matching contributions of 100% of each participant’s salary deferrals, up to 2% of the employee’s compensation as defined in the Plan.

The Company has the option to make additional discretionary contributions to the Plan.

Participants may direct the investment of their contributions and the Company’s contribution(s) into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common collective trust as investment options for participants.

Participant Accounts: Each participant’s account is credited with the participant’s contributions, the Company’s matching contribution, an allocation of any other Company contributions, and an allocation of Plan earnings (losses). Participant accounts are charged

with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contributions is graded over six (6) years of continued credited service as follows:

Notes Receivable from Participants: Prior to June 1, 2024, participants may borrow from their accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. As of June 1, 2024, the minimum loan amount was reduced to \$500. Prior to June 1, 2024, participants may only have two outstanding loans at any time. As of June 1, 2024, participants may only have one outstanding loan at any time. The notes are secured by the balance in the participant's account and bear an interest rate commensurate with interest rates charged by local commercial banks for similar loans. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: Upon termination of service, death, disability, or retirement (age 65), a participant may elect to receive single lump-sum distribution or installments equal to the value of the participant's vested interest in his or her account. The Plan allows for in-service withdrawals if a participant reaches age 59^{1/2}, and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan Administrator will authorize benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the benefit will be rolled into an individual retirement account in the participant's name.

Forfeited Accounts: As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,096 and \$659, respectively. There were \$34,641 and \$46,298 of forfeitures used to reduce employer matching contributions during the years ended December 31, 2024 and 2023, respectively. These accounts will be used to reduce future employer matching contributions.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Investments are valued daily by the Plan recordkeeper. Interest and dividend income is recorded on the cash basis, which approximates accrual basis. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded based on the terms of the Plan document.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan are paid directly by the Company and are therefore excluded from these financial statements. Administrative expenses of the plan are allocated to participant accounts.

C. CERTIFIED INVESTMENT INFORMATION (UNAUDITED)

The investment activities and balances included on the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the trustees, Empower Trust Company, LLC and ADP Retirement Trust Services, LLC, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$17,909,919 and \$16,854,991 as of December 31, 2024 and 2023, respectively; notes receivable from participants of \$576,637 and \$293,307 as of December 31, 2024 and 2023, respectively; related investment income of \$1,418,887 and \$1,878,056, and interest on notes receivable from participants of \$35,690 and \$16,892 for the years ended December 31, 2024 and 2023, respectively.

D. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodologies are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds:

Investments are valued at daily calculated NAV and are traded at their quoted prices through the National Securities Clearing Corporation.

Common Collective Trusts (including Stable Value Fund):

Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

E. PARTY-IN-INTEREST TRANSACTIONS

Plan investments included annuity contracts managed by ADP Retirement Trust Services, LLC, the trustee of the Plan, or affiliated companies. Investment-related expenses are paid from plan assets and are included in total expenses. The Company pays certain administrative expenses for the Plan, including auditor fees and the cost of ERISA bond coverage.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

F. TAX STATUS

The Plan obtained an opinion letter dated October 6, 2020 in which the Internal Revenue Service stated that the form of the Plan was acceptable under the Internal Revenue Code. The Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a liability for any uncertain position that more likely than not would not be sustained upon examination by

the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

G. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

H. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

I. MERGER

On June 1, 2024, the Maguire CDJRWG, LLC 401(k) Plan was merged into the Maguire Automotive Group, LLC 401(k) Plan. The transferred net assets have been recognized in the accounts of the Maguire Automotive Group, LLC 401(k) Plan as of June 1, 2024, at their balances as previously carried in the accounts of the Maguire CDJRWG, LLC 401(k) Plan.
