INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of

Opinion

We have audited the financial statements of UPS Retired Employees Health Care Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA) which comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements (modified cash basis) (the "financial statements").

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan (modified cash basis) as of December 31, 2024 and 2023, and the changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, in accordance with the modified cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. NOTES TO FINANCIAL STATEMENTS (MODIFIED CASH BASIS)

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

General—The United Parcel Service Health and Welfare Plan Trust for Non-Collectively Bargained Employees (“VEBA” or “Master Trust”) was established on December 30, 1985 and has been amended periodically. The VEBA is the funding vehicle for the UPS Retired Employees Health Care Plan (the “Plan”), the UPS Flexible Benefits Plan, and the UPS Health Care Plan (collectively, the “Plans”). The Plan is also funded by restricted assets in a 401(h)-account held by the UPS Retirement Plan in the UPS Group Trust (“Group Trust”) (see Note 6).

The following description of the Plan is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan’s Administrative Committee controls and manages the operation and administration of the Plan. Plan assets are held in the Master Trust for which the Bank of New York Mellon (“Mellon Trust”) serves as the trustee (“Trustee”).

Contributions—The VEBA receives and invests contributions from United Parcel Service, Inc. (the “Plan Sponsor”, “employer”, or “UPS”). Participants in the Plan who retired prior to January 1, 1993, do not contribute to the Plan. In addition to deductibles and copayments, participants contribute specified amounts based on applicable premiums for their respective benefit elections. The amount to be contributed by participants is determined annually based on several factors.

The majority of employer contributions to the Master Trust are allocated to each plan based upon the level of service provider payments (benefit payments, premiums (if any) plus administrative expenses, net of employee contributions) made on behalf of the applicable plan as compared to total service provider payments of the VEBA, net of employee contributions.

The Plan Sponsor makes contributions to the Plan as needed to fund claims in excess of participants’ contributions. Any deficiency of the Plan’s net assets over benefit obligations is expected to be funded by the Plan Sponsor on a pay-as-you-go basis.

Benefits—The Plan provides health and welfare benefits, including health, dental, vision, short-term disability benefits, and certain types of life insurance (life insurance is provided for only long-term disability participants), to eligible non-union UPS retirees and their dependents. Benefits are also provided to former employees of UPS, who have been approved for long-term disability benefits, and their dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Health Reimbursement Arrangement—The Plan has a health reimbursement arrangement (HRA) that is funded solely through employer contributions. The HRA allows eligible participants to be reimbursed tax free for qualified medical expenses subject to a specified ceiling. The HRA does not accumulate or carry over into a new plan year. The employer is not permitted to refund any part of the balance to the participant; the account cannot be used for anything other than reimbursements for qualified medical expenses; and remaining amounts are not portable once the participant leaves the Plan.

Termination—Although it has not expressed any intention to do so, UPS has the right under the Plan to modify the benefits provided to employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, UPS will contribute the necessary amounts to fund all applicable expenses incurred prior to the date of the termination.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting—The Plan prepares its financial statements on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (GAAP). Contributions are generally recorded when received, and claims, premiums, and administrative expenses are generally recorded when paid. Benefit obligations are not recorded in the statements of net assets available for benefits; however, they are disclosed on an accrual basis in Note 5.

Use of Estimates—The preparation of financial statements in conformity with the modified cash basis of accounting requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, disclosure of benefit obligations and changes therein, claims payable, claims incurred but not reported, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition—The Plan's and Master Trust's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded when received. Investment income allocated from the Master Trust includes the Plan's proportionate share in the Master Trust's gains and losses in investments bought and sold as well as held at year-end.

Claims Incurred but Not Reported—As reported in Note 5, the Plan's liability for claims incurred but unreported at year-end is estimated using actuarial methods that use historical trend information developed through studies of medical claim lag patterns incurred in the prior years.

Claims and Premiums Paid—Claims and premiums are recorded when paid.

Postemployment Benefit Obligation—The postemployment benefit obligation for disability and COBRA benefits for inactive participants, beneficiaries, and dependents is estimated by the Plan's actuary in accordance with accepted actuarial principles. Such estimated amounts are reported in Note 5 at present value, and long-term disability benefits are measured based on a discount rate of 5.82% and 6.06% at December 31, 2024 and 2023, respectively.

For 2024 and 2023, the disability assumptions are based on the 2012 Group Long-Term Disability Basic table, reflecting the 2019 GLTD experience Study Preliminary Report, with a 6-month elimination period, excluding freight.

For 2024 and 2023, the mortality assumptions used are based on the Pri-2012 healthy no collar mortality table, with MP-2021 mortality improvements after 2012 assuming the long-term rate of mortality improvement phases down to 0.5% by 2029 and 2028, respectively.

Other assumptions are as follows:

Duration—Short Term Disability—If the number of actual elapsed weeks is less than 10, the assumed remaining duration is 10 weeks less the elapsed number of weeks. Otherwise, if the number of actual elapsed weeks is greater than or equal to 10, the assumed remaining duration is 20 weeks less the elapsed number of weeks.

Duration—COBRA—At December 31, 2024, survivors receiving a UPS subsidy are assumed to remain enrolled for as long as their subsidy is available. Other participants who have enrolled are assumed to remain enrolled for the duration of their COBRA eligibility. At December 31, 2023, participants who have taken more than half of the initial maximum benefit period are assumed to take one-half of the remaining maximum benefit period. Other participants are assumed to take one-half of the initial maximum benefit period less the number of months already taken.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postemployment benefit obligation.

Postretirement Benefit Obligation—The postretirement benefit obligation disclosed in Note 5 represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to an employee's service rendered to the date of the financial statements and reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the Plan Sponsor. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attached to that employee's service rendered to the valuation date. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Plan Sponsor and from existing Plan assets.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical rates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment, and it does not include those costs expected to be borne by Medicare, the retired participants, and other providers.

For the December 31, 2024 valuation, the annual rate of increase in health care costs was assumed to be 7.50% in 2025 and grading down by 0.25% in years 2026 through 2037 and remaining at 4.50% thereafter.

For the December 31, 2023 valuation, the annual rate of increase in health care costs was assumed to be 7.25% in 2024 and grading down by 0.25% in years 2025 through 2035 and remaining at 4.5% thereafter.

The health care cost trend assumptions have a significant effect on the costs reported. If the assumed rates increased by one percentage point for each future year, the obligation as of December 31, 2024 and 2023, would increase by approximately \$9,294,000 and \$10,400,000, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Administrative Expenses—Administrative expenses of the Plan are paid by the Plan, as provided in the Plan document.

Refunds—Refunds due from the Plan’s pharmacy benefits manager are recorded upon receipt. Pharmacy rebates totaling \$400,744 have been netted with claims disbursements to providers in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

Risks and Uncertainties—The Plan (through the Master Trust) and the Group Trust utilize various investment securities. Detailed disclosures on the investments in the 401(h) account, which is held by the UPS Group Trust, are presented in the UPS Retirement Plan financial statements. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events, such as a pandemic or international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near-term, and that such changes could materially affect the amounts reported in the financial statements.

The actuarial present value of the postemployment and postretirement benefit obligations are reported based on certain assumptions including those pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

Subsequent Events—Management has evaluated subsequent events for the Plan through October 15, 2025, the date the financial statements were available to be issued. There are no subsequent events that require adjustment to or disclosure in the financial statements.

3. MASTER TRUST

The Master Trust investments are stated at fair value as determined and reported by the Trustee in accordance with the Master Trust Agreement established by the Plan Sponsor. The value of the assets held by the Master Trust is determined based on the fair value of the underlying assets. Use of the Master Trust permits commingling of the Plan’s assets with the assets of the other Plans in the Master Trust.

The Plan’s interest in the Master Trust represents 16.52% and 2.96% of the Master Trust’s net assets at December 31, 2024 and 2023, respectively.

The value of the Plan’s interest in the Master Trust is based on the beginning of year value of the Plan’s interest in the trust plus actual participant contributions, allocated employer contributions, allocated investment income, less actual claims netted against refunds, less premiums paid and administrative expenses, as applicable.

The investment income of the Master Trust during 2024 is \$142,310 which consisted of interest income.

Investment income is allocated annually from the Master Trust to each plan based upon the investment income for the year compared to each plan’s relative expenses.

Financial Accounting Standards Board Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, establishes a single authoritative definition of fair value, sets a framework for measuring fair value, and requires additional disclosures about fair value measurements. In accordance with ASC 820, the Plan classifies its investments into Level 1, which refers to securities valued using quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market, but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

As of December 31, 2024, the fair value of the Master Trust investment in the interest-bearing cash account is valued at cash plus interest earned (Level 2 inputs within the fair value hierarchy). As of December 31, 2023, the fair value of the Master Trust investment in the money market mutual fund is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs within the fair value hierarchy).

4. FEDERAL INCOME TAX STATUS

The Master Trust established under the Plan to hold the Plan's assets is intended to qualify as a VEBA trust under Section 501(c)(9) of the Internal Revenue Code (IRC), and accordingly, the Master Trust's net investment income is exempt from income taxes. The Master Trust has obtained an exemption letter dated February 2, 1988, from the Internal Revenue Service (IRS). The Plan Sponsor believes that the Master Trust, as amended, continues to qualify and operate in accordance with the applicable provisions of the IRC. The IRS has determined and informed the Plan Sponsor by a letter dated October 15, 2015, that the UPS Retirement Plan and related trust, which hold the assets of the 401(h) account, were designed in accordance with the applicable regulations of the IRC. The Plan has been amended since receiving the determination letter; however, the Plan Sponsor believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan administrator has analyzed the tax positions taken by the Plan, and concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Sponsor believes the Plan is no longer subject to income tax examinations for years prior to 2022.

6. 401(h) ACCOUNT

Effective January 1, 1976, the UPS Retirement Plan was amended to include a medical-benefit component in addition to the normal retirement benefits to fund a portion of the postretirement obligations for retirees and their beneficiaries of the Plan in accordance with Section 401(h) of the IRC. A separate account has been established and maintained in the UPS Retirement Plan for such contributions. The restricted net assets and the related obligations for health and welfare benefits are reflected as the net assets held in the UPS Retirement Plan 401(h) account in the statements of net assets available for benefits. In accordance with IRC Section 401(h), the Plan's investments in the 401(h) account may not be used for, or diverted to, any purpose other than providing health benefits for retirees and their beneficiaries.
