- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Benihana 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Benihana 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Benihana 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Benihana 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.



- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Benihana 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. Benihana National Corp. and its participating subsidiaries are the employers of the Plan and are collectively referred to as the "Company" or "Employer".

General

The Plan is a defined contribution plan covering a majority of full-time and part-time employees of the Company who have completed at least two months of service and are at least twenty-one years old. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Transfer from/to Benihana Restaurant Employees 401(k) Plan

During 2024, in connection with changes in employees' job classifications, certain participants in another 401(k) benefit plan sponsored by the Company transferred their account balances from that benefit plan into the Plan and certain participants in the Plan transferred their account balances to another 401(k) benefit plan sponsored by the Company.

Administrative Error

An administrative error occurred during 2021 and 2022 in that a group of employees who were not eligible for the Plan were incorrectly enrolled automatically in the Plan. The Plan Administrator intends to refund the accounts created for those employees at no cost to them which as of December 31, 2024 and 2023, amounted to \$505 and \$12,329, respectively, included as benefits payable on the accompanying statements of net assets available for benefits, and to refund distribution fees deducted from the accounts of terminated employees from this group who received payment which as of December 31, 2024 and 2023, amounted to \$505 and \$505, respectively, included as other employer contributions receivable on the accompanying statements of net assets available for benefits. In addition, the Plan incorrectly received payroll contributions for employees who were eligible for the other 401(k) plan the Company sponsors, i.e., the Benihana Restaurant Employees 401(k) Plan ("Restaurant Plan"), and the accounts attributable to those contributions will be transferred to the Restaurant Plan which as of December 31, 2023, amounted to \$154, included as due to Benihana Restaurant Employees 401(k) Plan on the accompanying statements of net assets available for benefits.

NOTE 1. DESCRIPTION OF THE PLAN (Continued)

Contributions

Each year, participants may contribute a percentage of annual compensation on a pre-tax and/or after-tax basis, as defined in the Plan, up to the statutory maximum. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may make discretionary matching contributions and discretionary profit-sharing contributions. No discretionary matching contributions or discretionary profit-sharing contributions were made by the Company for the year ended December 31, 2024. In order to share in the discretionary profit-sharing contributions, participants must have at least 1,000 hours of service during the Plan year and be employed on the last day of the Plan year.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution and earnings from participant directed investments, net of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions is based on years of continuous service. Participants are fully vested after three years of continuous service.

Forfeitures

Forfeitures can be used to reduce future employer contributions and administrative expenses. At December 31, 2024 and 2023, there were no forfeited non-vested accounts.

Investment Options

Upon enrollment in the Plan, a participant may direct the investment of their contributions to various investment options offered by the Plan and may change such options daily.

Notes Receivable from Participants

A participant may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of 50% of a participant's vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at a rate determined by the Plan administrator at the time of the loan application. Principal and interest is paid ratably through payroll deductions.

Plan Administration

The Plan is administered by the Company. The Plan's assets are maintained by its trustee, Reliance Trust Company ("Trustee"). Standard Retirement Services, Inc. serves as the Plan's record-keeper.

NOTE 1. DESCRIPTION OF THE PLAN (Continued)

Payment of Benefits

Upon termination of service for any reason, a participant (or their beneficiaries) may receive the value of the vested interest in his or her account as a single lump-sum distribution if the balance does not exceed \$5,000. If the participant's balance exceeds \$5,000 then the participant may receive a single lump-sum distribution, installments over a period of not more than participant's assumed life expectancy, or partial distributions of at least \$1,000.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their allocation of employer contributions.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition

Other than the fully benefit-responsive group annuity contract, which is reported at contract value, the Plan's investments are stated at fair value. Shares of mutual funds are valued at quoted market prices at year end. Security transactions are recorded on a trade date basis, which is the date the order to buy or sell is executed. Interest income is accrued on a daily basis. Dividend income is recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. At December 31, 2024 and 2023, the interest rates on participant loans ranged from 5.25% to 10.50%.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Certain administrative functions are performed by employees of the Company. No such employees receive compensation from the Plan. Certain administrative expenses, such as professional fees, are paid directly by the Company. Plan expenses are recorded when incurred.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Party-In-Interest Transactions

The Plan has an investment option that is managed by an affiliate of the Plan's record-keeper and notes receivable from participants. These transactions qualify as party-in-interest transactions.

Risk and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Concentrations

Substantially all of the Plan's assets are held by the Trustee, located in Atlanta, Georgia.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE (UNAUDITED)

The following information included in the accompanying financial statements and supplemental information was obtained by management and agreed to or derived from data that has been prepared by and certified to as complete and accurate by the Trustee.

During the Plan year ended December 31, 2024, the Plan's investments (including gain and losses on investments bought and sold, as well as held during the Plan year) in mutual funds appreciated in value by \$2,075,359. In addition, interest and dividends relating to the Plan's investments amounted to \$872,204.

NOTE 4. FAIR VALUE MEASUREMENTS

Generally accepted accounting principles require the Plan to report its investments at estimated fair value on a recurring basis. Fair value is measured by a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A description of the valuation methodologies the Plan uses for assets measured at fair value is included in Note 2. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methodologies may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. INCOME TAX STATUS

The Plan is operated under a pre-approved prototype plan offered by Standard Retirement Services, Inc. The prototype plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since then, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan assesses its tax positions in accordance with *"Accounting for Uncertainties in Income Taxes"* as prescribed by the *Accounting Standards Codification*, which provides guidance for financial statement recognition and measurement of uncertain tax positions taken or expected to be taken in a tax return for open tax years (generally a period of three years from the later of each return's due date or the date filed) that remain subject to examination by the Plan's major tax jurisdictions.

The Plan assesses its tax positions and determines whether it has any material unrecognized liabilities for uncertain tax positions. The Plan records these liabilities to the extent it deems them more likely than not to be incurred. Interest and penalties related to uncertain tax positions, if any, would be classified as a component of income tax expense.

The Plan believes that it does not have any significant uncertain tax positions requiring recognition or measurement in the accompanying financial statements.

NOTE 6. GROUP ANNUITY CONTRACT

The Plan has a fully benefit-responsive group annuity contract with the Standard Insurance Company, which is called the Standard Stable Asset Fund. The fully benefit-responsive group annuity contract is a traditional contract, whereby the Plan owns the contract itself. The insurance company maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses. Since the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The Plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The insurance company may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, including the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, plan disqualification or failure to adopt the Plan in a reasonable period of time. Upon termination by the insurance company, a market value adjustment or withdrawal restrictions may apply. The Plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the insurance company, but cannot be less than 1.0%. Such interest rates are reviewed on a quarterly basis for resetting.

NOTE 7. NON-EXEMPT PARTY-IN-INTEREST TRANSACTIONS

During 2024 and 2023, there were unintentional delays by the Company in submitting employee contributions and loan repayments of approximately \$891,888 and \$3,064, respectively, to the Trustee. Lost earnings related to these remittances were not significant to the financial statements. These late remittances are reported in Form 5500 as a nonexempt prohibited transactions.

NOTE 8. EXCESS CONTRIBUTIONS PAYABLE

The Plan failed the discrimination test for the years ended December 31, 2024 and 2023, resulting in excess contributions amounting to \$39,420 and \$26,774, respectively. The excess contributions, including investment gains of \$3,796 and \$3,216, for the years ended December 31, 2024 and 2023, respectively, are recorded as liabilities in the accompanying statements of net assets available for benefits and were subsequently reimbursed to participants, except for \$5,363 related to the year ended December 31, 2024 which was reimbursed to a participant during 2024. The excess contributions and related investment gains during 2024 are recorded as a reduction of participant contributions and net appreciation in fair value of investments, respectively, in the accompanying statement of changes in net assets available for benefits.

NOTE 9. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 15, 2025, which is the date the accompanying financial statements were available to be issued.

In September 2025, the Company adopted a plan to merge the Plan into a newly created defined contribution plan by early 2026.
