## INDEPENDENT AUDITORS' REPORT

### **Opinion**

We have audited the accompanying financial statements of the Health Alliance for Technology, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of Health Alliance for Technology (the Plan) as of December 31, 2024 and 2023, and the changes in net assets available for benefits and of changes in benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ## Notes to Financial Statements

### Note 1 – Description of the Plan

The following description of the Health Alliance for Technology (the Plan) provides only general information. Participants should refer to the plan documents, summaries, and other descriptive plan literature for a more complete description of the Plan's provisions.

- a. **General** – The Plan was established on May 7, 2008. The Plan was established to hold insurance policies through which participating employers can provide programs of health and other insurance benefits under the employee benefit plans they maintain for their employees and dependents.

This program is considered a “group insurance arrangement” as defined by the Employee Retirement Income Security Act of 1974 (ERISA). ERISA defines a “group insurance arrangement” as an arrangement providing benefits to the employees of two or more unaffiliated employers, fully insures one or more welfare plans of each participating employer, and uses a trust as the holder of the insurance contracts and conduit for payment of premiums to the insurance company(ies).

- b. **Eligibility** – Participation in the Plan is limited to employers in the technology industry in the state of Washington who have executed an adoption agreement. The only individuals who are entitled to participate in and to receive benefits from the Plan are those selected employees and dependents identified by participating employers. Individuals must also be a member of GeekWire, LLC, to participate and receive benefits from the Plan.
- c. **Contributions** – Under an administration agreement signed by the ALLtech Health Trust (the Trust) and Associated Industries Management Services, Inc. (AIMS), AIMS has all necessary authority to receive contributions to pay premiums on the group insurance policies owned by the Trust and to also pay reasonable expenses of the Plan. Each employer agrees to provide information, including payroll information and data, to the Plan regarding the employer's participants and employees of any controlled group in which the employer may be a member. Each employer agrees to promptly remit to the Plan the amount of contribution required to maintain welfare benefits coverage for each of the employer's participants in the amounts and at times described in the Adoption Agreement. In the event that any employer fails or refuses to remit the employer's or the participants' contributions due to the Plan on a timely basis, AIMS will cancel and terminate the coverage afforded the employer's participants, and the employer will be notified.

Employer and participant contributions are received and held by the Trust pending payment of approved insurance premiums and welfare benefits. The Plan allows participating employers to elect various benefit coverage options. Such contribution rates are determined by the Board of Trustees.

- d. **Benefits** – The Plan provides medical, prescription drug, dental, and vision benefits for eligible employees and their dependents. The Plan fully insures these benefits. Premiums are paid by the Plan.

### Note 1 – Description of the Plan (Continued)

- e. **Related parties and parties-in-interest** – The sponsor of the Plan is the Information Technology Group. The administrator of the Plan is AIMS, a contract administration organization related to Associated Industries of the Inland Northwest (AIIN). The Trust contracts with various insurance brokers. Financial statement accounting and auditing services are provided by Anastasi, Moore & Martin, PLLC.

The administration agreement provides for a Board of Trustees responsible for the administration of the Trust. The Board of Trustees has contracted with AIMS to provide administrative services to the Trust. Under the terms of this contract, the Trust pays AIMS a base administrative fee of 3% on gross contributions collected and reimburses AIMS for necessary and reasonable administration costs of the Plan. During the years ended December 31, 2024 and 2023, the Plan paid administration fees totaling \$1,073,774 and \$809,004, respectively, to AIMS.

### Note 2 – Summary of Significant Accounting Policies

The summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are the representations of the Board of Trustees, who is responsible for the integrity and objectivity of the financial statements.

These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

- a. **Basis of accounting** – The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.
- b. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan sponsor to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
- c. **Interest-bearing cash** – Interest-bearing cash includes investments which are not subject to withdrawal restrictions and can be converted to cash on short notice. Interest-bearing cash includes interest-bearing demand deposits held at financial institutions, money market accounts, and certificates of deposit.
- d. **Investment valuation** – The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

## Notes to Financial Statements

### Note 2 – Summary of Significant Accounting Policies (Continued)

- e. **Employer contributions receivable** – Employer contributions due but not paid at period end are recorded as contributions receivable. Delinquent contributions are recorded when collected. Amounts recorded are considered fully collectible and, accordingly, no allowance for doubtful accounts is presented.
- f. **Rate stabilization reserves** – Certain benefits are provided through an experience rated insurance contract with The Standard Insurance Company (the Standard). The experience rating can result in significant premium rate adjustments. To assist in mitigation of significant rate adjustments, the Standard retains funds as rate stabilization reserves. The carrier may credit the reserves for interest earned. Any other changes to the reserves are a result of contract negotiations between the Plan and the Standard. If the contract was terminated, any funds in the reserves would be refunded to the Plan after the contract's experience results were settled. As such, the reserves are recognized as an asset of the Plan.
- g. **Unearned employer contributions** – Employer contributions received in advance of the coverage period are recorded as unearned contributions. Contributions are recognized when the period of coverage begins.
- h. **Payment of insurance premiums** – Insurance premiums are recognized when paid. Rebates of insurance premiums are recognized when received. During the years ended December 31, 2024 and 2023, the Plan received rebates in the amounts of \$44,560 and \$45,879, respectively.
- i. **Subsequent events** – Subsequent events have been evaluated through **DATE**, which is the date the financial statements were available to be issued.

### Note 3 – Income Tax Status

The Trust established under the Plan to hold the assets of the Plan is qualified as a tax-exempt organization under Section 501(c)(9) of the Internal Revenue Code (IRC). A favorable tax determination letter has been obtained from the Internal Revenue Service (IRS). The Board of Trustees believes the Plan and related trust are designed and have been operated through December 31, 2024, in compliance with applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the tax-exempt status; however, there are no audits for any tax periods in progress.

### Note 4 – Priorities Upon Termination

Although it has not expressed any intention to do so, the plan sponsor has the right under the Plan to modify benefits provided to active participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. Upon termination of the Plan, all assets remaining in the Trust (net of payments for all expenses) shall be used for the continuance of benefits provided until such assets have been depleted.

If the assets are insufficient to pay all accrued benefits and liabilities, distribution of the assets shall be made in accordance with plan termination provisions and the requirements of ERISA and applicable government regulations. In no event shall any of the assets remaining in the Plan be paid to or be recoverable by any employer.

### Note 5 – Risks and Uncertainties

In determining the fair value of financial instruments, plan management uses a variety of methods and assumptions that are based on market conditions and risks existing at the date of the statements of net assets available for benefits. All methods of assessing fair value result in a general approximation of value and such value may never actually be realized.

The Plan maintains deposits in accounts with major financial institutions which exceeded the \$250,000 Federal Deposit Insurance Corporation limit. These financial institutions have strong credit ratings and management believes the credit risk related to these deposits is minimal.

The Plan and the related insurance carriers face an increasingly challenging regulatory environment. Certain interpretations of laws, rules, and regulations could potentially result in adverse effects to the Plan. However, it is not expected that the Plan will significantly change operations or terminate prior to December 31, 2025.

### Note 6 – Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

### Note 6 – Fair Value Measurements (Continued)

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Level 1* – The fair value of interest-bearing cash is based on the closing price reported on the active market in which the individual securities are traded.

*Level 2* – The Plan has no investments that are classified as Level 2 at December 31, 2024 or 2023.

*Level 3* – The Plan has no investments that are classified as Level 3 at December 31, 2024 or 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
