Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of US Brick Holdings, LLC Retirement Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Note 1—Description of the Plan

The following description of US Brick Holdings, LLC Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan, established February 28, 1992, and most recently amended effective January 1, 2022, is a defined contribution plan covering all employees of US Brick Holdings, LLC and US Brick, LLC (collectively, the “Companies” or “Plan Sponsor”) who have attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Plan entry dates for eligible employees are the first day of each month coinciding with or next following the date age 21 is attained.

Administration – The Plan Sponsor has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

Contributions – Eligible participants may elect to contribute between 1% and 90% of their pre-tax eligible compensation, as defined in the Plan, subject to the Internal Revenue Code (“IRC”) limitations; additionally, participants can contribute an additional after-tax deferral into a Roth account subject to the maximum IRC limitations. The Plan has a provision for automatic deferral provisions for all eligible participants, who on the effective date of the automatic deferral provisions are not deferring any amount and who did not make a timely affirmative election to not contribute elective deferrals, are automatically enrolled in the Plan in the amount of 1% of eligible compensation per payroll period with no escalation percentage. Participants may also contribute amounts representing distributions from other qualified plans. Such contributions, if any, are recorded as rollover contributions in the accompanying financial statements. Rollovers from other qualified retirement plans are accepted by the Plan if the employee meets all legal requirements of the Plan. The Companies may make a discretionary matching contribution at the discretion of the Companies’ Board of Directors. As of December 31, 2024 and 2023, the Plan recorded \$262,104 and \$261,393, respectively, as discretionary matching contribution receivable. Receivable amounts were funded by the Companies in the following Plan year.

Participant Accounts – Each participant's account is credited with (a) the participant's contribution, (b) the Companies’ contributions, if any, and (c) an allocation of the Plan’s earnings (losses). Each participant’s account is charged with participant withdrawals and an allocation of the Plan’s expenses. Allocations of Plan earnings (losses) and administrative expenses are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their voluntary contributions. Vesting in the Companies’ discretionary matching contribution portion of their accounts is based on years of continuous service. A participant is vested in increments of 20% until 100% vested after 5 years of credited service.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution upon request by the participant. In addition, a participant may elect to receive withdrawals upon reaching age 65.

Hardship Withdrawals – The Plan allows participants to make hardship withdrawals to satisfy certain immediate and heavy financial needs. A participant may request a hardship withdrawal for certain qualifying expenses as defined by the Plan document, and within what the Internal Revenue Service (“IRS”) deems an immediate and financial need of the participant.

Note 1—Description of the Plan (continued)

Forfeitures – For the year ended December 31, 2024, there were \$20,889 in additions to the forfeiture account. The balance for forfeitures was \$34,500 and \$27,884 as of December 31, 2024 and 2023. During the year ended December 31, 2024, \$15,127 was used to reduce employer contributions.

Notes Receivable to Participants – Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms cannot exceed five years unless the proceeds are used to acquire a principal residence. The loans are secured by the vested balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Management has evaluated notes receivable from participants for collectability and has determined no allowance in considered necessary. At December 31, 2024, the interest rate was 5.25% - 10.50% for all outstanding loans.

Investment Options – Participants may direct their accounts into various mutual funds and a common collective trust that have been provided as investment options.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in accordance with U.S. GAAP requires the Plan administrator and the Companies to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Such estimates include those regarding fair value. Actual results could differ from those estimates.

Contributions Receivable – The amount of participant-related contributions that have been deducted from the participant's payroll as of the end of the year, but have not been deposited with the Plan until after the end of the year is reflected as participant contributions receivable in the Plan's financial statements. In addition, any contributions due and payable by the Companies are reflected as Employer contributions receivable in the Plan's financial statements.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan management determines the Plan's valuation policies utilizing information provided by Reliance Trust Company (the “qualified institution”). See Note 4 for discussion of fair value measurements.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan has determined that the investment contract held by the Plan is not fully benefit-responsive; therefore, fair value is the appropriate measure.

Net appreciation in fair value of investments is comprised of realized, as well as unrealized, gains or losses resulting from investment transactions. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date.

Fair Value Measurements – The Plan follows the fair value measurements topic of the Financial Accounting Standards Board Accounting Standards Codification (“ASC”) 820 which defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The standard describes three levels of inputs that may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodology used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds – Funds are valued at the daily closing price as reported by the fund. The funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and thus classified within Level 1 of the valuation hierarchy.

Common Collective Trust - Investments in the common collective trust fund are stated at estimated fair values, which have been determined based on the unit values of the funds. Unit values are determined by the organization sponsoring such funds by dividing the funds’ net assets at fair value by its units outstanding at each valuation date. As there is no readily determinable fair value and the trust is valued a NAV as a practical expedient, it is shown outside the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Risk and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes would materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Administrative Expenses – Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Fees related to the administration of certain transactions from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Payment of Benefits – Benefits are recorded when paid.

Note 5—Related party and party-in-interest transactions

Certain Plan investments are units of mutual funds and a common collective trust issued, backed, and/or managed by wholly-owned subsidiaries of the qualified institution. These transactions qualify as party-in-interest transactions. Certain broker and investment advisor fees incurred by the Plan are included in net appreciation in fair value of the mutual funds as they were paid through revenue sharing, rather than direct payment.

The Plan made other direct payments to the qualified institution which are included in administrative expenses. Administrative service fees amounted to \$30,389 for the year ended December 31, 2024, which are included in administrative expenses in the statement of changes in net assets available for benefits. Additionally, notes receivable from participants are also considered party-in-interest transactions because they are transactions with Plan participants.

Note 6—Plan termination

Although it has not expressed any intent to do so, the Companies have the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant's contributions remain fully vested and the Companies' contributions, if any, become fully vested. Under no circumstances may the Companies take ownership of any of the Plan's assets as a result of such termination.

Note 7—Tax status

The Plan has not obtained a determination letter from the IRS stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the standardized prototype plan that it is utilizing. The IRS has determined and informed the Qualified Institution by a letter dated October 6, 2020, that the prototype plan document was designed in accordance with applicable sections of the IRC.

The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax-exempt as of the financial statement date.
