### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We were engaged to perform audits of the financial statements of the **American College of Cardiology Defined Contribution Retirement Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Disclaimer of Opinion***

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### ***Basis for Disclaimer of Opinion***

Prior to January 1, 2009, records were maintained at a contract, not a plan level; therefore, management has not maintained, and Teachers Insurance and Annuity Association and College Retirement Equities Fund did not provide sufficient accounting records and supporting documentation relating to certain annuity contracts and custodial accounts issued to current and former employees, and supporting documentation is not adequate to assure the completeness and accuracy of the amounts included in the financial statements. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements have been affected by these conditions.



### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America (GAAS) and to issue an auditor's report. However, because of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

### ***Other Matter - Supplemental Schedules Required by ERISA***

The supplemental schedules, Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024 and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, are presented for purpose of additional analysis and are not a required part of the financial statements, but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedules referred to above.

## Notes to Financial Statements

---

### 1. Plan Description

The following description of the American College of Cardiology (the Employer or the Organization) Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution 403(b) plan covering all employees of the American College of Cardiology (the Employer) who are of age 21 or older, with the exception of employees who work less than 20 hours a week. The Organization's management along with the Retirement Investment Committee is responsible for oversight of the Plan. The Organization's Retirement Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Custodian and Administration of the Plan*

The custodian and recordkeeper of the Plan is Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Fund (CREF). The administrator of the Plan is the Organization. TIAA and CREF hold all assets of the Plan in accordance with the service provider contract with the Organization. The Retirement Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

Employees who normally work more than 20 hours per week may participate in the tax-deferred portion of the Plan immediately upon employment. Employees are eligible to receive Employer non-elective fixed contributions after one year of service. One year of service is defined by the Plan as the twelve-month period during which an employee completes one thousand hours or more.

#### *Contributions*

The Plan allows both Employer and employee contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants may immediately elect to make pre-tax and Roth contributions to the Plan up to Internal Revenue Code limits. Participants who have attained the age of 50 before the end of the year are eligible to make catch-up contributions. An Employer non-elective fixed contribution will be made for employees who have satisfied the eligibility requirements in accordance with the schedule below.

Employer non-elective fixed contributions are calculated as a percentage of compensation based on date of hire.

### *Participant Accounts*

Each participant's account balance is credited with the participant's contributions, qualified rollover contributions, Employer non-elective fixed contributions and an allocation of earnings or losses and expenses thereon. Allocations are based on participant earnings, account balances, or specific participant transactions. Participants may direct the investment of their account balances into various investments offered by the Plan, including mutual funds, other registered investments, fixed annuity contracts and a pooled separate account offered by TIAA and CREF. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

### *Plan Loans and Notes Receivable from Participants*

There are two types of loans that exist in the Plan: participant loans reported as notes receivable from participants and Plan loans. Plan loans are collateralized loans previously offered through TIAA and CREF. Participant loans reduce the participant's vested account balance by the amount of the loan and are not collateralized. Effective January 27, 2022, the Plan introduced participant loans, replacing the previously allowed collateralized loans, which were discontinued as of January 26, 2022.

### *Plan Loans*

Participants might borrow directly from TIAA and CREF a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the present value of the vested accrued benefit of their pre-tax deferrals or 45% of the combined accumulations attributable to their Group Supplemental Retirement Annuity Certificate (GSRA) under the originating TIAA Traditional Annuity contract and the companion CREF Certificate or 90% of the TIAA Annuity accumulation attributable to their GSRA balance. Collateral equaling 110% of the loan balance must be held in the TIAA GSRA Certificate.

The loans are not shown in the Plan's statements of net assets available for benefits as the loans are not made from Plan assets and are therefore not considered assets of the Plan. Loan interest rates are variable at prevailing interest rates and can be increased or decreased quarterly for the GSRA loans by TIAA and CREF. Principal and interest are paid ratably by the participant directly to TIAA and CREF.

Any applicable surrender charge will be assessed against the portion of the loan collateral used to foreclose on all or part of any loan.

A portion of the TIAA Traditional Annuity balance is held as collateral against these loans when participants have not made payments as agreed to in the loan agreement and the loan has gone into default. As of December 31, 2024 and 2023, the balance of collateral for these plan loans amounted to \$133,277 and \$125,088, respectively.

Loan balances outstanding from TIAA and CREF to the Plan's participants were \$251,253 and \$384,260 as of December 31, 2024 and 2023, respectively.

### *Notes Receivable from Participants*

Participants are allowed to borrow a maximum of three loans from their employee contributed investment balances with TIAA and CREF. Notes receivable from participants reduce the vested

account balance in the participant's account. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Notes receivable from participants incur interest rates at the time of issuance (e.g., Prime rate plus 1%). Principal and interest are paid by the participant to TIAA and CREF. The notes are repaid ratably through deductions from the participant's account balance over a period of five years or less, unless used to purchase a principal residence up to 10 years. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the Internal Revenue Code (IRC).

### *Payment of Benefits*

Participants may make withdrawals from their accounts upon termination of employment, death, or retirement (age 65). Benefits are provided through the accumulation of each participant's share of Employer contributions, their contributions and allocation of Plan earnings. The Plan allows hardship withdrawals only from the elective deferral portion. A participant may elect to receive a lump-sum amount equal to the vested portion of the participant's account, installment withdrawals, annuity payments or ad-hoc distributions. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA.

### *Vesting*

Participants are 100% vested in their pre-tax deferral account balance, which also includes rollover contributions, plus actual earnings thereon. For Employer non-elective fixed contributions, participants hired prior to January 1, 2009 are 100% vested. For participants hired on or after January 1, 2009, vesting of benefits attributable to Employer non-elective fixed contributions made on behalf of participants is in accordance with the following schedule:

### *Forfeitures*

The Plan maintains separate forfeiture accounts with TIAA and CREF. When an employee terminates prior to full vesting, the Plan's cumulative, unvested Employer non-elective fixed contributions made on behalf of the participant, as well as earnings and losses thereon, are transferred to the Plan's forfeiture accounts. Forfeited accounts relate to Employer non-elective fixed contribution amounts and are used to reduce future Employer contributions or to pay Plan expenses. For the year ended December 31, 2024, the Plan utilized forfeitures of \$53,996 to reduce Employer contributions and pay certain Plan expenses. The forfeiture balance was \$178 and \$505 as of December 31, 2024 and 2023, respectively.

### 2. Summary of Accounting Policies

#### *Annual Reporting Requirements*

In November 2007, the Department of Labor (DOL) issued amended regulations eliminating an exemption granted to 403(b) plans from the annual Form 5500 reporting, disclosure and audit requirements under ERISA effective for tax years beginning in 2009. Prior to January 1, 2009, TIAA and CREF maintained records at a contract, not Plan, level. Neither the Plan Sponsor nor TIAA and CREF have been able to produce sufficient accounting records and supporting documents relating to certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009. As a result, the completeness and the accuracy of the annuity and custodial accounts, related investment income, and distributions related to these accounts, if any, could not be determined.

#### *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires management to make certain estimates and assumptions that affect reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value except for the Plan's investment in the fully benefit-responsive contracts which are reported at contract value.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at the unpaid principal balances plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Administrative expenses are paid by the Employer and are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

### *Revenue Credits*

The Plan's trust agreement provides for a participant revenue credit arrangement, whereby the trustee allocates quarterly deposits into the accounts of eligible participants who are invested in certain funds. There are unallocated revenue credits of \$15,533 and \$14,735 as of December 31, 2024 and 2023, respectively. During 2024, the Plan received credits of \$108,633 which were used to pay administrative expenses. Revenue credits are presented in other income in the statement of changes in net assets available for benefits.

### **3. Certified Investment Information**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF, a qualified institution.

### **4. Fair Value Measurements**

FASB ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. These methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*CREF Registered Investments* - These separate accounts are registered investments that publishes their net asset value on NASDAQ and invest principally in equity securities, fixed-income instruments and short-term investments in accordance with each portfolio's investment objectives. Account investments and fund holdings are primarily valued using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments including matrix pricing. Money market account holdings are generally valued at amortized cost. On a daily basis, units in these investments are revalued to reflect performance of the underlying investments minus any fees and charges.

*Pooled Separate Account* - The pooled separate account publishes its net asset value in NASDAQ and is stated at fair value as determined in accordance with the policies and procedures reviewed by the Investment Committee of TIAA. The value of the units held in the pooled separate account is based on the market value of the underlying real estate holdings which are valued principally utilizing external appraisals and involve significant judgment.

Appraisals can be subjective in certain respects and rely on a variety of assumptions and conditions at the respective property or in the market in which the property is located, which may change materially after the appraisal is conducted.

The pooled separate account provides participants with a liquidity guarantee enabling the account to have funds available to meet participant redemptions, transfers, or cash withdrawals. TIAA and CREF guarantees that participants can redeem their accumulated unit value determined after their transfer or cash withdrawal request is received in good order. Withdrawals from the pooled separate account are limited to once per calendar quarter.

*Non-Fully Benefit-Responsive Fixed Annuity Contracts* - The non-fully benefit-responsive fixed annuity contracts, composed entirely of TIAA Traditional Annuity Contracts offered through the Retirement Annuity (RA) contracts, are reported at fair value using the discounted cash flow model which is approximated by contract value. The contract value equals accumulated cash contributions and interest credited to the Plan's contracts, less withdrawals. The crediting interest rate is between 1% and 3%. The TIAA Traditional Annuity is not available for sale or transfer on any securities exchange.

The TIAA Traditional Annuity holdings within the RA contracts have liquidity restrictions. Participant-initiated transfers or withdrawals may only be made in ten annual installments over a period of approximately nine years.

### ***Level 3 Sensitivity of Fair Value Measurements and Changes in Significant Observable Inputs***

The significant unobservable inputs used in the fair value measurement of the Plan's Level 3 investments are subject to market risks resulting from changes in the market value of its investments.

## **5. Fully Benefit-Responsive Contracts**

For the traditional annuity contracts that are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value without restriction.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less

than 3%. Such interest rates are reviewed on an annual basis for resetting. Additional amounts may be declared on a year-by-year basis by the TIAA and CREF Board of Trustees.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

### **6. Related Party and Party-in-Interest Transactions**

The Organization is the administrator of the Plan, and as such, executes the normal duties associated therewith. Certain Plan investments are managed by TIAA and CREF. TIAA and CREF acts as the record-keeper for those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments as they are paid through revenue sharing rather than a direct payment. The Plan Sponsor pays any other fees related to the Plan's operations.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accounts of each affected participant become fully vested.

### **8. Tax Status**

The Plan adopted a 403(b) Volume Submitter Plan which received an IRS opinion letter dated August 7, 2017, stating that the form of the plan is acceptable under the IRC. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any uncertain tax positions that more likely than not would not be sustained upon examination by IRC. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near

term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### **10. Delinquent Participant Contributions**

During the Plan year ended December 31, 2024, participant contributions totaling \$1,016 were not remitted to the Plan within the period prescribed by DOL regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. The Employer corrected these transactions and the related lost earnings were remitted to the Plan during 2025.

### **11. Subsequent Events**

The Plan Administrator has evaluated all subsequent events and transactions through October 13, 2025, the date the financial statements were available to be issued.
