Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the **ArborGen Inc. 401(k) Profit Sharing Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA Section 103(a)(3)(C) audit. Opinion

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

Note 1. Description of Plan

The following description of the ArborGen Inc. (the Company) 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General

The Plan is a 401(k) defined contribution plan covering all employees of the Company, except for employees covered by a collective bargaining agreement, non-resident aliens, leased employees, and citizens of Puerto Rico. All eligible employees are entitled to participate in the Plan once they attain the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974.

Plan amendments

The Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act of 2022 (the Act) was enacted to enhance retirement savings opportunities and improve retirement plan administration in the United States. The Act provides a broad range of mandatory and optional provisions affecting retirement plans, including increasing participation, improving portability of retirement savings, and expanding penalty-free withdrawal options for certain circumstances. Plan sponsors may elect to adopt certain provisions voluntarily before their mandatory effective dates. For the year ended 2024, the Plan adopted the following voluntary provisions under the SECURE 2.0 Act:

- Qualified Retirement Plan Overpayment Recovery: The Plan has adopted updated procedures concerning the recovery of inadvertent overpayments made to participants or beneficiaries.
- The automatic cash-out threshold for former participants' account balances was increased from \$5,000 to \$7,000.

Management has evaluated the impact of these amendments and determined that they do not materially affect the financial statements as of and for the year ended December 31, 2024. These changes are intended to improve participant experience and administrative efficiency in accordance with recent legislative developments.

Contributions

Each year participants may contribute up to 100% of their pre-tax and after-tax compensation as defined by the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contributions or defined benefit plans. Effective September 1, 2017, the Plan elected an auto-enrollment provision whereby all eligible employees not participating or contributing less than 1% are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate at 1% of eligible compensation, with an annual 1% increase up to 4%, and their contributions invested in a designated balanced fund until changed by the participant.

For the years ended December 31, 2024 and 2023, the Company has elected to make a safe harbor matching contributions in an amount equal to 100% of the first 5% and 4%, respectively of the participants' compensation. The Company contributed \$396,209 and \$307,056 for the years ended December 31, 2024 and 2023, respectively. The Company may also make annual discretionary profit-sharing contributions in an amount to be determined at the end of the Plan year. These discretionary profit-sharing contributions, if any, are allocated to the participant's account in the ratio of the participant's compensation to the total compensation paid to all eligible participants. There was no discretionary profit-sharing contribution for the years ended December 31, 2024 or 2023. Qualified non-elective contributions may be made by the Company in order to satisfy the nondiscrimination tests described in the Internal Revenue Code (IRC). The Company did not make any qualified non-elective contributions for the years ended December 31, 2024 and 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Note 1. Description of Plan (Continued)

Participant accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and Plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options

Upon enrollment in the Plan, participants may direct their contributions, the Company's safe harbor matching and discretionary profit-sharing contributions, and the Company's qualified non-elective contributions, if any, in a variety of investment options as more fully described in the Plan's literature. Participants may change their investment options at any time.

Vesting

Participants are immediately vested in their contributions and the Company's safe harbor matching and qualified non-elective contributions, plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

Participant notes receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is equal to the prime rate as defined. Principal and interest are paid ratably through payroll deductions. A participant may only have two loans outstanding at a time.

Payment of benefits

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or other installment options as provided by the Plan. Hardship distributions are permitted. All fully vested balances are available for distribution after the participant reaches the age of 59½.

On termination of service, if a participant's vested balance does not exceed \$1,000, the Plan will automatically distribute the participant's vested account balance in a lump sum. If the account balance is between \$1,000 and \$7,000, (\$5,000 prior to 2024) it will be rolled into an IRA if the participant does not elect a benefit. If his or her account exceeds \$7,000 (\$5,000 prior to 2024), a participant may elect to receive the value of the participant's interest in his or her account in the form of a lump-sum distribution, roll over the vested balances into another qualified plan, or may leave their funds in the Plan.

Forfeited accounts

The Plan permits forfeitures to be used to pay for administrative expenses and then to reduce future employer contributions. As of December 31, 2024 and 2023, there were no forfeited non-vested accounts. No forfeitures were used in 2024 and 2023 to pay administrative expenses or reduce employer contributions.

Note 2. Summary of Significant Accounting Policies and Activities

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ materially from those estimates.

Investment valuation and income recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses had been recorded as of December 31, 2024 and 2023. If a participant ceases to make repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

Note 3. Information Prepared and Certified by the Custodian

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments, loans and related interest income held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, and dividend income for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Trust Company.

Note 4. Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

- *Shares of registered investment companies (Mutual funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Pooled separate accounts:* Stated at estimated fair value as determined by the fair value of the underlying assets of the account. The account values of separate accounts are not publicly quoted and are therefore classified as Level 2 investments.

Note 5. Fully Benefit-Responsive Investment Contract

The Plan invests in a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal Life) totaling \$1,371,246 and \$1,219,629 as of December 31, 2024 and 2023, respectively. Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The credit rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract plus earnings less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan, (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (e) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Such events include the following: (a) an uncured violation of the Plan's investment guidelines, (b) a breach of material obligation under the contract; (c) a material misrepresentation, or (d) a material amendment to the agreements without the consent of the issuer.

Note 6. Related Party and Party-In-Interest Transactions

Certain plan investments are managed by Principal Trust Company. Principal Trust Company is the custodian as defined by the Plan and therefore these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment as they are paid through revenue sharing rather than a direct payment. The Plan made direct payments to the third-party administrator and investment advisor totaling \$57,041 and \$59,011 for the years ended December 31, 2024 and 2023, respectively, which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 7. Plan Termination

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions, including profit sharing contributions.

Note 8. Income Tax Status

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service (IRS) states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Delinquent Contributions

Due to administrative errors, the company did not remit certain participant contributions of \$84,918 and \$306,448 in a timely manner as defined by ERISA during 2024 and 2023, respectively. These contributions are considered non-exempt party-in-interest transactions which may result on an imposition of a 15% excise tax on the amount of the transaction. The Company intends to compensate participants for any potential lost earnings associated with the delay in remitting contributions. The accompanying financial statements do not include any adjustments or accrual related to the potential liability for excise tax or earnings.

Note 11. Subsequent Events

The plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued. There were no material subsequent events to disclose as of this date.

Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of **ArborGen Inc. 401(k) Profit Sharing Plan** (the Plan) as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

Management has determined it is permissible in the circumstances and has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, as permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements of information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Our consideration of internal control was for the limited purpose described in the preceding paragraph and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies, and therefore, material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, we identified certain deficiencies in internal control that we consider to be significant deficiencies.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or combination of deficiencies, in internal control such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis. We did not identify any deficiencies that we consider to be material weaknesses.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control over financial reporting that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiencies in the Plan's internal control to be significant deficiencies:

Timely Remittance of Participant's Deferrals and Loan Repayments

During the year under audit, we discovered that on 3 occasions participant deferrals and loan repayments were not consistently submitted to the Plan in a timely manner as defined by the Department of Labor. We recommend that Plan Management implement policies and procedures that will ensure deferrals and loan repayments are submitted to the Plan within three days of the withholding.

Eligible Compensation

During our audit, we noted that the compensation used for calculating employee deferrals is not consistent with the definition of eligible compensation stated in the plan document. Bonus wages were excluded from compensation for two employees at termination when the plan document states these are eligible wages. Plan management needs to calculate and distribute employee excess elective deferrals for the affected participants. We recommend Plan management improve its internal controls and processes over the calculation of eligible compensation.
